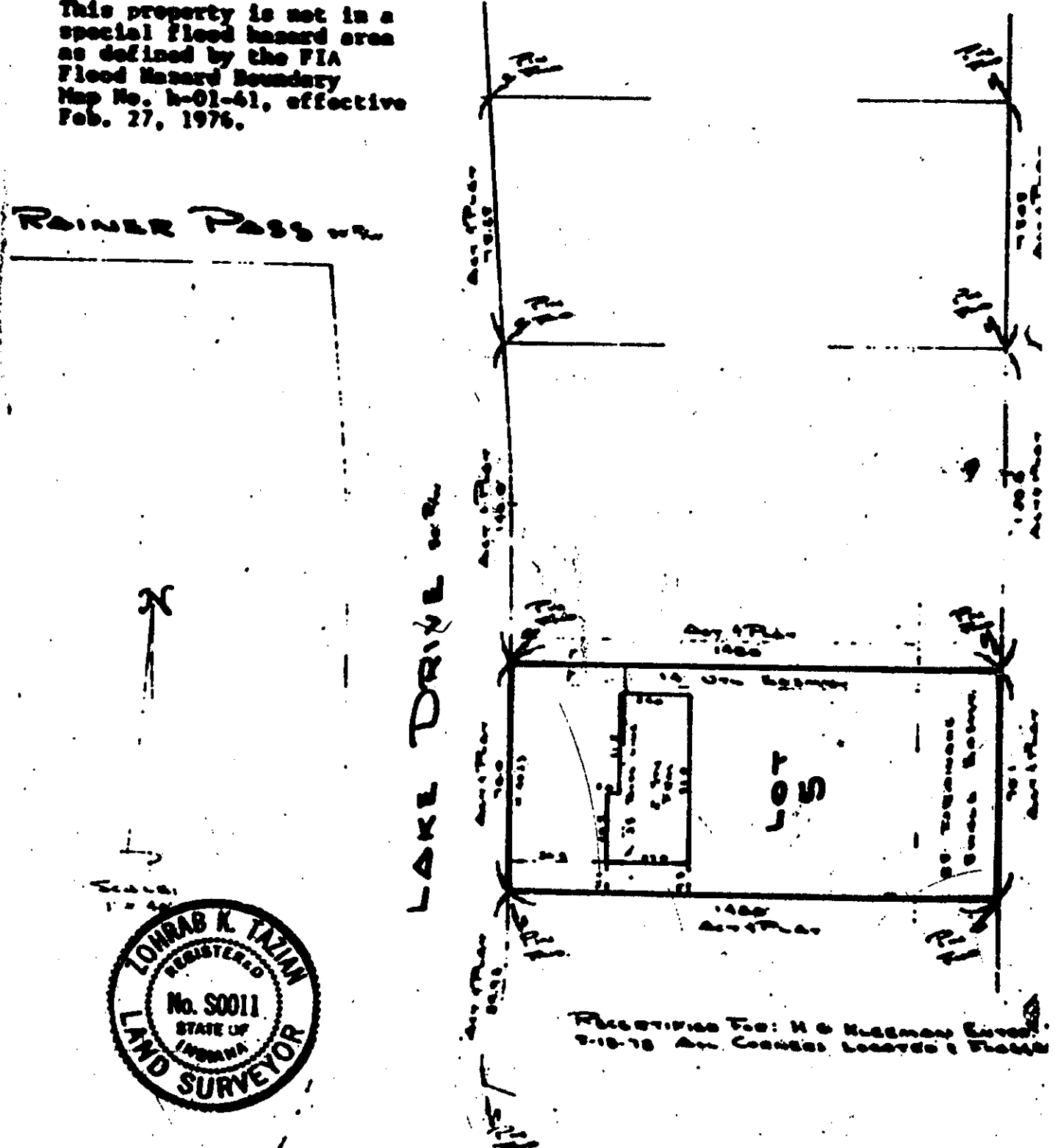
CERTIFICATE OF SURVEY

This property is not in a special flood hazard area as defined by the FIA Flood Hazard Boundary Map No. h-01-61, effective Feb. 27, 1976.



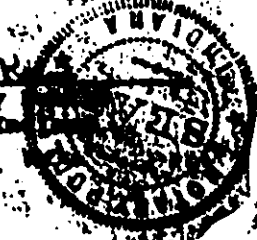

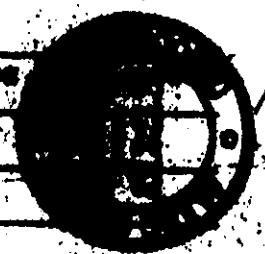
