# PHOTO BOOTH CONTRACT

This agreement is between Nature's Own Photography, LLC. (hereafter "Provider") and

### Scope of Work:

This contract is for photo booth rental and services related to photo booth rental (hereafter "booth", "service" or "services" to take place at the following time and place.

the photo booth operational for a minimum of 80% during this period. Occasionally operations may be					
interrupted for maintenance of the booth. The provider will not be held responsible for any interruptions of					
service out of their control (i.e., power outage, acts of war, acts of God, unsafe work environment, etc.).					

The provider agrees to provide the following during this period (no price difference if not used):

- Photo Booth (Lumia M Pro)
- Attendant
- Photo props appropriate to event
- Prop table
- Print / Text / Email options for image delivery to guests
- Printer DNP RX1 Printer
- 50' power extension cable
- Custom print layout

### **Expectations from Client:**

The client will arrange for an appropriate space for the photo booth at the event's venue. A solid, flat floor space must be 10' x 10' minimum (10' x 20' if large groups of people per photo is expected) and 8' high ceilings. The client is responsible for providing power for the booth unless a power pack is ordered in options. The photo booth requires a 100V, 10 Amps, 3 prong outlet from a reliable power source within 50 feet (along a wall) of the set-up area. The circuit must be free of all other connected loads. Any delay in the performance or damage to the photo booth equipment due to improper power is the responsibility of the client (\$1,000.00 damage cost minimum). The client shall provide crowd control, if warranted, and provide safe and appropriate working conditions.

The photographer retains copyright of the photographs, and hereby grants the Client unlimited, but nonexclusive, rights to use or reproduce the photographs from the shoot. At no time is the client authorized to take credit for the photos. At no point is the client, or Nature's Own Photography, LLC, authorized to take or receive money for any photos taken at this shoot without express written consent.

The balance of the payment for services must be paid the day of the shoot detailed in Section 1, Scope of Work.

The client shall reimburse the provider for any additional costs that they may incur based on the clients' requests (i.e., parking, tolls, etc.), which is necessary to the performance of these services.

This contract shall be governed by the laws of Texas and any applicable Federal law.
