**\*ALL WEAPONS TRANSFERS MUST COME FROM A FFL HOLDER!!!!!!\***

Truck-N-Trim, Inc. (TNT or TNT Firearms and Accessories) serves as a transfer agent to assist its customers in obtaining weapons ordered from Federal Firearms License (FFL) Dealers within or outside of Florida, manufacturers, or importers **NOT** from unlicensed individuals (this is our store policy).

By serving as the agent in Dealer-To-Dealer transactions TNT Firearms will receive the weapons from the seller's dealer and complete the required paperwork.

- The license will only be valid for the business listed on the FFL and is nontransferable.
- The fee for providing this service is \$35.00 per handgun. (I.e. Each additional firearm(s) is \$27.00, if you are transferring two (2) weapons from the same dealer or different dealers it will cost you \$62.00), and \$35.00 per long gun. **For any weapons that are over the value of \$800.00 there will be a transfer fee of \$50.00 per (hand or long) gun per transfer.**
- If we receive a weapon with **NO** information before hand then there will be an additional \$10 charge per weapon per transfer. Every FFL must include your name, make, model and serial number of the gun.
- Once the firearm is received by TNT Firearms you will then fill out the required paperwork. This paperwork includes the necessary federal form (4473). **ALL FIREARMS MUST BE PICKED UP WITHIN 3 DAYS OF NOTIFICATION OF RECEIPT OF FIREARM(S) OR YOU WILL BE SUBJECT TO A \$1.00 A DAY HOLDING FEE PER DAY AFTER THE 3RD DAY.**
- If we receive a gun to transfer to you, and you are unable to obtain the firearm for **any** reason including but not limited to being denied by the Florida Department of Law enforcement (F.D.L.E) or by your admission on the federal form (4473), you will be responsible for the shipment and charges that apply to ship the firearm back to the original dealer. If no such arrangements are made within thirty (30) days the weapon will become property of TNT Firearms.
- Any exceptions to the above agreements must be made in advanced and my incur an additional fee.
- TNT Firearms will not be held liable for the condition of the weapon. Any warranties are solely between the purchaser and the original dealer.
- TNT Firearms has the right to cancel any transactions at any given time for any reason.
