



# Prince Hall History in American



By RW Bro. Daryl L. Andrews Often times, Prince Hall Masonic History is separated from the fabric of American History unintentionally. Many see the history of the organization as a separate occurrence on a similar timeline. The fact of the matter is that Prince Hall History is American History and the struggles experienced by our nation have impacted it greatly. As such, American History and Prince Hall History should not be viewed through two separate lenses.

The history of the United States of America and Prince Hall Masonic History are, in fact, one in the same and lead to the same source—the American Revolutionary War. Prior to the start of the war, Hall and others received their Masonic Rites from an Irish Military Lodge whose members were attached to the British Army. Their membership granted them the right to participate in Masonic ceremonies yet did not give them the authority to meet as a Lodge. They would not gain this ability legitimately until the conclusion of the American Revolution.

Despite the participation of African Americans in the American Revolutionary War, post war America was still in a segregated state. Slavery was still in effect and racial inferiority was a concept that was regularly relegated upon African Americans. This is likely the cause for the denial of admission of Hall and his fellow brethren into the Lodges and ceremonies of the Grand Lodge of Massachusetts. As a result, Hall and his brethren applied for their own charter from the Premier Grand Lodge of England which was granted in September of 1784. The charter, although not received until 1787, granted them full rights and privileges as a Masonic Lodge answering directly to the Grand Lodge of England. Thus, granting them legitimacy in the eyes of one and all as African Lodge #459.

The charter is one of a few warrants issued by the Premier Grand Lodge of England that has lasted the test of time. It is this document that is revealed bi-annually at the ceremonial opening of African Lodge in Massachusetts (pictured right) in commemoration of the first opening of

The charter, which is the most prized document in all of Prince Hall Freemasonry, represents more than just a Masonic document to many. It is an American artifact that should be cataloged among the precious papers that are held near and dear to the country. It represents the recognition of true brotherhood despite racial differences across international boundaries.

It is upon this basis that Prince Hall and his fellow citizens engaged in civic efforts to ensure that this same recognition, the brotherhood of man, was implemented in his locale. Within months of the completion of a draft of the Constitution of the United States of America, Hall and his fellow citizens petitioned the General Court of the Commonwealth of Massachusetts to end the practice of the Slave Trade within the Commonwealth. This effort and prior attempts were the catalysts that drove the legislature to adopt the act which prohibited the Slave Trade and illegal abduction and sale of freedmen into Slavery in March of 1788.

This effort and other subsequent efforts by Hall confirmed that his focus and the focal points of African Lodge were set squarely on improving the communities in which members lived and served. During the timeframe where George Washington was being inaugurated and the Bill of Rights ratified, Hall and his brethren continued to lobby the legislature for educational programs for black children and training for the recently freed. When rebuffed, they took matters in their own hands by transforming their homes into schools for children, aiding slaves on their pathways to freedom and training them for future opportunities. These efforts drew the attention of other prominent African American men and organizations which led to joint efforts to satisfy the aforementioned goals. There comradeship and mutual concern for the community prompted more men to gain membership into the Masonic ranks and extend the organization to new bounds.

Members of the Free African Society, which was formed in 1787, in particular, became prominent members in the Masonic ranks by the end of the 18th Century. The founders of the Society, Absalom Jones and Richard Allen, were both inducted by Prince Hall as they shared the belief in the brotherhood of man under the fatherhood of God. Hall issued a public charge in 1792 which highlighted the need to aid abolitionists efforts and build stronger communities. This shared sentiment preached well to many particularly during the period in which the Federal government enacted the Fugitive Slave Act of 1793. As such, Hall, Jones and Allen stepped up their civic efforts.

The Fugitive Slave Act of 1793, effectively, deputized American citizens giving them the right to return slaves who had fled northward to freedom. Often times, freed men were abducted, claimed as slaves and sold into Slavery contrary to the act passed by the Massachusetts legislature in 1788. This is most recently portrayed in the film released in 2013 titled "12 Years a Slave" depicting the story of Solomon Northup. He was a free man who had been abducted and sold into Slavery. To combat acts like these by American citizens, civic efforts by Afro-American leaders increased greatly. This prompted Prince Hall to give another charge in 1797 to mobilize his troops.

Hall's charge of 1797 did not fall on deaf ears as it not only inspired the efforts of Masons by also the community at large. As such, Jones and Allen stepped up their civic efforts and joined the Masonic ranks along with their supporters. This group established a second branch of African Lodge in Philadelphia, Pennsylvania in 1797. Shortly

thereafter, a third branch was established in Providence, Rhode Island. From this nucleus, Prince Hall Freemasonry extended itself as a civic organization and continued to focus on community improvement through well through Washington's Presidency and beyond.

The extension of African Lodge #459 in 1797 into branches and, subsequently, separate Lodges produces a view point that often contradicts with principles of Masonic regularity. A Lodge cannot establish another Lodge according to these principles. However, considering the times and the circumstances, the manner in which the extension was executed was warranted.

Even though the charter of African Lodge was a valid charter stemming for a valid source, the Lodge was not accepted as a regular Lodge by those Lodges attached to the Grand Lodge of Massachusetts. This was, most likely, due to the racial climate of the day. Non acceptance of the branches of African Lodge in Philadelphia and Providence were likely due to the premise that only a Grand Lodge can charter a subordinate Lodge. While the latter conforms with current standards of regularity, there was much unrest during this period on the topic.

With regard to a Lodge establishing another Lodge and being accepted, several precedents had already been established as noted by famed abolitionist and Past Grand Master of Ohio (Colored), John Jones. In his article "A Colored Mason's Defense of Prince Hall Lodge and Its Offspring" published in the Chicago Daily Tribune on January 30, 1876, Jones cites the formation of Lodges in Germany by other Lodges to quell a contrast offered by the Grand lodge of Ohio (Caucasian) in January of 1876. The Lodge of Unity in Frankfort organized The Lodge of Unity in Nuremburg. The Lodge of Aux Troix Globes was also organized in Berlin on September 13, 1740 without authority from a Grand Lodge. These Lodges were all eventually accepted as regular Lodges by the Grand Lodge of England because the mother Lodge was considered regular. Jones alleged that the decision to accept those Lodges as regular Lodges was tied to race. Masonic scholars in today's era claim the same relative to the initial acceptance of African Lodge and her branches by the Massachusetts Masonic community.

All things considered, it is impossible to withdraw the racial climate from the conversation relative to the expansion of African Lodge #459 into branches. As the mother Lodge could tie itself back to a legitimate source, the children should have been accepted in the same manner as it was done for those Lodges in Germany. Hence, per Jones, the argument posed by the Grand Lodge of Ohio (Caucasian), was from a prejudiced perspective without consideration of the precedents that had already been set. Further, as the precedents were common among the Masonic scholars of that day, the only basis for prejudicial treatment was race.

Even though race played a large role in the social machine of the 18th and 19th Centuries, Afro-American leaders fought through the challenges to improve the state of their communities. In religious circles, Absalom Jones and Richard Allen worked to provide relief and increase faith. The opening of the African Episcopal Church of St. Thomas and the formation of the African Methodist Episcopal Church (AME) in 1794 are shining examples of both. Mother Bethel AME was opened as an educational center by the Free African Society in 1795 to educate black youth. Hall continued to prod the legislature to fund education for black children. Rather than wait for the seals of approval, he and the brethren of African Lodge utilized his home as a school for the children in 1803.



The death of Prince Hall on December 7, 1807 is a critical point in the history of Afro-American Freemasonry in the United States of America. From Hall's efforts and those of the brethren of the branches of African Lodge #459, their communities had been uplifted tremendously during an era in which Slavery and the slave trade were still legal; in which racial barriers extended far and wide; and where the political leaders of the day and age were not easily acquiescing to the demands of free black men. Despite the challenges, the Craft had extended to civic-minded men across the northeast portion of America who maintained the focus of improving the conditions for the Afro-American communities in which they lived and served. It is with this point of focus in mind that Afro-American Freemasonry extended across North America with the extension of the United States of America and the Afro-American church.

Following the death of Hall, the brethren of African Lodge of Boston, African Lodge of Philadelphia and African Lodge (Hiram) of Providence worked to position themselves for a permanent, united standing in America. As such, the three branches, which had operated separately as individual Lodges since formation, organized and formed a home in 1808, the African Grand Lodge, as its governing body.

The War of 1812 and the union of the two Grand Lodges of England (Premier and Antient) changed the relationship between American Lodges and the Grand Lodge of England. In 1812, Great Britain and France were engaged in the Napoleonic War. With economic sanctions laid on America by both nations due to the wartime state, travel across the high seas by American vessels was often met with conflict. The British Navy engaged in the practice of impressment of American vessels as a method to restrict American trade. These acts drove America into war with Great Britain which became the War of 1812.

The battles between America and Britain were waged on land and sea. Although the United States suffered the burning of the nation's Capitol in 1814, American forces were able to fend off subsequent invasions. For Britain, battles on two fronts between America and France caused a drain on her resources. As such, the war ended as a stalement with the Treaty of Ghent on February 17, 1815.

In the eyes of many scholars, the War of 1812 and the Napoleonic War was also a driving force for the Masonic union in England. On December 27, 1813 in the midst of two wars, the Premier and Antient Grand Lodges united to form the United Grand Lodge of England. The settlement of the rolls found many American Lodges to be removed from amity with the United Grand Lodge. Thus, began the period of separation of African Lodge to England.

#### "Making A Health Care Dream A Reality for the Most Worshipful Prince Hall Grand Lodge-State of Illinois"

As the Grand Historian it is with great honor to write this article on my colleague, Past Master Albert Haynes, III. Of Plumbline Lodge, #116, an amazing man who is truly someone you should know. Professionally Worshipfully Brother Haynes, III., is a Pharmacist with Walgreen's located on Chicago's near north side. He is a graduate of the University of Illinois, Class of 1984. For over thirty years, Worshipful Brother Haynes has provided health care services to this community. He has gained the community's trust and is respected by his peers at Walgreens. Because of his passion for health care for all human beings, he dreamed of providing the same medical health care for the community through the form of flu-shots.

Worshipful Brother Haynes, III., dream started in the year 2011 and it is now 2016 (five years later). The flu-shot program has expanded across the State of Illinois and its service is being provided in all of the Districts for the Most Worshipful Prince Hall Grand Lodge, Jurisdiction of Illinois. Worshipful Brother Haynes, III., is a member of the Prince Hall Grand Lodge Medical Unit consisting of brothers who are paramedics by profession and sisters who are nurses by profession.

Brothers and Sisters, let me tell this story from the beginning and hopefully at the conclusion you will agree that Worshipful Brother Haynes, III., is truly an amazing man. On June 18, 2011, Worshipful Brother Haynes, III., established a dialogue between his employer, Walgreens, and the Grand Lodge in an effort to do charitable work for the community. The dialogue pertained to the possibility of establishing a community service program to have an off-site flu-shot program for senior citizens. Due to Worshipful Brother Haynes, III., persistence and his dream to medically serve the black community, he revisited and discussed the matter on September 26, 2012 with Grand Master Millard V. Driskell to use the Grand Lodge as an off-site facility for flu-shots. The Grand Master approved the effort.

On November 3, 2012, history was made at the Grand East. The historical event was an all day activity that involved three community service programs conducted simultaneously including administering of flu-shots; medical testing to determine if a person is at risk of contracting the Alzheimer's Disease; and administering a diabetes/ kidney screening test program. The first flu-shots ever conducted at the Grand East were administered by Worshipful Brother Haynes, III., and his professional Walgreen's staff. The Alzheimer's and the Diabetes/Kidney

Screening Programs were initiated by Dr. Joe Harrington, an employee with the Illinois Department of Health. The professional staff of the Thapelo Institute conducted the Diabetes/Kidney Screening Program for the third time in three years. Rush University Medical Center through its Rush Alzheimer's Disease Program, staff conducted a mental Alzheimer's memory test on participants to determine Alzheimer's potential or if any were at risk for dementia. All service programs were successful.

On November 22, 2012, at the Grand Lodge Annual Thanksgiving Dinner for the less fortunate, Worshipful Brother Haynes, III., and his staff were at the Grand East again administering flu shots to a new group of community participants as well as members of the Prince Hall Masonic Fraternity. It is because of Worshipful Brother Haynes, III., dream to medically serve the black community through the administering of flu-shots that the community and the Prince Hall Masonic Family members are a little bit more healthier.

In addition to the many professional accolades Worshipful Brother Haynes, III., has received from his employer, he is also the Assistant Grand Historian for the Grand Lodge; Past Most Wise and Perfect Master, Hiram Chapter # 28-House of the Rose Croix; and Western Consistory No. 28-Grand Inspector, 33° Mason. Further, Illustrious Brother Haynes, III., is the recipient of the Illinois Council of Deliberation 2015 Meritorious Service Award which is the highest award awarded to a Scottish Rite Mason. ## Multiple Sclerosis (MS) Do You Truly Understand This Health Condition?

Do you truly understand this health condition Multiple Sclerosis (MS)? As I explored the subject matter, I recalled knowing people suffering from MS, including the diagnosis of a family member by a Neurologist within the last 4 years, presenting symptoms leading back several years prior to the final diagnosis. Red flags (family) urged me to research factors causing of the onset of MS. Scanning back, over 25 years, each case independent and years apart. The symptoms are common in most of cases, yet variable in the severity.

#### In Retrospect, Moments of Reflection:

- Fellow Fraternal Member: Days of extreme fatigue, pain, periodically confined to the bed and not able walk at times.
- Friend: Emotional outburst of anger, onset of paralysis in the left leg and eventually wheelchair bound due paralysis.
- **Coworker:** Forced to stop work; to care for a spouse fallen to extreme fatigue and inability to walk.
- Family Member: Days of extreme fatigue, numbness in extremities, head arches and pain at times.

#### Do you truly understand their health condition? Answer: No. Or, How Multiple Sclerosis impacts their quality of life.

**The Research to Understand MS (Multiple Sclerosis):** There are many mysteries associated with MS. The National Institutes of Health indicates "no one knows what causes MS". It may be an auto immune disease, which happens when your immune system attacks healthy cells in your body by mistake. A common theme characterizes, MS (Multiple Sclerosis) as a disease primarily impacting the central nervous system (brain, spinal cord, optic nerve and nerve cells). The nerve system travels throughout the entire body, this the pathway linking various symptoms a person suffering from MS experiences. There is a higher prevalence of MS in women than men; the onset generally begins between 20 to 40 years of age. Although, there is an onset in cases cited as early as 2 years old and as old as 70 years old. The National Institutes of Health research indicates that 1 in 1000 Americans have MS, the chances are 1 in 20 if a sibling has MS, and 1 in 4 chances if an identical twin has MS.

What causes the onset of MS: The immune system attacks the protective sheath (myelin protective coating surrounding the nerves fibers), where the MS disease may cause the nerve fibers to deteriorate or become permanently damaged, thus causing an interruption in communication between your brain and the rest of your body.

**Symptoms:** Fatigue, tingling or weakness in the face, arms, legs, pain, double vision, headaches, cognitive impairment (memory poor judgment, trouble focusing or multi-tasking), anxiety, mood swings, irritability, numbness, trouble walking or standing, lack of balance and coordination, breathing problems, itching, tremor, muscle tightness, burning sensations in legs, feet or hands, dizziness, lightheadedness, poor articulation of words, speaking too loud or too soft, and sounding hoarse or nasal.

**Severe Symptoms:** "MS hug" feels like somebody is grabbing very tight around the midsection, and "MS lassitude," a very severe fatigue, partial or complete blindness, pain during eye movement, depression, epileptic seizures, hearing loss, speech and voice disorders - slurred speech, bowel and bladder dysfunction, sexual dysfunction and electric-shock sensations with neck movements.

**Diagnosis:** 1. Neurological Diagnosis indicating damage to at least two areas in the Central Nervous System (Brain, Spinal Cord or Optic Nerve), Evidence that damage occurred at least one month apart. 2. Magnetic Resonance Imaging (MRI) detects brain lesion/ scar/plaque. 3. Visual Evoked Potentials (VEP) 4. Cerebrospinal Fluid Analysis. 5. Possible Clinically Isolated Syndrome (CIS) Inflammation or demyelization damage to the nerve cells covering. 6. Monitoring number of lesion/scar/plaque in a relapse.

**Medication:** Several FDA approved medications prescribed to control specific MS symptoms are currently available. Some of these medications may delay the progression of the disease, and/or reduce the number and severity of MS relapses: seven (7) Injectable, three (3) Oral and three (3) Infusion medications. The pharmaceutical industry continues to develop drug formulation for MS.

**Side Effects:** This is a partial combined list of side effects for injectable, oral and infusion medications. Pain in the extremities abdominal pain, dry mouth, flu like symptoms, cough, cold sweats, chills, flushing, fever, fatigue, headaches, migraines, dry skin or rash, toothache, somnolence, throat infections, dizziness, nausea, vomiting, diarrhea, constipation, flatulence, injection site pain, bruising and inflammation, urine constituents, seizures, chest pain, tremor, joint pain, increased spasm, upper and lower respiratory tract infection, bronchitis, sinusitis, anemia, vasodilatation, mild renal impairment, anorexia, anaphylaxis, acute hypersensitivity, gastroenteritis, urinary tract infection, vaginitis, menstrual disorder, alopecia, edema, decrease lymphocytes, liver injury, elevated hepatic enzymes, elevated total bilirubin, yellowing (jaundice) of the skin and eyes or dark urine, PML- progressive multifocal leukoencephalopathy (a rare deadly brain disease), depression, psychiatric disorders, suicide, bradycardia and fetal risk.

## **NUTRITION: ARE YOU AN APPLE OR A PEAR?**

In my research, I found that, for years, experts thought people with apple-shaped bodies had greater worries. Fat stored in the stomach area puts them at a higher risk for health problems, such as diabetes and heart disease. They also believed that pear-shaped folks, who stored their fat in the buttocks, thighs and hips, were protected from these health issues. However, a recent study shows that the belief about pear-shaped people may not be correct. In the study, experts found that both pear-shaped and apple-shaped people

had an increased risk of metabolic syndrome. Metabolic syndrome is a group of risk factors, such as high fasting blood glucose, high blood pressure and lower HDL "good" cholesterol levels, that can lead to type 2 diabetes and heart disease.

Fat stored in the buttocks, thigh and hip area doesn't just sit there. It's active and releases two proteins: chemerin and omentin-1. People with high chemerin levels also tend to have high blood pressure, increased insulin resistance, increased signs of inflammation, high triglycerides and lower levels of HDL cholesterol. Those with low levels of omentin-1 had high triglycerides, a high blood glucose level and a low level of HDL cholesterol.

**Keys To Weight Loss:** If you carry extra weight in either your stomach or your buttocks, hips and thighs, losing weight will lower your chemerin level, which in turn, reduces your risk of metabolic syndrome and heart disease. Losing weight isn't always easy, but it can be done. As a pear or an apple, you may be tempted to do belly-focused or butt-focused exercises to reduce the fat stores in these areas. While spot-focused exercises can help tone and strengthen muscle, they don't reduce the fat in those areas. Your best bet is to focus on the health of your entire body.

#### How People in the National Weight Loss Registry Drop Extra Pounds and Kept It Off

- Ninety (90%) percent exercise, on average, about one hour per day. Many choose to walk as their form of exercise.
- Seventy Eight (78%) percent eat breakfast every day.
- Seventy Five (75%) percent weigh themselves at least once a week.
- Sixty Two (62%) percent watch less than 10 hours of TV per week.

<u>Get Your Sleep</u>: People who sleep fewer than seven hours a night or more than nine hours a night are more likely to gain weight than people who sleep seven or eight hours a night. If you are worried about your growing belly, increase your soluble fiber intake. Research shows that people who consume 10 g of this type of fiber every day store less fat in their belly area. Food sources include nuts, beans, dried peas, flaxseeds, lentils,

oatmeal, oat cereals and oat bran, psyllium, carrots, celery, cucumbers, apples, pears, blueberries and strawberries.

So, now you have it. Apple, Pear or any shape you may have, let's focus on becoming a healthier you. Eat Healthy, Stay Healthy and be Happy.

**Focus on the Reason for the visit:** Ask questions about your condition (Improve the Quality of the Doctor's Visit).

Schedule Future Appointments and Refills before leaving. Follow the Medical Instructions.

His delivery not only included a synopsis of the Entered Apprentice degree for younger brothers, but it also served as a timely review for "seasoned veterans of the craft" who may not have recently revisited the concepts therein. The audience composition was varied to include Right Worshipful Brother, Aubrey K. Barlow, Deputy Grand Master, several 2<sup>nd</sup> District Deputies, Past Masters, Worshipful Masters, Wardens and Brethren from Lodges throughout Illinois. Among the brethren interestingly enough, were two freshly initiated Entered Apprentices who absorbed the navigation of the ritualistic symbols and processes with neophyte enthusiasm.

Along with the vast array of 1<sup>st</sup> degree metaphysical concepts, Past Master Terry introduced the operative masonic term of "*tuckpointing*" which is the common maintenance practice of repairing mortar joints that have become debonded or cracked over time. The rehabilitation process prohibits water entry into brickwork and thus prevents the deterioration of the overall structure. In comparison, habitual review of the foundational esoteric portions of Freemasonry allows Master Masons to keep enthusiasm high despite the constant deluge of bureaucracy, politics and stagnation that may become imbedded within any organization. During the discussion portion of the event, several Brothers confessed that the current unbalanced focus on the "business as usual" portions of Freemasonry have left many disenfranchised.



As a result, Keystone Lodge #15's foundational series seeks to offer brethren a unique opportunity to rediscover the love of the artful science that may have been lost along the way. It presents a much needed respite from systematic redundancies that lead to information constipation. These presentations allow us to genuinely meet on the level with the freedom to choose to become better men. As the next installment in the series approaches, we look forward to continue sharing in the building experience with one and all.




