





Burr Oak Research Project

This project was received Thursday November 9th. The stated goal is locating, photographing and researching the history of the dedication plaque. Who dedicated it & when was the ceremony done.

Saturday November 11th 2007 I went to Burr Oak Cemetery to locate the plaque. I asked the office personnel for assistance in locating the commemorative inscription. After showing them the photo of the stone they searched there records for possible matches; including M.W., Most worshipful, Prince Hall, Grand Lodge, and the names of several Past Grand Masters. They had no record of any of these persons or a dedication. The office staff Mr. Marcus Owens stated that it wasn't in Burr Oak. With no further information provided by the office I then searched the grounds myself. After a two hour exploration I left, to get further direction regarding its location.



After receiving the name and number of a Sister Yvonne German from the Grand Master, I spoke with her and she gave me the location of the stone. Returning Saturday November 18th, 2007 I located and photographed the stone in between plots 457 & 466 on the Fair Lawn. The office then examined their records again, with no results. I spoke with Ms. Carolyn Townsend on November 30th regarding possible ownership of the stone, she informed me that she would take a look at the off site storage records and notify me of any results. A follow up meeting has been scheduled for January 9th.

I spoke with Ms. Carolyn Townsend on January 29th 2007 regarding the search of the off site records as stated in the previous report. I was informed that no documentation existed on the stones owner or when it was placed in the cemetery. She did however offer for us to maintain periodic contact, as more information may become available in the future. I will make it my personal duty to contact Ms. Townsend at least once every six months. It could also be advantageous to review any Grand Lodge documentation that could lead to further insight about the Stone.

It has become apparent with the new found information regarding Burr Oak Cemetery, mass graves, exhuming bodies to resell plots, and inexplicable greed that the documentation that I sought in 2007 could have possibly exposed this atrocity. We intend to make a trek to Burr Oak Cemetery to ascertain the location of the Plaque I initially went to gain information on as well as the other Brothers and Sisters of which I have photographs. Once this is completed a conclusion Report will follow.



Potential Courses of Action

- 1. Apart from to the results of the historical inquiry, have a rededication ceremony of the stone.

 On the Fair Lawn, use this to symbolize the resurrection of the Craft in Illinois.
- 2. Unearthing the stone and rededicating it at the Grand East, also as a resurrection, finding that which was lost and has returned home.

The Stone's Discovery

Sister Yvonne German of Plumbline Chapter 109 was at Burr Oak Cemetery to visit one of her relative's as she walked by a section on the Fair Lawn when she saw two initials on a piece of metal M.W. The rest of the stone was completely covered by rubbish. She then walked closer to inspect the object and saw that it was a Prince Hall dedication. Ms. German asked one of the grounds keepers to clear it for her. They unearthed it and cleaned the stone.

While history on the stone is currently illusive, it can be said, that which was lost has been found. I will persevere with this project and continue to inspect any possible leads that may arise.





Before I sat down to write this paper, I asked myself a question - "what does Freemasonry and music have in common and how could I put the two together?" Well, after interviewing PGM Jerry Butler, I was pointed in the right direction. Musicians traveling in the south during the Jim Crow era were not allowed to go through the front door of many places and were not welcomed in most with the exception of the doors of the Prince Hall Masonic Temples. They were able to enter the Masonic halls to relax and fellowship. So, subsequently, many of them became Masons. Some of these great musicians were bandleaders Lionel Hampton (Boyer Lodge No. 1, New York, NY, PHA) William "Count" Basie (Wisdom Lodge No. 102, Chicago, IL PHA) who was also a Shriner and Edward Kennedy "Duke" Ellington who was a member of Social Lodge No.1 in Washington D.C., PHA Also, Composer, William C. Handy (Hiram Lodge No. 4, New York, NY, PHA) who was known as "Father of the Blues" as well as the melodic pianist, James Herbert "Eubie" Blake. The great crooner Nathanial "Nat King" Cole was also a Mason (Thomas Waller Lodge No. 49, Los Angeles, CA, PHA) as well as Jazz greats Oscar Peterson and Thomas "Fats" Waller. A majority of The Brotherhood of Sleeping Car Porters and their organizer, A. Phillip Randolph (Joppa Lodge No. 55, NYC) became Masons for similar reasons

A couple of Masons that are still with us who are musicians would be Gerald Alston who used to sing lead with the legendary group 'The Manhattans'. He's now a solo artist and the man who still makes the ladies scream, the Rock and Roll Hall of Fame member Al Green.

I would be remiss if I did not mention some local musicians/Masons:

Walter Dyett, the wonderful violinist and musical educator, was Musical Director at DuSable High School. His tutelage groomed many students at DuSable who later became great musicians in their own right. Some of his former students include Bo Diddley, Dinah Washington and Nat King Cole. Although Nat Cole was not born in Chicago, he was raised here and grew up in Bronzeville.

M.W. Brother Henry G. Fort, 33°, 23rd Grand Master of the MWPHGL of Illinois, was an accomplished bass player who played in Nat King Cole's band and was a member of Harmony Lodge No. 88, Chicago, IL.

I also interviewed the Junior Warden of North Star Lodge # 1, the one and only, Bro. Gene Chandler "AKA" 'The Duke of Earl'. I asked him what inspired him to want to be a Mason and he said that when he found out that his longtime friend and mentor, PGM Jerry Butler was a Mason that peaked his interests. He stated that he knew of Bro. Butler's extraordinary character and caliber, so that was enough reason for him to join.

On a side note, Bro. Chandler created a 501c3 benevolent organization titled Project Happiness which is supported by North Star Lodge No. 1. Every year Project Happiness gives out turkeys for the Thanksgiving holiday and for Christmas they give away toys and clothes for needy kids at Stroger Hospital. The organization also gives away Christmas trees for public housing residents and school supplies to kids. They help churches who need assistance during the Thanksgiving and Christmas season and also supply the Maywood Housing Authority with toys for them to give away to the kids. Project Happiness was featured on ABC 7 Chicago news for the wonderful work they do.



Last but certainly not least, M.W. Bro. Jerry Butler, 33°, 41st Grand Master of the MWPHGL of Illinois and also a member of North Star Lodge No. 1. The Rock and Roll Hall of Famer who's affectionately known as "The Ice Man" was the original lead singer of the legendary R&B group, "The Impressions", before branching off into a hugely successful solo career. During my interview with PGM Butler I asked who introduced him to Masonry and he said it was a great trumpet player by the name of Johnny Coles. He also told me an interesting truth about how he became a Mason on site but perhaps I will save that tidbit for a future edition. Needless to say, he ended up joining North Star Lodge No. 1 and they had the insight to Initiate, Pass, and Raise him in ritualistic style.



Now it's time for a little esoteric piece on Freemasonry and music. A Greek philosopher who some of usas Masons may know by the name of Pythagoras studied and practiced music and legend has it that he believed that the distance between the planets could also be compared to the sounds coming from a musical string. He believed the solar system consisted of spheres that revolved around circles and a central fire and that the spheres emitted distinctive sounds that that when combined created a beautiful harmony that is referred to as music of the spheres. Another name that is used in reference to Pythagoras is harmony of the spheres. He's credited with saying that "the planets and stars move according to mathematical equations which relates to musical notes - that creates a symphony.

You may be asking, what does this have to do with Masonry? Well the theory is, the same ratios that are pleasing to the ear from music would also be pleasing to the eye in architecture and architecture is an intricate part of Masonry.

EYES WIDE OPEN

Thirty years ago diabetes mellitus affected over 5 million people in America and diabetic retinopathy was a frequent complication of this disease. Diabetic retinopathy is responsive for approximately 20% if new cases of blindness between the ages of 45 to 74.

Glaucoma is a group of sight threatening diseases that damage the optic nerve, resulting in vision loss. Open angle glaucoma is the most common form and is often associated with increased intraocular pressure. Anyone can develop glaucoma, but those at higher risk include African Americans and everyone over the age of 60. This disease is often called the "sneak thief of sight" because it can go undiagnosed with glaucoma.

Dry Eye Disease (DED) is also known as keratoconjunctivitis, dry eye syndrome, and dysfunctional tear syndrome. Approximately 5 million Americans 50 years and older have moderate to severe DED. DED patients often complain of sandy or gritty feeling, burning and stinging, itching, dryness, eye fatigue, and pain.

The treatments of these ocular disorders vary. It is important to know what your particular health care insurance will pay for. The insurances employ Pharmacy and Therapeutics committees which selects medication that insurance will cover based on clinical and financial considerations.

TIPS

- Monitoring and controlling the blood pressure and blood glucose levels in diabetics can decrease the risk of diabetic retinopathy.
- Glaucoma can be managed by avoiding sunlight, wearing wide brimmed hats, avoid heavy lifting and placing the eye medication in the lower eyelid.
- DED can be managed by taking regular breaks from reading and computer use, avoid excessive rubbing of eyes, use humidifiers, apply warm compresses to eyes, and yawning to stimulate tear ducts.
- Retinopathy and glaucoma require follow up eye examinations with your doctor.

Prince Hall Monument

The purpose of this article is to render to the Illinois Prince Hall Masonic family that a Prince Hall Monument is being built to honor our revered founder Prince Hall, Founder of the Prince Hall Masons fraternity that stretches around the globe that bears his name to this day.

It is without question that Prince Hall is the premier fraternity leader ever to have existed in an African-American context or in American history in my opinion. He made immense contributions to our society not only to the fraternity but to the well being of mankind.

The man Prince Hall was a visionary and opened door's that seemed impossible to open but were not left closed by his hand. This revolutionary hero, wealthy business

motivator, abolitionist. educator. man. community organizer and fraternal powerhouse will be honored with a monument in the City of Cambridge Massachusetts. Also, the City of Cambridge has declared Prince Hall a founding Father of this Country. A team of researchers have discovered that men who were Prince Hall Masons were the principal leaders in the civil rights movement from the beginning of our recorded history to the It was also uncovered by present day. researchers from the Massachusetts Historical Society that the number one "Organizer" and the most influential African-American man of that time, especially in Massachusetts and New England, was Prince Hall. According to Sidney Kaplan, a founding member of the Department of African

American Studies at U. Mass Amherst cited that Dr. Martin Luther King Jr., and others stand on the shoulders of Prince Hall.

When the City of Cambridge was looking for someone to represent the contributions African-Americans made to the City and to the Nation, the name Prince Hall immediately Interestingly, only older Africansurfaced. Americans and Masons knew who Prince Hall was. The Mayor of Cambridge, E. Denise Simmons said "The name Prince Hall was better known when she was a Child". Moreover, the Mayor maintained a high interest in Prince Hall and traveled to England a few years prior and brought back information from the Grand Lodge of England about Prince Hall and around that time as a City Councilor she then introduced a resolution to have the monument built September 12th, 2006. Eventually, the fruits of her labor paid off. The unveiling of the Memorial to Prince Hall on the Cambridge Common is scheduled Saturday, September 12, 2009. Prince Hall will be the first African-American to be honored on Historic Ground near the George Washington Memorial. This would be the first monument in recognition of any African- American on the Cambridge Common, historic for being the site where General George Washington formed the Continental Army and where many African-American men were there to greet him to join the army and fight in the revolutionary war.

The Prince Hall Grand Lodge of Massachusetts is heavily involved in this project. There are Prince Hall Brothers on the Prince Hall Memorial Committee. Hence, Most Worshipful Brother Leslie A. Lewis Grandmaster at the time along with R.W. Earl W. Cole, Jr., Grand Historian representing the Prince Hall Grand Lodge of Massachusetts, standing alongside with other notables including the Mayor broke ground for the memorial Tuesday, October 28, 2008.

There is a grassroots effort going on to educate the Prince Hall family about the monument around the globe. According to of Mitchell Brother Massachusetts. Committee Member stated that letters will be formed by Brothers from New York, Michigan and Massachusetts and they will be sent to each Grand Master and each Prince Hall Jurisdiction. Although, the Prince Hall Grand Lodge of Massachusetts is instrumental in this endeavor while working with the City of Cambridge, donations are needed from the Prince Hall family to secure the completion of the memorial. P.M. Young from Michigan, Committee Member created a slogan, 1,000 Prince Hall Masons to donate \$100.00 and also P.M. Young will stand before the Detroit City Council June 23rd, 2009 to solicit support for the monument. However, donations are being asked from the entire Prince Hall Masonic family as each body is just as important as the other. Microsoft Corporation has donated \$10,000.00 as of date. Nonetheless, this is our time to shine as a Information about the project, history, video and specifics can be found at www.princehallmemorial.org.

The monument has stirred considerable attention. The National Grand Lodge of Greece has sent a letter of full support of the Prince Hall Monument and they have endorsed Prince Hall being named a Founding Father of this Nation. Also, quite a few University Professors have expressed support including intellectual, author and lecturer Dr. Cornell West.


