STATEMENT OF UNITY CEREMONY

With the stroke of four pens, the annals of Scottish Rite history were rewritten at the House of the Temple (Southern Jurisdiction headquarters) in Washington, DC. The historic signing of the Statement of Unity by the four Sovereign Grand Commanders of the regular and recognized Supreme Councils—*United Supreme Council, AASR, PHA, Northern Jurisdiction, USA, Inc. (USC NJ); United Supreme Council, AASR, PHA, Southern Jurisdiction, USA (USC SJ); Supreme Council, Northern Masonic Jurisdiction, USA (NMJ); and Supreme Council, Southern Jurisdiction, USA (SJ)*—was an idea born out of the Sovereign Grand Commander Summit held June 7, 2022, and realized on Wednesday, September 7, 2022.

Thirty-three (33) guests from all four Supreme Councils witnessed the ceremony which was opened with the Invocation delivered by SGIG Leonard Proden, 33°, District of Columbia (SJ). Channeling the late, great Archbishop Desmond Tutu, he quoted a text from "The Testament of Cardinal Mercier"—"In order to unite with one another we must love one another. In order to love one another we must know one another. To know one another we must go and meet one another." An apropos message for a ceremony of unity.

Master of Ceremony and Deputy for the Orient of the District of Columbia (USC SJ)) SGIG Eric F. Konohia 33° , Deputy, Orient of the District of Columbia (USC SJ) requested that the distinguished group of Sovereign Grand Commanders approach the podium to speak on the significance of the occasion.

Sovereign Grand Commander Dr. Melvin J. Bazemore (USC NJ) delivered a powerful oration (see next page). His comments concluded by thanking his counterparts for their vision and cooperation in arriving at this event of historical significance. He reserved the greatest gratitude for Sovereign Grand Commander James D. Cole (SJ) and his staff who worked tirelessly to make this event a success.

Sovereign Grand Commander Peter J. Samiec (NMJ) highlighted that ceremonies are a part of life, but this ceremony has "no peer." He further stated that the four Sovereign Grand Commanders "…provide living proof that diversity and harmony are not exclusive, but are conjoined under the brotherhood of man and fatherhood of God."

Sovereign Grand Commander Corey D. Hawkins Sr. Esq. (USC SJ) reminded all that the purpose of this event was historic and its significance will exist beyond the lives of the participants and witnesses. He further stated that "beyond the four of us...there are no others". He was proud to have the opportunity to literally "make order out of chaos."

Sovereign Grand Commander James D. Cole (SJ) provided background on the genesis of the event and future expectations as recognition and solidarity were the first steps. Cross collaboration will be forthcoming. He closed with "Our Supreme Architect will smile down on us and will say to us 'Well done my good and faithful servants.'"

As we have completed three quarters of the year 2022, a great deal of milestones, honors and historic moments have been realized due to the blessings of our Heavenly Father. On May 7, 2022, I received the degree of Honorary Dr. Humane Letters from Wilberforce University, the nation's oldest private, Historically Black College or University. This institution places its founding to the year 1856 in the great state of Ohio and has remained a stalwart institution for higher education for all. We also concluded a successful 47th Triennial Session in the month of May in the City of Brotherly Love, Philadelphia, Pennsylvania. Our Holy See now resides on "United Supreme Council Way" on a historic renaming ceremony. Visitations at our Triennial not only included representation from the legitimate Supreme Councils in America but also from the Supreme Council of Haiti in the person of Sovereign Grand Commander



Gaetan Mentor. The Samuel J.D. Shook Jr. Class of 2022 in addition to other highlights marked this session, the first in-person session since the COVID-19 pandemic, a historic session indeed.

In the month of June, I met with the Sovereign Grand Commanders of the legitimate Supreme Councils in the United States of America on June 7, 2022 at a historic session. Together, we resolved to create a Statement of Unity and work within these boundaries to ensure cohesion and synchronicity between our Supreme Councils. This culminated in a significant historic event on September 7, 2022 in which we, the four Sovereign Grand Commanders, signed the declaration pledging to work together to secure the legacy of the Ancient and Accepted Scottish Rite of Freemasonry through mutual recognition and joint ventures for posterity. In my capacity as Sovereign Grand Commander of the United Supreme Council, Ancient & Accepted Scottish Rite of Freemasonry, Prince Hall Affiliation, Northern Jurisdiction USA, Inc., I addressed the audience as follows:

Today, September 7, 2022 represents the culmination of the work begun when the Ancient and Accepted Scottish Rite of Freemasonry began in 1801 in Charleston, South Carolina, followed by the Supreme Council, Northern Masonic Jurisdiction. The formation in the late 1800s between the two Prince Hall Affiliated Supreme Council's signing of the articles of union, followed by the joint resolution of recognition between the United Supreme Council, Northern Jurisdiction (PHA) and the Supreme Council, Northern Masonic Jurisdiction dated January 23, 1995, signed by Sovereign Grand Commander Samuel Brogdon Jr. and Sovereign Grand Commander Robert O. Ralston. In 2013 Sovereign Grand Commander Ronald A. Seale extended recognition to both the United Supreme Councils, Southern and Northern Jurisdictions, PHA where their respective Grand Lodges were also in fraternal recognition. As significant as those individual acts of recognition are, I submit that this occasion is even more historic in that it represents the first time the signatures of the four recognized Supreme Councils in the United States will appear on one document, signifying the unity between our respective Supreme Councils.

The Statement of Unity between the Supreme Council, Ancient and Accepted Scottish Rite, Southern Jurisdiction; United Supreme Council, 33°, of the Ancient and Accepted Scottish Rite of Freemasonry, Prince Hall Affiliated, Southern Jurisdiction; The Supreme Council, Ancient Accepted Scottish Rite, Northern Masonic Jurisdiction and The United Supreme Council, 33°, of the Ancient and Accepted Scottish Rite of Freemasonry, Prince Hall Affiliated, Northern Jurisdiction is one of the true examples of operating under the fatherhood of God and brotherhood of man. I am extremely proud to be a part of this historic moment in history and pledge the fidelity of the United Supreme Council, Northern Jurisdiction, Prince Hall Affiliated, to the tenants contained within this Statement of Unity.

There is still room for more history to be made particularly as it relates to enhancing the Scottish Rite Experience. I encourage you, Fraters and Loyal Ladies, to roll up your sleeves and help to make this United Supreme Council the organization of which we can all be proud.





A LIFE-CHANGING LESSON

Years ago, a man learned a life-changing lesson after starting a new job. He wanted to connect with some of his coworkers, particularly with a group of employees who seemed friendly and fun. One day, someone in the group invited the new hire to join them for lunch, and soon he was a regular in their lunchtime conversations.

But before long, the new employee noticed that the topic of conversation always focused on the other workers in the office never in their hearing, and never the kind of things those coworkers would enjoy hearing. The group would laugh and tell stories, making fun of certain workers and criticizing or

complaining about others. After a while, the man had a simple but powerful thought: "What are they saying about me when I'm not here?"

In a rush of acute awareness, he realized that he did not trust these coworkers. He had always assumed that they never made fun of him – but suddenly he wasn't sure. The man decided to find colleagues who were trustworthy friends. And he resolved to be more trustworthy himself.

It's relatively easy to be loyal and kind to people in their presence, especially when it benefits us in some way. It takes integrity to be compassionate also to those who are absent, who may not be in a position to notice and reward our loyalty. In our natural desire to fit in, we sometimes draw boundary lines that exclude others. Too often, we think we'll feel more accepted if others are rejected. All that creates, however is a false sense of closeness.

There is a better way. Think about how you feel around people who are genuinely kind, who look for the best in everyone, and who refuse to take the bait when someone starts to belittle or gossip. Thank of the confidence a husband and wife feel knowing of each other's loyalty, in word and deed, even when they are apart. Imagine how the world might be different if we all sought acceptance by accepting others, if fitting in meant making room, if we treated others the way we hope they would treat us. THAT WOULD BE A LIFE-CHANGING LESSON.

OUR HISTORY SHOULD NOT BE A MYSTERY: XVI

DO YOU KNOW WHERE YOUR CONSISTORIES ORIGINATED?

Coincident with the cover story being about our 9 th Most Puissant Sovereign Grand Commander James F. (Francis) Rickards 33° I thought it would be fitting to only include one profile this issue—that of his Consistory—Wolverine Consistory No. 6.

WOLVERINE CONSISTORY NO. 6

Valley of Detroit, Orient of Michigan, Chartered May 9, 1904/Instituted June 6, 1904

There was a "Negro" Scottish Rite presence in the Orient of Michigan as early as 1890. Most Puissant Sovereign Grand Commander Thornton A. Jackson 33° of the United Supreme Council, Southern Jurisdiction (USC SJ) appointed a Robert C. Waring as Deputy. A Consistory was chartered in the Valley of Detroit under USC SJ sometime between 1890 and 1894 (no name has been found). There are no records of its activity after July 1897.

Wolverine Consistory was organized under the obedience of the United Supreme Council, Northern Jurisdiction (USC NJ) by then S.P. James F. Rickards 32° in what was a harbinger of future leadership. As we should all know he progressed steadily through Scottish Rite leadership by being Elevated, Coroneted, Crowned, and ultimately Elected to be our ninth Most Puissant Sovereign Grand Commander.

Originally numbered "No. 13" (following the chartering of Mount Sinai Consistory #12, Valley of Providence, Orient of Rhode Island) the number was later changed, and the Consistory was assigned the number "6". The number "6" was available due to the original Consistory #6—King Solomon in the Valley of Boston—going defunct in 1899. Wolverine Consistory was subsequently assigned as "#6."

The "Wolverine" name almost certainly derives from the State of Michigan carrying the nickname "The Wolverine State." Also, around the same time there was in existence a Major League Baseball team named the Detroit Wolverines. Now the "wolverine" name is most often associated with the University of Michigan sports teams. Curiously wolverines are not native to Michigan and have been rarely spotted there.

The breadth and depth of the membership includes those awarded the



The United Supreme Council Samuel J.D. Shook Class of 2022 was also presented. Four members are namesakes of a Class of Grand Inspectors General:

- **R.W.J. Jeffery Class of 1957**—He was the first PHA Frater to wear the 33° ring as we know it today; Most Illustrious Commander-in-Chief and Deputy for the Orient of Michigan; Illustrious Grand Recording Secretary and Illustrious Grand Minister of State.
- Homer E. Gaines Class of 1993— Past Grand Master, MWPHGL of Michigan; Most Illustrious Commanderin-Chief and Deputy for the Orient of Michigan; and uncle of current Deputy at Large SGIG Edward B. Darnell 33°.
- Booker T. Alexander Class of 1995—He was an Imperial Potentate, AEAONMS; Past Grand Master, MWPHGL of Michigan; and Sovereign Grand Commander, USC NJ.
- Billy G. Hunter Class of 2017—He was an Active USC NJ member.

An intriguing tidbit of information is that two members of Wolverine also

have Consistories named in their honor—Homer E. Gaines Consistory #112, Valley of Grand Rapids, Orient of Michigan and Booker T. Alexander Consistory #117, Valley of Bamberg (Germany), Orient of Europe.

Similar to four other Consistories-

- **DeMolay Consistory** #1, Valley of Philadelphia, Orient of Pennsylvania;
- King David Consistory #3, Valley of New York City, Orient of New York;
- New Haven Consistory #7, Valley of New Haven, Orient of Connecticut
- **Bezaleel Consistory #15**, Valley of Cleveland, Orient of Ohio

at least two Sovereign Grand Commanders have called Wolverine Consistory #6 home. In Wolverine's case it is three as the 20th and current Sovereign Grand Commander, Illustrious Melvin J. Bazemore 33° holds membership in this Consistory.



SAVING OUR YOUTH: "From Cradle to College"

Continued thanks to our participating Orients (Connecticut, Illinois, Massachusetts, Michigan, New Jersey, Ohio, and Washington/Oregon) for all their support. During the pandemic, we have had to curtail our mentoring programs. Hopefully, our nation is getting back to normal, and we can resume our full mentoring activities. We do have two informational reports of our

mentoring efforts this year, which are included below.

Orient of Michigan—Valley of Detroit SGIG Christopher Buck, 33°—Deputy for the Orient GIG Karl E. D'Abreu, Sr.—Mentoring Coordinator

This conversation is about lessons learned while mentoring. Taking on a mentoring role can be challenging, even for a seasoned mentor. When done properly, it demands time and energy from both parties. However, working together can be fun and stimulating within a mentoring relationship. The mentee wants a safe place to learn and grow. The mentor wants to give that with the right amount of structure and support. Below are four mentoring takeaways I learned as a mentor this past year. Think about these tips for your positive mentoring experience.

1. PUSH THINGS FORWARD

One of the benefits of being a mentor is the influx of fresh ideas from your mentees. Your mentees will inject new energy into your workshops or



meetings. Don't feel threatened, as today's new approaches assist you with what you already do well. A new perspective helps you think of new and different opportunities.

2. FOCUS ON THE FUNDAMENTALS

Ask yourself and your mentee questions such as: What is the important learning that you need for your success? Can you speak about your goals? There is no one better equipped to offer a fresh take on the core basics of the relationship than your mentee. At this stage, they don't have any emotional attachment to what you've created for your course. Thus, it's easier for them to pinpoint the big ideas without bias.

3. PERSONALIZE THE EXPERIENCE; MAKE NO ASSUMPTIONS

With the hectic pace of daily life and the academic school year, it's easy to forget daily civilities and meeting mentees where they are. A simple good morning, or how was your weekend? What are you doing this week? Small talk carries a lot of weight in building relationships.

In relationships, it's the little things that matter, especially when the daily stress levels of the mentee may be elevated. There are many ways to address these details, and get to know each other in building the mentor mentee relationship:

- Share your strengths and weaknesses
- Connect your mentor skill sets to the mentee's goals, be a resource
- Humanize your experience
- Discuss a major success and an epic fail you've had in life, and how you overcame it
- Laugh a little, have fun learning and mentoring

4. CHANNEL THE POSITIVE YOU

Both mentor and mentee will have days when everything is clicking the right way. And as mentors we've all gotten into a flow-like state, engaging students and mentoring effortlessly. But how about those days when things are less than stellar? Maybe you feel tired. Maybe technology is giving you the business. In those circumstances, it's easy to feel negative, pessimistic, and helpless. However, you know you, recalibrate yourself, be positive. Become an inspiration, work as a team with your mentee and discover new strategies for your own personal bag of resources.




USC VETERANS RESOURCE COMMITTEE HOSTS VETS' BENEFITS SYMPOSIUM AT 141st ANNUAL SESSION

Through the efforts of the United Supreme Council Veterans' Resource Committee and under the leadership of SGIG Eugene Anderson, Jr., 33°, our Supreme Council is taking active steps to ensure Veterans and their family

members are aware of federal, state, and local benefits for which they are eligible. The committee is composed of Veteran volunteers with a passion for serving others. They are dispersed across five subcommittees that focus on claims, benefits, legislation, employment, and women Veterans.

During the 141st Annual Session of the United Supreme Council, the Veterans' Resource Committee hosted a Veterans' Benefits Symposium. Nearly 250 people attended the event. Committee members GIG George E. Forest, 33° (Ohio), GIG Tyrone K. Cook, 33° (Europe) and GIG Dr. Lawrence Carter, 33° (Pennsylvania), provided information on claims, benefits, legislation, and federal employment. The event's highlight was an interactive presentation given by GIG Dandrick L. Gallegos, 33° (Far East).

GIG Gallegos serves on the claims subcommittee and works for the Department of Veterans Affairs. He has



How may I upgrade my military discharge characterization?

"Each of the military services maintains a discharge review board with authority to change, correct or modify discharges or dismissals that are not issued by a sentence of a general courts-martial. The board has no authority to address medical discharges. The Veteran or, if the Veteran is deceased or incompetent, the surviving spouse, next of kin or legal representative may apply for a review of discharge by writing to the military department concerned, using DoD Form 293. This form may be obtained at a VA regional office, from organizations or on the Internet: http:// veterans' www.dtic.mil/whs/directives/infomgt/forms/ formsprogram.htm. However, if the discharge was more than 15 years ago, a veteran must petition the appropriate service Board for Correction of Military Records using DoD Form 149, which is discussed in the "Correction of Military Records" section of this booklet. A discharge review is conducted by a review of an applicant's record and, if

requested, a hearing before the board."¹

How do I obtain a copy of my Military Treatment Records?

Records may be electronically requested through the National Archives at https:// www.archives.gov/veterans/militaryservice-records or by completing the SF-180 Request Pertaining to Military Records. To obtain a copy of records possessed by the Veterans Benefits Administration (VBA), such as evidence used in support of disability claims, compensation and pension exams, etc., complete VA Form 20-10206, Freedom of Information Act (FOIA) or Privacy Act (PA) request and submit it to the VBA. A Veteran Service Officer may assist you with this task.

What are some ways to stay abreast of new legislation?

Proposed rules and publication of rules are posted on the Federal Register at https://www.federalregister.gov. "The Federal Register is the official daily publication for rules, proposed rules, and notices of Federal agencies and organizations, as well as executive orders and other presidential documents."² A person may visit the website, establish an account, and automatically receive notifications on different areas, including veteran-related issues. Additionally, an individual may comment on a proposed rule change, etc., before being finalized.

Individuals may also stay informed on congressional and state legislative actions by establishing personal accounts with the following websites and electing for automated alerts of the introduction, passage, and enactment of legislation.

Additionally, congressional hearings on Veteran related legislation may be viewed on some of these websites.

Regarding the Department of Defense Expanding Access to Military Commissaries, Exchanges, and Recreation Facilities.

"Veterans eligible solely under Section 1065 of Title 10, United States Code, (Purple Heart recipients, former prisoners of war, and veterans with a Department of Veterans Affairs-documented serviceconnected disability rating between 0-90%) who are eligible to obtain a Veteran Health Identification Card (VHIC) must obtain a VHIC from the VA to facilitate DoD and Coast Guard installation and privilege access. The VHIC must display the eligibility status "PURPLE HEART", "FORMER POW" or "SERVICE CONNECTED". Visit https://www.va.gov/healthbenefits/vhic for information regarding eligibility for the VHIC and the application process."³

Regarding filing a claim for exposure to particulate matter while serving in Southwest Asia.

"To be eligible for benefits for asthma, rhinitis, or

sinusitis, you must have gotten one of these conditions within 10 years of your separation from active military service."⁴ When filing for any of these disabilities, ensure you have a medical diagnosis of the condition(s).

In closing, the USC Veterans Benefits Symposium was very informative and successful. The committee intends to make it an even better in the following years. We welcome your input, feedback, and suggestions to make improvements and enhance the Scottish Rite experience for our Veterans and their family members.

The USC Social Justice & Civic Action Committee

Dr. Melvin J. Bazemore stated during his Sovereign Grand Commander allocution at the 141st Annual Session, "...for as Scottish Rite Masons, one of our obligations is uniting all masons of all Rites and degrees together over the face of the earth for

the purpose of producing peace, harmony, and concert of action against the enemies of superstition, fanaticism, sectarianism and bigotry." One way that we shall combat these enemies is to educate our communities on the importance and significance of understanding and preparing for new public policy realities. To assist the Rite in these efforts, the Social Justice and Civic Action Committee has been created under the authority of Sovereign Grand Commander Bazemore. Led by

THE INITIAL CONSTRUCT OF THE COMMITTEE

The Social Justice and Civic Action Committee will develop a holistic approach to how fraters can engage in and promote social equity in their respective communities. Leveraging political engagement as a tool to shape and influence social action and public policy issues. While there will be a core group of fraters focused on the overarching strategic vision and direction, the committee will look to each Orient to develop a Civic Engagement team with a designated chair. These Orient Civic Engagement teams will provide information regarding social action and public policy issues specific to their Orient. Through the collaboration of the Orient Civic Engagement teams with the core team members, the Social Justice and Civic Action Committee will monitor state and national issues that impact the various communities of the Northern Jurisdiction.

WHY THE COMMITTEE IS IMPORTANT?

The Social Justice and Civic Action Committee will enhance the voice of the United Supreme Council and increase the scope of actions taken collectively by our Fraters. The committee will craft centralized messaging to the membership as well as offer different calls to action that fraters and loyal ladies can implement. Additionally, we will leverage the Orient local relationships to help amplify the impact that the United Supreme Council can have through our members.

The desire to create Social Justice runs deep in our history and we are going to actualize that desire by becoming better communicators and generating more focus on the subjects and topics we address to improve our communities. Over time we intend to develop our media skills to better present the voice of the United Supreme Council utilizing a variety of media outlets and tools such as continuing to develop press releases and enhancing the use of The Bulletin to communicate our concerns. Also, we will grow our social media presence and expand into video, audio and other communication devices to share internally and externally the important issues for the members of our Northern Jurisdiction as conveyed by our Sovereign Grand Commander.

We intend to bring collective energy and engagement to the ideas we support. Through this committee, the United Supreme Council hopes to get back to its roots and be on the forefront of social and civic issues. Once the committee has stabilized and the Orients have developed their respective Civic Engagement teams, the committee will look to expand our impact through strategic partnerships with national advocacy organizations. In addition, we shall look to provide templates to help Orients and Valleys to host events that bring visibility to the causes we support and encourage.

VOTER REGISTRATION

When most people think about voting, they picture ballots cast every four years, for a national Democratic or Republican candidate. We are less interested in local elections which are just as important as national elections, because they decide so many things that will affect us in our daily lives. There are dozens of positions and propositions to vote on at a local level. Perhaps, the lack of interest stems from the difficulty in learning about the candidates or positions, due to there being less media attention than surrounds a presidential election. Nevertheless, these elections are critical to our democracy.

Many voters are particularly likely to vote in presidential years, but not turn out for midterm elections. Turnout is often lower in midterm and off-cycle election years, which can lead to small, non-representative groups of Americans making outsized decisions about issues like education, housing, criminal justice, policing, and minimum wages. Decisions are being made about our future and often without us. We have seen far too often that elections can really be swayed by small margins, in some cases just a few votes. If our community does not participate, these big decisions will more likely fall into the hands of a subset of voters who do not look like us, do not share our values, and do not have our best interest in mind when making decisions. Making outcomes less representative of the population overall and, specifically for us.

While Black turnout is roughly on par with the average

communities around the major issues. This should help to increase turnout in our community during all election cycles and thus increase our impact regarding the critical issues impacting us.

WHAT YOU CAN DO TO HELP THE VOTING PROCESS

Civic engagement looks different for everyone, but one thing remains true: every voice and every vote matters! When people come together through activism and electoral politics, you can help change the trajectory of our democracy. Fraters, November 8, 2022 is fast approaching. These upcoming midterm elections have been a topic of discussion since December 2020. Soon, conversations about the presidential elections in 2024 will begin to surface. Let's not forget about the 2023 election cycle in many of our communities.

As such, we are asking each frater to **PAC** for the upcoming elections. Yes, PAC! <u>P</u>articipate, <u>A</u>dvocate and <u>C</u>ollaborate.

<u>PARTICIPATE</u>:

Quite simply, vote. If you are a new voter, register as soon as possible. If you have recently moved, make sure that you have updated your registration information. Work to register others who are new voters or have not participated in the voting process recently. Actively participate in non-partisan efforts - e.g. work at a polling place or drive voters to the polls.

♦ <u>ADVOCATE</u>:

Embrace and champion issues that are important to you individually and our respective communities collectively. Educate yourselves and others on the issues at the local, state and federal levels; also on candidates' positions. Once we have educated ourselves, we must spread the word beyond the use of social media.

• <u>COLLABORATE</u>:

Look to work with other organizations who are working to increase voter participation.

Please know that the United Supreme Council is ready to PAC during this, and every, election cycle.

We hope that you will PAC as well. Participate, Advocate, and Collaborate. The United Supreme Council needs you, but more importantly, our communities need you!

Imagine losing your best friend, mentor, and Lodge brother that you have traveled the highways and byways with for decades, and then to become appointed to the position that he coveted so dearly. My feeling of adulation is met with gratefulness and the expectation of being the successor of greatness. There can never be a serious expectation of replacing Sovereign Grand Inspector General Samuel J.D. Shook, Jr. as Dean of Scottish



Rite Instruction for the United Supreme Council, AASR, PHA, Northern Jurisdiction, USA, Inc. You must rise to the occasion and be the man of integrity that he believed you to be and lead and act as such.

Maintaining the integrity of the process and the work that "JD" set forth was very unnerving. I was clear that I was now under the scope and radar of Scottish Rite Masons all over the globe. I was reminded that I am now steering the ship that he carefully assisted in the modern-day crafting of. "No pressure" is what a peer told me, but I felt the weight of the world tap dance in my head. Our visionary and leader, Sovereign Grand Commander Dr. Melvin J. Bazemore allowed me to incorporate some new ideas into the 2022 class, thus there were some immediate modifications that took place.

Modern technology worked and enhanced our process and was the forced change that made us all look at this work differently. As we were all forced to adapt to a post-Covid world perspective, we had no choice, but to conform and appreciate it. Covid-19 brought us into the 21st Century expeditiously, and my instructional team adjusted and performed admirably!

Meeting with the Class of 2022 via Zoom a few months prior to the arrival at our annual United Supreme Council Session gave the team and me a chance to get to know them and likewise, it provided them a chance to know us as their guides through this process. It additionally allowed us a chance to begin the process instructions. With the additional structural enhancements of Zoom and other modifications, we are better positioned, and the class members can enjoy their families and this amazing Scottish Rite experience to the thirty -third and last degree to a greater extent.

These enhancements for this process are a work in progress! We shall continue to enrich the structure as we continually strive for excellence through the elevation process.

Most Puissant Sovereign Grand

The year was 1912. The era was a period in which multiple Supreme Councils consisting of Prince Hall Masons from across the country existed. A time of egotism, pride and vanity in which combative distinctions were resolved through consolidation, it was a year in which many withdrew from bogus Scottish Rite factions and took the Oath of Fealty to either the Northern Jurisdiction or the Southern Jurisdiction, the only two legitimate United Supreme Councils among African American men in the United States of America. It was during this period that Sovereign Grand Inspector General James F. Rickards, 330, served as Sovereign Grand Commander of the United Supreme Council, Ancient & Accepted Scottish Rite, Prince Hall Affiliated, Northern Jurisdiction, USA, Inc.

Illustrious Rickards was born and raised in Dover, Delware on January 17, 1848. Educated in a school established by the Society of Quakers, he relocated to Detroit, Michigan when he came of age and attend Bryant & Stratton's Business College. He relocated to Cleveland, Ohio where he entered the gates of Freemasonry. On March 8, 1869, he was made a Master Mason in Excelsior Lodge #11. Shortly thereafter, he returned to Detroit and became a

founder of Pythagoras Lodge #14 of the Michigan Jurisdiction.

In 1878, Rickards entered under the employ of the United States Postal Service. He was employed as a Letter Carrier and would serve in multiple capacities for the Postal Service over his career which spanned nearly forty years. His rise through the ranks of the Postal Service was done in conjunction with his rise through the community and Masonic ranks which indicates that his destiny in leadership and service was divinely crafted.

> Rickards held membership in St. Matthew's Protestant Episcopal Church. A strong purveyor of faith, he served as its very first Superintendent of Sunday School. In 1886, he was elected Vice President of Branch #1 of the United States Letter Carriers Mutual Benefit Association in Detroit. In 1887, he was elected Right Eminent Grand Commander of the Michigan Grand Commandery of Knights Templar (served for 11 years). Shortly thereafter, he was elected President of the International Conference of Knights Templar. His Scottish Rite elevations followed a similar pattern.

By the end of the 19th Century, the Scottish Rite among African American men was in a state of flux due to the efforts of John G. Jones and Milton Fields. Two additional Supreme Councils were created and many were lured into their ranks. As clarity on the nature of these new Supreme Councils was eventually realized, many in those factions realigned themselves with legitimate bodes and, by the turn of the 20th Century, shifted fealty to either the United Supreme Council of the Northern Jurisdiction (USC NJ) or the United Supreme Council of the Southern Jurisdiction (USC SJ). It was during this era that Rickards made his entrance into the Scottish Rite.

As an active member within the International Conference of Knights Templar, Rickards, undoubtedly, was keenly aware of the challenges within the Scottish Rite. Many of his

Commander James Francis Rickards

York Rite comrades like Richard E. Moore were also prominent members in one of the two Supreme Councils. Moore was a member of Fields' faction while others held membership in the Jones' faction. As such, on December 25, 1903, eight Masonic Brothers were assembled by J. Francis Rickards to organize the start of Scottish Rite Masonry in Michigan. They gathered support from thirty Knights Templar and applied collectively for Scottish Rite Degrees to the USC NJ. Their prayer, which was presented by way of petition at the Annual Session of the USC NJ in Philadelphia on May 9, 1904, was granted and Wolverine Consistory of Detroit was born with Illustrious Rickards, who had subsequently been elevated to Grand Inspector General, as Illustrious Commander-In-Chief.

Illustrious Rickards (right) experienced a swift elevation in the USC NJ. Within a ten year period, he rose from Illustrious Commander-In-Chief of Wolverine Consistory to the



Most Illustrious Commander-In-Chief of the United Supreme Council. His organization of Wolverine Consistory was noticed by Sovereign Grand Commander Joshua David Kelley (left) whose mission became to gather Consistories under Jones and Fields to shift fealty to the USC NJ. In this effort, Illustrious Rickards was appointed Deputy for the Orient of Michigan and became one of SGC Kelly's most valuable swords. In 1906, Illustrious Rickards organized Bezaleel Consistory #15 in Ohio and laid the

groundwork for the transference of the Dominion of Canada from the Southern Jurisdiction to the Northern Jurisdiction in 1908. These efforts and other good works found him elected as Illustrious Grand Minister of State at the 9th Triennial of the USC NJ.

This elevation can also serve as a testimonial to the things that faith had in store for him. Illustrious Rickards' ability to organize and manage appear to have generated a great deal of





confidence in his abilities. These skills, of course, were likely honed during his

leadership and servitude opportunities within his local Lodge and in the York Rite. Yet, at the passing of Sovereign Grand Commander Kelly in 1910, he was elevated to second in command after Illustrious Robert H. Hucless (left), Acting Sovereign Grand Commander. Shortly after the 10th Triennial Session in 1911, Sovereign Grand Commander Hucless succumbed to illness and his spirit returned from whence it came. Thus, Illustrious Rickards was elevated to the Office of Sovereign Grand Commander and would serve for the next ten years.

During his tenure as Sovereign Grand Commander, Illustrious Rickards accomplished a number of high

profile tasks. He continued the mission of his predecessors by bringing new Orients under the umbrella of the Northern Jurisdiction. With the assistance of Illustrious Richard E. Moore who took the Oath of Fealty in August 1912, the Orient of Illinois was officially organized on May 8, 1913. Illustrious Rickards also worked with the permission of Sovereign Commander Robert L. Pendleton of the Southern Jurisdiction to onboard the Order of the Golden Circle to the Northern Jurisdiction. These and other additions extended the Northern Jurisdiction and set the stage for prosperity that would carry over into the administration that followed.

In October of 1921, Illustrious Rickards received a call from our Heavenly Father ordering his spirit to return home. He was preceded in death by his wife and survived by his daughter. A faithful servant, he answered the call. His successor in office was none other than Sovereign Grand Inspector General Sumner A. Furniss, 33°, Sovereign Grand Commander. In honor of Illustrious Rickards, Illustrious Furniss dedicated the first edition of the Bulletin to him.


ORIENT OF EASTERN CANADA

GIG FLUKER—The 32° and 33° are a part of the Scottish Rite—Appendant Bodies. The Scottish Rite, Shrine and York Rite confer symbolic degrees. While they are meant to enrich a Mason's experience further and give more opportunities to serve and socialize with our brothers, they do not confer a higher rank or power to a Mason. All Freemasons are taught that no degree is more elevated than the 3°. The first lesson introduced to every Master Mason is

that we are all equal—we all meet upon the level and part on the square. The 32° in the Scottish Rite is the highest of the regular degrees in that order but the degrees are not even necessarily conferred in sequential order. Each degree has a ritual that goes along with it. Depending on your jurisdiction, you will experience different practices entirely. However, you can participate in any Scottish Rite valley events if you are a general member of the Scottish Rite. The 33°, however, is an extraordinary, honorary degree given to members of the Scottish Rite who have been longstanding members of the Order and performed outstanding service to the Scottish Rite. Simply put, it is the Scottish Rite's "Honor Society". Having this honorary and the last degree bestowed upon me was a dream come true. Sharing a room with men of extraordinary achievements in the Masonic Order will always be remembered as one of the crown jewels of my life. The daily grind of learning what it is to be a 33° Mason in training sessions pushed the message that we are expected to be teachers of the Masonic Order. The degree work was the best I personally experienced in my 26 years in Freemasonry. 



Most Puissant Sovereign Grand Sumner A. Furniss—Part 2

In the early years there were not many issues or complications, but the administration of the Order of the Golden Circle (OGC) proved to be a thorn in his side. Commander Furniss disagreed with the direction that his predecessor had taken. He felt that the should be an auxiliary to the Consistories overseen by the Deputies. His will, accredited by a letter from Most Puissant Sovereign Grand Commander Robert L. Pendleton explaining the original intent, prevailed and the OGC was reorganized.

Originally named the *Committee on Permanent Quarters of the Supreme Council* created by Commander Rickards, Commander Furniss renamed it to the *Committee on Permanent Quarters*, continued his predecessor's work, and chaired the once again renamed *Cathedral Building Committee* which, through diligent efforts in trying times after World War I, raised money; surveyed sites; purchased land; supervised construction to the completion of the Cathedral. During his chairmanship of the committee, he engaged in efforts to sell the idea of a central headquarters for the USC NJ to the rankand-file members. He implored upon the subordinate Consistories the importance of owning a building. He was well suited to this pursuit having been involved in securing a building and raising funds through involvement with a building fund during his time in the John G. Jones organization and his Knights of Pythias Lodge.

A curious set of events between Commander Furniss and Harry A. Williamson changed the course of Masonic history. Williamson, in assisting the Library Committee, intended to donate his extensive collection of volumes about Prince Hall Freemasonry as the basis of the Cathedral library's holdings. He desired to join the planned Consistory in Brooklyn—Long Island Consistory. The backstory is that the application to affiliate was rejected because he was one of the candidates. Correspondence was exchanged with Commander Furniss who reaffirmed the decision as Brother Williamson lived in Manhattan—not in Brooklyn. As a result, Williamson donated it to the New York Public Library. Long Island Consistory #61 was originally to be named *Peter W. Ray Consistory*. This did not happen. Coincidentally, Brother Williamson was related to Illustrious Ray.

The 46th Annual Session in May 1927, was held in the Valley of Indianapolis no doubt to Commander Furniss' influence. At this session Commander Furniss renewed four scholarships the USC NJ previously bestowed on "worthy colored boys." Commander Furniss was pleased to preside over the dedication and opening ceremonies of the recently completed Scottish Rite Cathedral in May 1928. It was the culmination of a labor of love, tremendous sacrifice of the members, and rigid dedication of the committee. Commander Furniss would continue to keep up a frantic pace of activity. One wonders how he did it all.

At the 57th Annual Session (19th Triennium) in May 1938 held in the Valley of Philadelphia, Most Puissant Sovereign Grand Commander Willard W. Allen 33° of the USC SJ was made an honorary member. This was also notable because it was the 10-year reunion of the David Leary Class of 1928. In December 1936,

and SGIG Charles Burns were utilized to provide much needed equipment for our youth. SGIG Andrews serves as a volunteer on the Board of Directors for the not-for-profit organization. The contributions of SGIGs Jackson and Burns in addition to anonymous donations resulted in the purchase of new catchers equipment for the team. A special purchase was made for the one young lady on the team who was selected as an All-Star this year.

Mentorship is alive and well in the

he personally presented the charter for Charles E. Gordon Consistory #36 (Pennsylvania). In early 1939, he jumpstarted the reorganization of the Orient of Nebraska. SGIG Nathaniel Hunter, a Past Grand Master, served as Deputy for the Orient and convened a Council of Deliberation for the first time in many years.

In April 1942, Commander Furniss suffered a huge loss with the death of his wife Lillian. They had been married 37 years. The loss took a toll on him, but in due time he bounced back. In a truly superlative fashion, he was honored, as most other Sovereign Grand Commanders have been, with a Class bearing his name-the Sumner A. Furniss Class of 1946. The notable distinction in this case is that he was still alive when it happened. He moved about the country and visited Consistories on a regular basis. He was always well received and celebrated as a dynamic speaker. He left crowds aghast and hanging on his every word. For as much success as he enjoyed professionally he did have an occasional brush with strife in his personal life. In February 1948, while responding to an emergency call and expecting a sick patient, he was instead met by a robber who purposely placed the false call to victimize him. The robber put a gun to his stomach and relieved him of cash and some personal effects.

In May 1948, during the 67th Annual Session held in the Valley of Philadelphia the Sumner A. Furniss Class of 1946 presented an oil painting featuring the likeness of Commander Furniss. The portrait hangs on the wall in the library at the Cathedral. Shocking the assemblage at the 68th Annual Session held in Valley of Chicago in May 1949, Illustrious Grand Minister of State Leland D. French

Orient. SGIG Charles Burns provided training on mentorship in the City of Springfield over the summer at a special session. The session was well attended. A Memorandum of Understanding was also signed by ICOD with the Illinois Alzheimer's Association at the session. Presented by the efforts of GIG Ray Willis, ICOD is now a sponsor for the organization which aims to promote awareness for Alzheimer's disease.

Under the aegis of the Honorable Melvin Frierson, Deputy for the Orient of Illinois (PHA), the Alms Club, Youth Programs, Education, and Social Services continue to be the linchpins of his overall initiatives. These efforts and other important activities will be detailed in the upcoming 105th Annual Session of the ICOD on October 13 - 16, 2022. The Session will be held at the Abraham Lincoln-Double Tree Hotel located 701 Adam St., Springfield, Illinois.

read a prepared statement of resignation from Commander Furniss as he was not present. It read, in part:

"There is no reasonable hope that I may command the strength . . . to plan or execute the strenuous duties which devolve upon your chief executive officer . . . it is my clear duty to retire to the ranks, and be relieved from the administrative duties and worries . . . ".

Commander Furniss was longest-serving Sovereign Grand Commander occupying the office for almost 28 years—October 1921 through May 1949. By vote he was made the first Sovereign Grand Commander Emeritus. The USC NJ enjoyed the second largest expansion of its jurisdiction during Illustrious Furniss' tenure—18 Consistories were chartered, Samuel W. Gordon Consistory #50 through Alexander G. Clark Consistory #68. He remained busy in his retirement. In April 1950, he was appointed to a Speaker's Bureau in support of a citizens group promoting involvement in politics. In January 1951, Commander Furniss was presented with a 25-year pin from his Lodge. That is not to say that he had been a member of the Lodge for 25 years, only that he was then presented the pin. It may have been the first time the Lodge issued pins of this kind. At that time, he had been a member of freemasonry for at least 52 years.

Commander Furniss passed on Sunday, January 18, 1953, just 12 days prior to his 80th birthday. His suffered from complications due to an earlier hip fracture. His services were held at Bethel AME Church of which he was a long-time member. He was interred in Crown Hill Cemetery in Indianapolis alongside his wife. They had no children.

The Orient of Massachusetts is pleased to share an account of a recent visitation to the Northern Masonic Jurisdiction Council of Deliberation. We are equally pleased to report on our continued Mentoring, Scholarship and Community Services programs. On June 23, 2022 The Deputy of the Orient of Massachusetts and members of the Massachusetts Council of Deliberation were honored to attend the Counsel of Deliberation session for the Northern Masonic Jurisdiction.

As Scottish Rite masons we value what we describe as "warm fraternal relations" between the different masonic bodies within and outside our jurisdictions. For centuries there existed

prohibitions against such relations due to lack of mutual recognition based on constitutional grounds and sadly, based on racism. For scores of decades lodges consisting of Caucasian Masons operated in the same state, city or town along side lodges consisting of Black Masons without any fraternal relations, completely disregarding the Masonic concept of Fatherhood of God, and the Brotherhood of Man. The "legitimacy" of Black Masons was the common excuse used to mask racism.

Thanks to William H. Upton of the Grand Lodge of Washington, author of "Negro Masonry" published in 1902, all questions concerning Prince Hall Masonry legitimacy were put to rest. However the proven fact of Prince Hall Masonry's legitimacy did not immediately sway the tide of racism. Indeed, the Grand Lodge of Massachusetts acknowledged the legitimacy of Prince Hall Freemasonry in 1947 only to rescind their vote a year later. It would not be until 1995 that the Grand Lodge of Massachusetts would recognize the Most Worshipful Prince Hall Grand Lodge of Massachusetts. There has always been those that simply did not want to accept Black Masons as equals, however, true Light cannot be hidden nor extinguished. Today there is recognition of Prince Hall Masonry in all but less than 10 states. We share recognition with the Northern Masonic Jurisdiction Scottish Rite.





Upon receiving a gracious invitation from Ill. George F. Hamilton, 33°, Deputy for the Orient of Massachusetts, Northern Masonic Jurisdiction, on June 23, 2022 SGIG Brightwell, Jr., 33° visited the Northern Masonic Jurisdiction Scottish Rite Council of Deliberation for the Orient of Massachusetts. Ill. Brightwell invited his Council of Deliberation Officers to accompany him on his visit. The Deputy and his Officers were warmly received. He is a part of the collective effort with the Community Foundation for Greater Buffalo and United Way of Buffalo & Erie County, that have established the "Buffalo Together Community Response Fund", which is Co-Chaired by President and CEO of the Buffalo Urban League, GIG Thomas Beauford, Jr. also of Bison Consistory #29. To date \$5.2 million has been committed from nearly 80 local and national foundations, corporations, amd more than 1,600 individuals.

This collaborative effort is built upon the collective desire to take action to support Black-led organizations on the frontlines of addressing immediate needs in the community—community rebuilding and systemic issues in marginalized communities. Black residents of East Buffalo partnered with organizations at LISC Western New York to launch a fund to support and stabilize the Black-owned/led businesses
