Giving honor to God who is the Giver of all good things:

Be it known that I, Aubrey K. Barlow as Grand Master of the Most Worshipful Prince Hall Grand Lodge, do hereby summon all Grand Lodge Officers, Past Masters, Worshipful Masters and Representatives of all Subordinate Lodges who hold allegiance to this governing body to the 153rd Annual Communication of the Most Worshipful Prince Hall Grand Lodge of Free and Accepted Masons of the State of Illinois which, will convene at the Wyndham Springfield City Centre, 700 East Adams Street, Springfield, IL 62701 on Wednesday, July 31, 2019 for the official reception of Grand Lodge Officers and visiting dignitaries and the continuation of the pertinent business of this Grand Lodge. The gavel will be sounded at 7:45 am by Holy City Lodge #150, under the leadership of Worshipful Master Torrence Parker. All annual reports from all officers will be received, the state of the Craft reviewed and all such other business that may regularly and legally come before this Grand Lodge and be transacted.

All Lodges must submit their 4th quarter report and their annual returns report for the period July 1, 2018 through June 30, 2019 typed and properly completed, signed by the Worshipful Master and attested by the Lodge Secretary with the Lodge seal affixed thereto. A copy of these reports must be on file in the office of

the Grand Secretary and the Annual Returns Office no later than **July 15, 2019**. This will ensure that all eligible members are legally seated at this Grand Lodge Session. All reports of Officers and Committees must be typed, a copy forwarded to the Grand Master and a copy to the Grand Secretary by **July 10, 2019**.

This Proclamation is issued by the authority invested in me by the By-Laws of the Most Worshipful Prince Hall Grand Lodge of Free and Accepted Masons in the State of Illinois, Article 1, Section 1, issued under my hand and seal on May 1, 2019 and is to be read in all May, June and July meetings of subordinate Lodges. Take due notice and govern yourselves accordingly.



MEMORIAL DAY ORIGINS

Many Americans trace Memorial Day to the mid-20th Century when it was officially made a national holiday in 1971 and designated as a day to remember soldiers who died in service of the country. Its roots, however, go far deeper.

The year was 1865. The located was Charleston, South Carolina. Shortly after the conclusion of the American Civil War, a group of freed slaves organized to memorialize those who lost their lives in the war that secured their freedom. The emancipated who remained in the town were so impressed and thankful for the efforts that freed them, that they banded together to secure the remains of soldiers who were slain as Confederate Prisoners at the prsion camp situated on the grounds of the Charleston's Washington Race Course and Jockey Club, removed fallen Union soldiers from mass graves, reinterred each of them in individual graves and erected the cemetary grounds around them. With efforts completed, the fallen were deemed "Martyrs of the Race Course". This phrase was affixed upon a sign at the entrance of the cemetary.

On May 1, 1865, the emancipated remembered the fallen by caring for the graves. In doing so, they decorated them in honor of their sacrafices after journeying to the ground via a parade. Graves were adorned with flowers and other deocrations to memorialize the dead. This marked the first memorialization of fallen American Soliders as it is the earliest recorded occurrence of a pre-cursor to the modern Memorial Day Celebration.

Newly Appointed Statewide Coordinator for Deputies



Healthier Eating

Balsamic vinegar; low-fat or fat-free salad dressing; lemon juice; vinegar
Low-fat 1% or fat-free, plain yogurt
Mustard; salsa; fat-free dressing; light/fat-free mayonnaise; light Miracle Whip (regular or Greek style)
Bake, broil, roast, steam grill, microwave, poach
Two egg whites or egg substitute
Nonstick spray or use a reduced-sodium meat stock
Chill soups, gravies and stews in refrigerator. Skim off hardened fat before reheating to serve
Lemon juice or low-fat tartar sauce
Whole wheat pasta; reduced-carbohydrate
Pasta to add fiber or to reduce carbohydrates


Mooney, 43, said it took him 11 years to write the book, which is a compilation of

FEEL FREE TO SHARE THIS LIST

Several bogus organizations trace their lineage directly to John G. Jones, an expelled Prince Hall Mason (right). He was a prominent Chicago attorney. He is considered by many sources to be the Father of Bogus Masonry.

Jones was a member of John Jones Lodge #7. He was elected Master of the Lodge in 1875 but served the Grand Lodge as Grand Secretary (1873-1875) and Deputy Grand Master (1875-1876) while in office. He was <u>suspended</u> and reinstated by the Grand Lodge in 1887. He was <u>expelled</u> along with William Gray in 1903.

Expulsion deprives a man of <u>ALL</u> rights and privileges of Freemasonry. Any acts performed in the name of Freemasonry by one who has been expelled, are NULL and VOID. Those who purport Masonic acts while expelled are knowingly duping innocents. Hence, their subsequent actions relative to Freemasonry are illegitimate and despicable to the ignorant.

Claiming to be Masons, Jones and Gray organized the MW St. John Grand Lodge after their expulsion. This act was done with full awareness of its illegitimacy. While their effort was shunned nationally, it was embraced locally and set a precedent that is used today.

While some of the organizations listed knowingly purport illegitimate Freemasonry, others do so unwittingly. This list is a tool for internal and external use to help ALL to identify legitimate Masonic bodies in Illinois. One must be able to trace their roots to a legitimate source to be removed.



In Freemasonry, some titles and salutations are earned and, unfortunately, cannot even be given on an honorary basis. However, there is some confusion. So let's start with the basics and work our way upward.

A salutation is a method by which an individual is saluted or introduced. Married women are saluted as "Mrs." Single women and saluted as "Ms." or "Miss". Gentlemen are saluted as "Mr." These are natural salutations. However, "Dr." is an earned salutation as it identifies individuals who have completed strenuous requirements. "Esquire" is an earned salutation as it identifies individuals who have passed the strenuous examination to become an attorney. While the former salutations are basically "unearned" because they are natural, the latter are "earned" as labor has been expended to receive the designation. The latter represents the case in Freemasonry.

Before moving forward, it is important to clarify an important fact. The highest salutation that one Mason may give is, quite simply, "Brother". This salutation is also a title. Essentially, every Mason in good standing is a Brother and holds the title of Brother. It signifies a deeper bond in which trust prevails. All good Masons stand by their obligations. The title could not be earned without having taken an obligation and without providing evidence of proficiency. This means that one Brother should be able to trust another Brother in his home when he is <u>NOT</u> present. So, this title, this salutation, is earned and should be revered.

Additional levels of salutation are added to "Brother" based on achievements. "Worshipful" can ONLY be added to the salutation of "Brother" if a Brother has been elected and served as Worshipful Master of a subordinate Lodge under the existing jurisdiction. At his **installation** and **NOT at his election** does this salutation shift from "Brother" to "Worshipful Brother". Once he has passed the chair after his term of leadership, he has become a "Past Master" which is a title. Yet, he will always retain the salutation of "Worshipful Brother" because it identifies that he has, at one point in time, served as a Master of a Lodge.

To have been elected Master of a Lodge is not necessarily a trophy but a duty. It is servitude because the Master is responsible for a great deal. Good service brings honor to one's name and to the Lodge. The initial election of the Brother to the office was obtained, most likely, as a result of strenuous work endured during prior stations and/or places in the Lodge. The salutation of "Worshipful" cannot be granted without service and cannot be bestowed in an honorary fashion. As such, this salutation is an earned one.

The history of the Most Worshipful Prince Hall Grand Lodge of Illinois has several precedents that reaffirm this assertion. One, in particular, is the case of Dr. Walter N. Thomas of Garden City Lodge #59. Dr. Thomas was a highly active member of the Lodge and in the Scottish Rite in the 1920s which drove the brethren of the Lodge to name him an honorary Past Master of the Lodge in 1923. Styled as "Brother" on the records, he earned the salutation of "Worshipful Brother" in 1926 when the Lodge elected him as Worshipful Master of the Lodge. Worshipful Brother Dr. Walter N. Thomas served three terms as Master of the Lodge from 1926 to 1928. He was appointed as Scottish Rite Deputy for the Orient of Illinois in 1929.

Certain rights and privileges come with earning the title of "Past Master" and salutation of "Worshipful Brother". Those Past Masters who have earned the salutation hold membership in the Most Worshipful Prince Hall Grand Lodge of Illinois in addition to their subordinate Lodges. This grants them the voting rights at both levels. Members of the Grand Lodge are also eligible to hold office at the Grand Lodge level. Those who do not have this designation only have voting rights at the subordinate Lodge level with the exception of the Master and Wardens of the Lodge. They are not Members of the Grand Lodge but Representatives of their subordinate Lodges who can vote on the Lodge's behalf in the Grand Lodge.

EARNED FROM SERVICE

Salutations for Members of the Grand Lodge or Past Masters are controlled at the Grand Lodge level. While "Appointed Grand Lodge Officers" retain the same salutation of "Worshipful Brother" as Members of the Grand Lodge, "Elected Grand Lodge Officers" prefix the salutation with either the word "Right" producing "Right Worshipful Brother" or "Most" producing "Most Worshipful Brother". The word "Most" replaces the word "Right" in the Illinois jurisdiction <u>ONLY</u> in the case where a brother has been elected as Grand Master. Actual Grand Masters and Past Grand Masters from Illinois and other recognized jurisdictions who have been elected Grand Master are also saluted in the same fashion.

For clarity it must be stated that once a Member has earned a salutation, it remains his permanent salutation even after he has passed the office. This is the case because the Members and Representatives of the Grand Lodge saw fit to elect that Member of the Grand Lodge as a "Right Worshipful Brother" or "Most Worshipful Brother". It became effective when the Member was installed and was, subsequently, earned with service. As such, the salutation will always remain in effect.

Historically, there have been <u>exceptions</u> many of which were followed by changes to the Constitution and Bylaws of the Most Worshipful Prince Hall Grand Lodge of Illinois:

- Honorary Past Grand Masters: "Honorary Past Grand Masters" who had not served as Actual Grand Masters were previously saluted as "Most Worshipful Brother". They are now saluted with the salutation that aligns with the highest office that was served - "Right Worshipful Brother" or "Worshipful Brother".
- Brother to Right Brother to Right Worshipful Brother: At the formation of the Grand Lodge in 1867, Harrison D. King of North Star Lodge was elected Deputy Grand Master of the Grand Lodge while serving as Senior Warden of North Star. He wasn't elected Worshipful Master until 1869. William L. Darrow was elected Grand Junior Warden (1867-May), Grand Senior Warden (1867-June) and Deputy Grand Master (1868) while serving as Worshipful Master of North Star (1867-68). John G. Jones was elected Grand Secretary (1873-75) before serving as Worshipful Master of John Jones Lodge #7 in 1875. <u>Article VIII</u> <u>Sections 2 & 3</u> of the Constitution was updated to incorporate a provision to prevent election to Grand Lodge offices for those who have not served or are currently serving as Worshipful Master.
- Worshipful to Most Worshipful: The highest office served by Austin Perry prior to being elected Grand Master in 1883 was Worshipful Master of Eureka Lodge #13 of Mattoon, Illinois. <u>Article VIII Section 4</u> of the Constitution was updated to incorporate a provision to limit eligibility for election to the Offices of Grand Master or Deputy Grand Master <u>ONLY</u> to the Grand Wardens.

The science behind the construction of salutations is simple. The salutation is built from the offices to which a brother has been elected and served. In accordance with the Constitution and Bylaws of the Most Worshipful Prince Hall Grand Lodge of Illinois, a brother cannot become a "Right Worshipful Brother" without having first become a "Worshipful Brother" nor can he become a "Most Worshipful Brother" without first becoming a "Right Worshipful Brother". This is the law.

In circumstances where no precedents have been set, the question of eligibility falls upon the Grand Lodge to make an <u>ad-hoc</u> determination. These determinations may or may not be fully accepted by all of the Members or Representatives. As such, discussion on this scenario may be required to prevent situations that could become uncomfortable. None-the-less, clarity relative to salutations is clear—**BROTHER to WORSHIPFUL BROTHER to RIGHT WORSHIPFUL BROTHER to MOST WORSHIPFUL BROTHER.** In these instances, each variation of the "Worshipful" salutation is clearly earned.

NAMESAKE LODGE SERIES: Charles E. Gavin Lodge #143

The 143rd Lodge chartered by the Most Worshipful Prince Hall Grand Lodge of Illinois was Charles E. Gavin Lodge of Chicago Heights, Illinois. It was organized in 1976 as the namesake of Dr. Charles E. Gavin. He was considered a civic giant and humanitarian in the South Suburban Chicago area and was a man who exhibited traits that are certainly worthy of emulation.

Dr. Charles E. Gavin (left), affectionately known as "Buddy", grew up and lived in Chicago Heights, Illinois. He attended Bloom High School and was recognized for outstanding, academic achievement. He was admitted into the National Scholastic Honor Society which marked the first time an African-American student at the school had gained admission. He was called to serve in World War Two after graduation. After completing his service in World War Two, he returned to Illinois to complete collegiate studies that would help him to achieve his goal of becoming a medical doctor. He enrolled at the University of Illinois and received his Bachelor of Science degree in Chemistry with high honors in three years. He received an academic scholarship and attended the University of Chicago obtaining a Master's degree in inorganic chemistry. He earned his medical degree from the University of Illinois, becoming one of the first African Americans to be certified and admitted after only one year of practice into the National College of orthopedic surgeons. Dr. Gavin earned employment at St. James Hospital in Chicago Heights, Illinois after post-collegiate studies. He gained renown as a surgeon and a strong manager. His high degree of skill and intelligence elevated him to the head of the orthopedic staff requiring him to develop that department at the hospital.

While his educational and leadership accomplishments were extraordinary, he was known within the Chicago Heights Community as being one of its most outstanding community servants. He was known for providing free health care to many who could not afford it. His activism in multiple social and fraternal circles

were of the highest quality and served as additional outlets for his humanitarian service. All people regardless of their socioeconomic status, ethnicity, or creed received outstanding quality medical care with respect and dignity from Dr. Gavin.

The untimely death of Dr. Gavin on January 9, 1971 at 44 years of age struck a blow to the Chicago Heights community at large. The amount of free services that Dr. Gavin provided the community were so enormous that the citizens of the city took steps to ensure that he would be remembered. Shortly thereafter, the Dr. Charles E. Gavin Memorial Foundation was organized to extend the benefits granted by Dr. Gavin. The Foundation's endeavors remain in tact and include the granting of financial aid, assistance and guidance to men and women enrolled in colleges and universities, the granting of aid and assistance for the furtherance of sound and effective health care and the granting of aid and assistance for furtherance of human love and understanding among races and creeds in our society. The City of Chicago Heights also worked to ensure that this giant would not be forgotten. In doing so, Dr. Charles E. Gavin Elementary School was erected. The school closed its doors in 2010 due to lack of enrollment. However, the resurgence of citizens in the communities shortly thereafter saw a need for the school to re-open. It re-opened as Lincoln-Gavin Elementary in 2012 and remains a part of the Chicago Heights School District 170.

Charles E. Gavin Lodge #143 was chartered in 1976 by the hands of Most Worshipful Brother James H. Black Sr. The Charter Worshipful Master of the Lodge was Tommie L. Thompson and the Lodge remained active through the 1990s. However, the migration of many to Chicago was the primary factor for the loss of membership. The Lodge surrendered its charter in the year 2000.

It is widely known that African American men carry some of the greatest burden of health disparities. In the United States, cardiovascular/heart disease and cancer are known to be the top causes of death and illness (Centers for Disease Control and Prevention-CDC, 2019). According to the American Heart Association (AHA), cardiovascular/heart disease is not just one condition, but multiple conditions that include diseases associated with the heart and blood vessels (AHA, 2019). Compared to white men, black men are almost two times more likely to suffer poorer outcomes from cardiovascular/heart disease (ACS, 2019). For cancers such as lung, prostate and colorectal, black men are more likely to be diagnosed with a more aggressive cancer and die at younger ages (American Cancer Society-ACS, 2019). There are many reasons that point to why African American men suffer a greater burden of disease, including: the associated stress with being a black man in America, diet and life-style factors, family history, and ease of access to health care professionals. Other important factors often overlooked when analyzing this burden of disease may include: men's understanding of their own health, masculinity, and the cultural awareness of health care providers who understand the multiple factors impacting the health of African American men.

The University of Illinois Cancer Center (UI Cancer Center) is committed to addressing the health needs of individuals, communities and families by forming partnerships that increase access and awareness to prevention, education, screening, early detection, treatment and research. Robert A. Winn, M.D., serves as the Director of the UI Cancer Center and is currently the only African American male in this role in the United States. We are committed to ensuring that communities and individuals such as African American men have access to innovative care, cutting edge research and comprehensive support for those living with cancer. Our "Bench to Community" model of the UI Cancer Center means as an institution we are committed to understanding how cancer research at the smallest cellular level directly influences health outcomes at the level of communities and zip codes in which we live. It is by working with community partners such as The Most Worshipful Grand Lodge State of Illinois Family that the UI Cancer Center is able to achieve its vision and mission to improve health outcomes of individuals, families and communities. Below, we provide five important steps that African American men can take to improve their health outcomes for cardiovascular/heart disease and cancer.

1. DEVELOP A RELATIONSHIP WITH A PRIMARY CARE PROVIDER

The UI Cancer Center and its affiliation with the University of Illinois Hospital and Health Science System - known as UI Health - is one of only a handful of academic medical centers that has a direct affiliation with a Federally Qualified Health Center (FQHC). Since the *War on Poverty* in the 1960s, FQHCs executed a federal mandate to ensure medically underserved communities have access to primary care. The UI Cancer Center keenly advocates for primary health care because of the importance it places on prevention and early detection of cancer and disease. We often get asked, "*What cancers should black men get screened for*?" A consistent relationship with a primary care provider (PCP) ensures one has a health care professional who is addressing all their health needs on a regular basis. A PCP can determine one's heart health by using evidence-based risk assessment tools informed by lifestyle, blood work, and family history. The PCP will also know which cancer screenings are appropriate for the African American man. Most, if not all, health insurances cover an annual checkup with a primary care provider for preventative health.

2. UNDERSTAND YOUR FAMILY HISTORY

As a culture, family has always been a central part of the African American community. However, when it comes to health histories, African American families do not always engage in open conversations about what conditions, diseases and illnesses impact one's family. For example, many cancer screenings are recommended based on what age a first degree relative such as a father, brother or son was diagnosed with an illness. Currently, we know that only about five percent to 10 percent of cancers are associated with a defect in the DNA that can be passed on from parent to child. In some cases, getting screened five to 10 years before a first-degree family member was initially diagnosed with cancer or heart disease can improve the health outcomes of African American men.

3. ENGAGE IN PHYSICAL ACTIVITY AND MAINTAIN A HEALTHY DIET

In studying community health, there are two types of risk factors that increase your chances of getting a disease or condition: modifiable risks and non-modifiable risks. Modifiable risk factors are lifestyle decisions one has the ability to change or improve. Examples of modifiable risk factors include: diet, exercise, tobacco, alcohol, recreational drugs, and exposures to certain environments. Non-modifiable risk factors are innate or fixed circumstances one cannot alter. Examples of nonmodifiable risk factors include family history and genetic ancestry. African American men have no control over the health issues that our fathers, brothers and other family members battled. Nevertheless, we do have more control over what we do and what we eat to ensure better health outcomes. Engaging in daily physical activity for at least 20 to 30 minutes of consistent movement is known to improve health outcomes of African American men. Types of exercise can involve exercising in a gym, playing a pick-up basketball game, or even speed-walking with the brothers of the Masonic Family. Additionally, a diet low in fat and processed foods and rich in fruits, vegetables and healthy grains has been scientifically proven to improve heart disease and cancer outcomes in African American men.

4. LIMIT THE AMOUNT OF STRESS AND FOCUS ON HEALTHY MENTAL HEALTH

The UI Cancer Center is fully aware that black men in America face mental and behavioral health exposures such as stress, racism and social isolation that negatively impact the health of African American men. We also understand that discussions on topics such as depression, anxiety and Post Traumatic Stress Disorder (PTSD) are often taboo in African American households. There is growing evidence that screening for anxiety and depression among African American men can provide insight to help men cope with the daily stress that can accompany being black in America.

In addition to the biological elements associated with cancer, we are learning more about the impact of the environment, diet, stress and lifestyle on cancer cells. The evidence suggests one's zip code may have similar influence as one's genetic code on health outcomes. The study of the environment impacting the genetic code is termed *epigenetics* in medicine. In other words, where you live and how you live can change how your genes respond.

5. LEARN MORE ABOUT THE IMPORTANCE OF RESEARCH

It is no secret that the African American community has not always had a good experience with health related research and clinical trials. The memory and methods of studying syphilis in African American men conducted by the U.S. Public Health Service at Tuskegee in the 1930s to 1970s and the legacy of Henrietta Lacks are just two painful examples of how research has been done "on us" as opposed to "with us" or "for us." Now, more than 40 years later with comprehensive federal laws protecting all research participants, the UI Cancer Center has partnered with African American men to form a group called the *Citizen Scientists*. These are everyday men, one of which is even a member of the Prince Hall Masonic Lodge, who are committed to ensuring that research is done "with" African American men instead of "on or to" African American men. It is important that African American men and other diverse communities encourage research that specifically relates to communities of color to promote innovative drug discovery, state of the art surgical procedures and holistic support from screening to cancer survivorship. Citizen Scientists are "grass-roots" researchers who help shepherd medical research within communities of color to be "for us and by us."

The UI Cancer Center is committed to addressing the cancer needs of African American men in Illinois and the U.S. Under the leadership of Dr. Winn, the UI Cancer Center is able to engage in comprehensive discussions about cancer, stress, food insecurity, heart disease and diabetes. We are grateful for the opportunity of partnering with The Most Worshipful Prince Hall Grand Lodge State of Illinois to ensure African American men and their families and communities across the State become aware of and gain access to evidence-based health information and comprehensive health care services that will improve their health outcomes. He served as Worshipful Master of the Lodge in 2002 and worked to uphold his duties as Master of the Lodge. Nearly 15 years after leading Rufus Mitchell, did his son, Steve Zackery attain the same office in Keystone Lodge #15 of Aurora. This father-son combination now serve as District Deputy Grand Masters for the Most Worshipful Prince Hall Grand Lodge of Illinois in its 2nd District.

Sons who follow in the Masonic footsteps of their fathers, grandfathers and other extend tradition ancestors the of Freemasonry through the bloodline. Jerrail Johnson of Jericho Lodge #120 became the recipient of a very special gift from his father, Past Master Reginald Johnson in September of 2018. The Coopers represent a strong family within the ranks of Freemasonry. Their familial bonds have translated well in the Masonic ranks. Rev. Clyde W. Cooper Sr. holds nearly half of century in Prince Hall Freemasonry. His service earned him



the style of Deputy Grand Master Emeritus of the Grand Lodge. He and his wife, Sister Anna M. Cooper, are also Past Worthy Grand Patron and Past Worthy Grand Patron of Eureka Grand Chapter Order of the Eastern Star. Rev. Cooper served as Worshipful Master of Wayfarers Lodge #128 in 1978. Charles Cooper Sr. served as Master of the same Lodge in 2001 and 2002. Sister Julia Cooper has held leadership roles in the Order of the Eastern Star as well as multiple Appendant Bodies. Right Worshipful Brother Jim Brown, Grand Trustee, also is a part of this family through marriage. When considering all accomplishments, they clearly qualify as a high profile Masonic family and collectively account for a century of Freemasonry.

The Senior-most member in the chain is Right Worshipful Brother Kenneth R. Ingram, #1 (top-right corner). Ingram served as Worshipful master of North Star Lodge #1 in 1984 and was selected as the Grand Lodge Mason of the Year during the same term. His niece, Shaneka (Ingram) Andrews, #114 OES is the wife of Past Master Troy Andrews, #91 (second row-middle). Troy Andrews is the brother of Right Worshipful Brother Daryl Andrews, #91 and Kyle Andrews, #91 (top-center). All three are Past Masters of Cornerstone Lodge #91. Daryl served as worshipful Master of the Lodge in 2005 and 2006, was selected as the Grand Lodge Mason of the Year in 2008 and was an Elected Grand Lodge Officer. Kyle served as Worshipful Master in 2013 and 2014. Troy served as Worshipful Master in 2015 and 2016. Sister Dana Andrews,#114 OES (second row-left) is the blood sister of the Brothers Andrews (family photo) who are the children of Clyde and Darlene Andrews. Sister Theresa Nikki Young, #126 OES (second row-right) is also the niece of Ingram and blood cousin to Sister Shaneka Andrews. Sister Gwendolyn Howell Andrews, #114 OES is the wife of Past Master Kyle Andrews (top-left). Sisters Shaneka, Nikki and Gwen are all Past Matrons. For Clarity, the Andrews siblings pictured above from oldest to youngest are Kyle, Troy, Daryl and Dana.

Familial bonds that were identified after research extended the bonds from the Chicago area to Central Illinois. As verified through Ancestry.com, Past Master Richard Andrews, #22 is the blood relative of the Chicago Andrews. Past Master Ronald Bell II, #23 is the blood cousin of Richard. Richard is the blood cousin of Brother Tyrone Andrews, #91 (not pictured) who was raised a member of the Lodge one year before Daryl Andrews over twenty years ago.

The familial recognition between Daryl Andrews and Kenneth Ingram came at a family Christmas gathering with the Ingrams in 1998. It was discovered that one of the sons dated the daughter of Past Master David Johnson, #91 which is the Past Master that brought Daryl into Cornerstone Lodge. Through this connection and subsequent conversations, Kyle and Troy joined Cornerstone Lodge #91. Their wives joined Princess Syene Chapter #114 along with their sister, Dana.There are more Andrews in the Masonic ranks of the Illinois, Louisiana, Mississippi and California jurisdictions. With the advancement of the Richard's son and potential for future members, the roots run deep and the potential is very high.

There are other families in the Illinois Masonic ranks that have similar linkages like the Coopers and the Andrews. Many are father-son combinations that were on display at the Father-Son luncheon at the Grand East earlier this year (below). Sponsored by the Membership Committee under the direction of Past Master Larry Burnett, fathers and sons under the Masonic umbrella were invited to share lunch and discuss their bonds. These families are only scratching the surface of all of the familial ties in the Illinois Jurisdiction. We look forward to more family ties in the future.



My Brethren, Prince Hall Masonry has been around for a very long time. Most Worshipful Brother Prince Hall was the first African American to be made a Mason in



America on March 6, 1775 in Boston, Massachusetts. He is our first Grand Master (per Prince Hall Grand Lodge of Massachusetts). We are talking about a man who was a slave who rose from slavery to become one of the most respected men in American History.

It is because of his dedication, his labor, his numerous sacrifices, and his vast contribution to society that we exist today. It is because of



Most Worshipful Brother Prince Hall, that today, there are over 5,000 Prince Hall Lodges with Forty Seven (47) Grand Lodges. In each of those organizations, there are at least 3,000 Master Masons. We, the Prince Hall Masonic Family of Brothers and Sisters, Nation Wide, are the fruits of Prince Hall, labor, dedicated services and sacrifices.

So, to my Brothers who are coming into Prince Hall Masonry, take advantage of the knowledge in your surroundings, namely, your "Past Masters". Ask your Past Masters questions, read, study, and attend the School of Instructions. Right Worshipful Brother Glenn Pickett, Grand Lecturer, is in charge of the Most Worshipful Prince Hall Grand Lodge School if Instructions. The Office of the Grand Lecturer is one of great importance. The Grand Lecturer is the recognized teacher of the Masonic System and it is by his faithful instructions "alone" that unity can be maintained in the methods of communicating our ritual.

Right Worshipful Brother Glenn Pickett is a fantastic lecturer, a dedicated brother, my friend, and my Western Consistory No. 28, 2002-2003 "Bowie/Clark" classmate. He will teach you well. You will be amazed in the knowledge you gain.

Brethren, a question, "not asked", is a question, "unanswered". Remember, if Prince Hall Masonry is worth joining, it is worth knowing something about. What you put into Masonry is what you get out of Masonry.

THE "AFRI

When I was first brought to Masonic light in 1991, my expectation was that there would be African implements adorning the Lodge meeting room – that there would be the spear and shield; the drum and shekere; the red, black and green flag. Yet, there were no African implements and neither was there any evidence of an African influence, other than the lingering notion that ancient Kmt we know as Egypt had something to do with it.

Upon reading the teachings of Dr. Chancellor J. Williams in his seminal work, THE DESTRUCTION OF BLACK CIVILIZATION (1971), I was reminded of a fallacy in our ritual text, and the Most Worshipful Prince Hall Grand Lodge soon acknowledged that the Africans taught the Greeks and the Romans the science of architecture and the other sciences that were needed to develop an advanced civilization. To further cement this idea into our consciousness, Dr. Jacob H. Carruthers teaches in his important tome, MDR NTR (1995), the essential truth that the mathematics and sciences are divine speech (of God) that helps us to understand and define the mystery of Creation. The term Mdr Ntr represents African deep thought and is taken from the language spoken in ancient Kmt.

The simple idea that the mathematics and sciences are intended to explain the mysteries of Creation is quite settling and could be helpful in opening the door to understanding for many African children in our public schools, today. Moreover, that God explains His or Her Creation in simple terms of arithmetic, geometry, algebra and the higher mathematics, and in terms of chemistry, physics, biology and other physical sciences is no longer fearful and threatening. Our Grand Architect has given us a language through which we communicate our understanding of life, space and time in a manner that transcends opinion and prejudice. This is the African in it.

Deep thought is essential. Consider the point within a circle. This ancient symbol means head and infers intelligence, understanding, comprehension and competence in the language syllabary of the Vai people of Liberia, West Africa. In the Vai language the symbol is called kuŋ. This is the African in it.

In closing, let me say that the main lesson I learned during my study of the first 3 degrees in

Masonry is that I must embrace change. African deep thought requires flexibility, strength and change in recognition that we are engaged in intellectual warfare. The fundamentalist Christian must concur, in a sense, that Mr. Devil is constantly challenging our morality and intellect, which becomes clear to us when we witness what is happening in our environment and society today. The Akan people of Ghana, West Africa long ago invented a system of funerary symbols that were intended to express the character and interests of the deceased family or tribal member. Those symbols are called Adinkra symbols and have emerged into popular worldwide usage. The symbol I want to share with you is called Nkyinkyin (below) and is thus described:


Pronounced, n-chin-chin, this symbol literally means, twistings and refers to a person's ability to adapt and change, according to W. Bruce Willis in his book, THE ADINKRA DICTIONARY (1998). Willis informs us that change is central to our ability to succeed. More simply put, Willis reminds us that changing our attitudes, habits and behaviors may lead us to desired outcomes, where a failure to change only maintains the status quo. This is the African in it.



The exploration of African languages and writing syllabaries tends to brighten and adorn our minds. Befitting the lessons that are introduced during the Chamber Work of the 2nd degree,

where the liberal arts and sciences are subtly recommended to our consideration, I recommend language arts and linguistics as a further means to engage in African deep thought. Dr. Mulana Karenga teaches us that Kawaida philosophy insists that the African engage in constant dialogue with himself and each other as a means to assure Unity – to which I add good health and prosperity. This is the African in it.

As a direct result of the symposium, several new petitioners moved forward to steps for membership and several bogus Masons filed petitions to be healed into Prince Hall Freemasonry.






YOUTH SHINE AT GRAND EAST ANNUAL BLACK HISTORY PROGRAM

Knights of Pythagoras

The Knights of Pythagoras Program is the namesake of Pythagoras, a Greek philosopher who lived about 2,500 years ago. He worked in the fields of music and geometry. He formed a religious society and wrote a general account of the world.



Pythagoras was born on the Island of Samos, near Greece. Later, he lived in Crotona, in the Southern part of Italy and formed a religious brotherhood. The members of this brotherhood lived according to rules that Pythagoras laid down. The group believed that after men died their souls went into other bodies, sometimes in the bodies of animals. This concept is known as transmigration of the soul. It is felt that Pythagoras may have obtained some of his ideas during his travels in the East. Pythagoras also believed that the earth was spherical and the sun, moon, and planets have movements of their own. His successors developed the idea that the earth revolved about a central fire. This belief anticipated the Copernican Theory of the universe.

As a philosopher, Pythagoras taught that numbers were the essence of all things. Therefore, he associated numbers with various colors and ideas. This concept in addition to the aforementioned appear to have come from his studies at the great school in Egypt. The Pythagorean theorem which provide a formula for the 3-4-5 triangle appears to align with the pyramids of Africa and several other instances of construction principles utilized by that nation. As such, his beliefs that were based on Egyptian influence were customized and are now renown across the globe.

The Illinois Jurisdiction has had three Lodges that took on the Pythagoras namesake—Pythagoras #63 of Brookport (inactive), Pythagoras Lodge #132 of Prospect (inactive) and Pthagoras Lodge #134 of Chicago (active). These Lodges were named to highlight the importance of striving forward through education and practical application of mathematical principles and skills. In contemplating the name for a new national youth order that would focus on math and education, the Conference of Grand Masters of 1951 entertained multiple options. Under the leadership of Grand Master Amos T. Hall, the name "Order of Pythagoras" was selected over "Chivalric Order of Knight Companions" during their Annual National Conference, May 8 - 10, 1951, in the City of Denver, Colorado. Hence, the name and the focus of the Knights of Pythagoras Youth Fraternity was established.

Grand Master P. G. Porter of Kansas, was elected the Supreme Master Knight of the International Supreme Council of the Order of the Knights of Pythagoras, August 17, 1958, at the National Supreme Councils of the Knights, Chicago, Illinois. A revered Mason, Porter's contributions were numerous and his advocacy for the order was so tremendous that it was adopted by several Southern Grand Lodges. Within a short period of time, the Grand Masters and representatives of twenty Prince Hall Masonic Jurisdictions implemented the Order in their jurisdictions and worked untiringly in promoting the Order and supplying its needs. This order is the youth organization that has been adopted and remains support by the Prince Hall Conference of Grand Masters today.

The Illinois Jurisdiction recently adopted the order as its premier youth order. The Order of the Junior Craftsmen was the home grown youth Order for Illinois since the 1930s. The same principles of education and leadership that were instilled in thousands of youth in the Order of the Junior Craftsmen are the same principles that are promoted in the Knights of Pythagoras. In order to align with the other jurisdictions and to implement this national program within its borders, the Illinois Jurisdiction approved a recommendation to adopt the new order. By the hands of Worshipful Brother Ron Wilson, Director, the efforts to move forward are now underway.




WHAT'S IN YOUR


