


## **Grand Minister of State**

## **Our History Should Not Be A Mystery: Part XV** DOYOU KNOW WHERE YOUR CONSISTORIES ORIGINATED?

This column has been running for some time now and more than half of our Consistories have been profiled. The ones that are remaining either have no known written histories: have been defunct time; and/or scant for some information remains. As mentioned in the last edition many of our Tall Cedars are being felled by Father Time and with them all the history of our various bodies becomes lost. However, the show must go on. Please read and enjoy.



#### Kennett Square Consistory No. 36 Valley of Kennett Square Orient of Pennsylvania Chartered early 1920s (Defunct)

This Consistory was eponymously named for the city in which it was located—Kennett Square. It was chartered during the tenure of Most Illustrious Commander-in-Chief and Deputy for the Orient of Pennsylvania S.G.I.G. Howard D. Gould 33°. Not much is known about this Consistory as is existence was very short. It went defunct around 1923. As a bit of further history, Kennett Square is known as the Mushroom Capital of the World.

#### Prince Hall Consistory No. 67 Valley of Seattle Orient of Washington/Oregon Chartered May 12, 1945

The naming of Consistories would not be right if there was not one named after our patron saint of sorts—the very reason for our existence—Prince Hall. This honor goes to the Fraters in the Orient of Washington/Oregon.

The first Consistory named "Prince Hall" was chartered on November 10, 1879, in Chicago under the aegis of John G. Jones. Sometime later another Prince Hall Consistory (USC NJ) was chartered in York, Pennsylvania, but has since become defunct. Interested Brothers in the Seattle area formed a club called the "Prince Hall Club" and from there the Consistory came to life.



Eventually from their ranks emerged honorary Past Grand Master of the Most Worshipful Prince Hall Grand Lodge of Washington; past Most Illustrious Commander-in-Chief and Deputy for the Orient of



Japan; and our 14th Sovereign S.G.I.G. Grand Commander, Russell S. Gideon 33°. So impressive an individual was he that a Gold Medal of Achievement was bestowed upon him in May 1980 at the 99th Annual Session (33rd Triennium) in the Valley of Philadelphia. At the 105th Annual Session (35th Triennium) held in the Valley of Philadelphia, the Class of 1986 was named in his honor. Additionally, G.I.G. Samuel J. Smith 33° was a Gold Medal of Achievement awardee in Chicago in May 1978 at the 112th Annual Session.

Of note, S.G.I.G. Joseph I. Staton 33°, Most Illustrious Commanderin-Chief and Deputy for the Orient of Washington/Oregon and Most Worshipful Prince Hall Grand Lodge of Washington was a member of this Consistory. There is a Consistory named in his honor in the Philippines belonging to the Orient of the Far East.

## VA Home Loans and Predatory Practices

### VETERANS CORNER OF THE BULLETIN

The Veterans' Affairs (VA) Home Loan program is one of the most popular and widely used for servicemembers and Veterans. In most cases, the VA does not directly fund home loans. VA home loans are provided by private lenders, such as banks and mortgage companies and the VA guarantees a portion of the loan. This enables lenders to provide borrowers with more favorable loan terms.

There are major benefits to using a VA home loan to purchase a home. Generally, no down payment is required; however, some lenders may require down payments in certain circumstances. Additionally, VA home loans have limited closing costs and competitive Also, there is no interest rates. need to obtain Private Mortgage Furthermore, it is a Insurance. lifetime benefit that may be used multiple times.

To qualify for a VA home loan, there are eligibility requirements. The servicemember or Veterans' length of service or service commitment, duty status and characterization of service determine eligibility. Additionally, National Guard members with at least 90 days of active service including at least 30 consecutive days are eligible. #### STEPS FOR A VA HOME LOAN

The VA does recommend certain steps to take when purchasing a home through the VA Home Loan program. The steps are as follows:

1. Apply for a VA-backed home loan Certificate of Eligibility (Serves as proof to the lender that you qualify for the VA home loan benefit)

#### 2. Evaluate your financial status

- Credit Profile
- Income and Expenses
- Monthly budget
- Determine how much you want to spend on a mortgage
- 3. Choose a lender
- 4. Choose a real estate agent (Read all agreements before signing with an agent and understand any charges, fees, and commissions as well as your rights and obligations)
- 5. Shop for a home
  - Look for houses in price range
  - Consider what factors are most important to you and your family (i.e., quality of schools, transportation, commute to work)

Once you've found the house you want to purchase:

- 6. Work with your agent to draft and sign a purchase agreement
  - Ensure the sales contract includes the "VA escape clause" or "VA option clause." This provides an option to void the contract if the property doesn't appraise for the contract price
  - Consider contingency options if the property fails inspection
- 7. Have the property inspected and appraised
- 8. Review pre-closing documents and provide lender and other required information
- 9. Close on your new home

10. Move in

#### **PREDATORY PRACTICES**

The VA Home Loan program is a great benefit to servicemembers, Veterans, and their families; however, there have been concerns with financial institutions employing predatory practices to take advantage of



borrowers. Congress and federal regulators have attempted to address the issue; however, an August 2021 report from the Office of  $45^{\text{th}}$ Congressman Katie Porter, Congressional District, Orange County, California indicates the issue persists. The report addresses two types of abuse: loan churning and risky cash-out refinancing.

*Loan churning* is a scheme where lenders originate an overpriced loan and then quickly pressure the borrower to refinance, generating It often starts new closing costs. through unsolicited offers to refinance your mortgage that appear be official. Many promise to extremely interest low rates. thousands of dollars in cash back, skipped mortgage payments, no out -of-pocket costs, and no waiting period. For example, lenders may advertise a low-interest rate to gain response а consumer to an advertisement. The consumer may assume that the rates are for a 30year fixed-rate mortgage, however, its actually for a 15-year or an adjustable-rate mortgage. This may result in the consumer paying discount points to obtain the advertised rate. Additionally, some of the other advertised benefits are costs that are generally added to the loan and increase the overall principal balance.

*Cash-out refinancing* is refinancing an existing mortgage loan, where the new loan is for a larger amount than the existing loan. It allows the borrower to withdraw cash from the total equity in the home and



## CRADLE TO COLLEGE MENTORING PROGRAM

The work and dedication of our participating Orients (Connecticut, Illinois, Michigan, New Jersey, Ohio, and Washington/Oregon) is truly appreciated. We continue to monitor the COVID-19 guidelines established by our Sovereign Grand Commander and local authorities, regarding activities we can or cannot participate in. However, our participating Orients continue to provide innovative programs. Even more innovation will be noticed after all restrictions are lifted because all of our Mentors are ready, willing, and able to provide this valuable and worthwhile service to our youth. Our program's intent is repeated below for your information.

#### **Our Mission:**

Provide mentoring services to school districts in the • Orients/Valleys of our fraternity in a caring, competent, and professional manner.

#### **Our Philosophy:**

The mentoring program is not a tutoring program. Mentors don't need any special skills, education, or training (beyond in-service training provided by the various Orients), but they do need to understand how to be compassionate and patient and attempt to instill proper moral values in the young people by the time they leave the program. At the same time Mentors should demonstrate, by their demeanor and behavior how the Mentees can be assets to their respective communities. The program can be adjusted to best fit the needs of the Orient, Valley, and School District.

#### Goals/Purpose:

- We will augment and support the school programs under the direction of the school administration.
- Expose students to positive local role models (Mentors should indicate they are strong competent and caring adults).
- Mentors will provide information and advice concerning career choices (choices available may be college, trade or vocational training, or the military training among others).
- Mentors should provide positive reinforcement through awards and recognition.
- Describe the benefits of the program and what the Mentees will gain through their participation.

Mentoring Coordinators should be prepared to report annually to the Charmian at the end of the school year.

typically results in a higher monthly payment. It may seem to be an attractive option for young servicemembers or Veterans with outstanding debt. However, it may create more financial distress over the long term. Cash-out refinancing is not necessarily predatory; however, some lenders do use this type of loan to exploit consumers.

#### **PROTECTION FROM EXPLOITATION**

Fortunately, there are government agencies that identify, stop and prevent illegal and misleading advertising regarding VA loans and refinancing. The **Consumer Financial Protection Bureau** (CFPB) is one of those agencies. They employ VA loan specialists that can assist servicemembers and Veterans and answer questions they may have. Complaints regarding refinancing and other mortgage issues may also be submitted to *www.consumerfinance.gov/complaint/* or via phone at 1 (855) 411-2342.

Additionally, if a borrower is having difficulty repaying their mortgage, the CFPB may assist and explore viable options. Furthermore, to reduce unsolicited calls from phone lenders, homeowners may also place their phone number on a National Do Not Call Registry at www.donotcall.gov.

#### **CLOSING THOUGHTS**

Although there are laws intended to protect servicemembers and Veterans from predatory practices, its equally, if not more important to be proactive and research lenders, realtors, inspectors, homeowner associations, and other entities involved with the home buying or refinancing process. Take a good look at their history and client reviews. Ask questions and educate yourself, so you may get the best financial outcome for you and your family. Additionally, if it seems too good to be true, it likely is.

She continues to be a beacon of light for her Sisters and the Christian community, as she continues to display grace and beauty as one of God's flowers.




#### **Orient of Connecticut**

## Freemasonry and Black Greek

In order to meet the demands of the day and age, African Americans have historically banded together to create power and share resources. This is certainly the case for Afro-American Freemasonry. While the formal organization of African Lodge can be tied to the charter issued in 1784, organizations like the Free African Society had also been in place to meet the challenges of Slavery. Its objectives were not only to free the enslaved but also to provide those who made it northward with the resources and abilities to start and sustain a new life on the homefront. This became its fundamental function and duty.

Faith, hope and charity fueled these actions. It is no secret why Prince Hall Freemasonry pulled from these ranks to fill Masonic Lodges. Their faith in God and worship yielded direction which resulted in solutions for the issues of the day. The relief provided by them also gave others hope in a better tomorrow. The acts of charity were acts of love that were meant to build a stage for the future. It is upon this stage that the fraternities and sororities of today stand.

While multiple Black Greek Letter Organizations (BGLO) have found many African American been in existence since the turn of students attending some of the

the 20th Century, they all receive acclaim for their works at the professional and collegiate levels. These organizations serve the purpose of advancement within multiple circles. The products of their unions provide evidence to their relevance today.

Sigma Pi Phi Fraternity is considered one of the first African American Greek fraternal orders in America. With its members affectionately known as the Boule, the fraternity was organized at the turn of the 20<sup>th</sup> Century as a means for African American professionals share resources. Its ranks to included physicians, scientists and other professionals who sought to convene and design solutions that would extend the careers of black professionals and open doors for subsequent generations. Many black Freemasons were members of these ranks in its early stages including Dr. Allen A. Wesley of North Star Lodge #1, Chicago, Illinois and others. Their success in uniting like -minded individuals opened new doors and could have been the spark which prompted the formation of fraternities on college campuses across the country.

The turn of the 20<sup>th</sup> Century

nation's most prominent universities. In order to ensure success, several felt it necessary to band together for protection and to share resources that would allow ALL to succeed. This is the premise for the creation of all BGLOs.

Alpha Phi Alpha was founded in 1906 on the campus of Cornell University in Ithaca, New York. Influenced by the Boule, its founding fathers organized themselves into the first black fraternity to ensure mutual success. The fraternity grew at Cornell and expanded across the country. The Beta Chapter was organized as the first fraternity on a Historically College or University Black (HBCU) in 1907 at Howard University in Washington, DC. Its success provided a model upon which other fraternities and would sororities establish and extend themselves.

Alpha Kappa Alpha sorority followed suit in 1908 at Howard University. It was the first sorority to be organized on the campus of a HBCU. Its founders were true women of distinction who sought to bring together link-minded ladies. Their focus on scholarship and service became a factor which drew more into its fold. Their formation sparked the establishment

of other new sororities and fraternities on the same campus in subsequent years.

Like Alpha Phi Alpha, Kappa Alpha Psi was organized on a predominantly white Indiana campus, University, in 1911 originally as Kappa Alpha Nu. The fraternity found itself embroiled in racial unrest early on. One of its initiates, Frank Myron Summers, was a track star who endured



racial taunts as he excelled in Track and Field. Often called that "Kappa Alpha Nig", he continued to excel despite the epithets. The fraternity decided to change its name to Kappa Alpha Psi and has remained steadfast in its pursuit of excellence.

With the establishment of a sorority on the campus of Howard University and the existence of Chapters of Alpha Phi Alpha and Kappa Alpha Psi on the campus, other groups of men and women were inspired to organize fraternities and sororities of their own for similar purposes. Omega Psi Phi was organized in 1911 and, within ten years, three additional organizations would follow. Delta Sigma Theta was organized as a sorority in 1913 from ladies who previously held membership in Alpha Kappa Alpha sorority. Phi Beta Sigma was organized as a fraternity in 1914 and Zeta Phi Beta was organized as a sorority in 1920.

Sigma Gamma Rho became the first BGLO sorority to be organized on a predominantly white campus. Founded in 1922, Sigma Gamma Rho was formed on the campus of Butler University. Its initial membership consisted of talented women of distinction who worked together to ensure mutual success in the educational arena. Like the aforementioned organizations, it remains in tact to this day.

It is important to note that each fraternity and sorority leveraged one another for their genesis and forward The relationship movement. between each is apparent as their modes of organization and expansion are almost identical. Each organized itself and adopted the Chapter system for logistical purposes. Each utilized a similar hierarchy in leadership structure and mode of operation. Each made it a point to collaborate with one another to maintain regularity. These relationships, the common structure

and common bonds of mutual improvement became a basis upon which a formal organization was created in 1930 to maintain the bond. As such, they came together in 1930 to form the National Pan-Hellenic Council (NPHC) which remains in existence to this date.

The NPHC welcomed Iota Phi Theta fraternity into its ranks in the 1960s. Founded on the campus of Morgan State University, an HBCU, Iota Phi Theta was actually born from the Civil Rights Movement. Many of its initial founders bonded well with the ideals of the Black Panther Party including self-reliance and strength in unity. These concepts drew men of likemind together on the campus to found the fraternity in 1963.

Many stellar African American citizens throughout history have had a direct linkage to BGLOs and have also attested to the fact that the helped them organizations to complete their collegiate educational requirements and post collegiate requisites. The bonds of brotherhood and sisterhood run deep as attested by the likes of Dr. Martin Luther King Jr., Jesse Jackson Sr., W.E.B. DuBois, Carter G. Woodson, George Washington Carver, Rosa Parks and many

others. Their examples have inspired generations of young men and women into the ranks not only on campuses through BGLO but also in the community through Prince Hall Freemasonry. Together, they activated many citizens who helped to sustain the state of the African American community despite the struggles of race relations. Considering this, it is no surprise that several BGLO founders held direct ties to Prince Hall Freemasonry including:


- George Biddle Kelley, a founder of Alpha Phi Alpha Fraternity, was a member of Mt. Moriah Lodge #25 of Troy, New York.
- Ezra D. Alexander, a founder of Kappa Alpha Psi Fraternity, was a member of Central Lodge #1 of Indianapolis, Indiana.
- Ernest E. Just, Edgar A. Love and Frank Coleman, founders of Omega Psi Phi Fraternity, were members in Lodges under the Jurisdiction of the District of Columbia. Just was a member of Corinthian Lodge #18 while Love and Coleman held membership Pythagoras in Lodge #9.
- A. Langston Taylor, a founder of Phi Beta Sigma Fraternity was a member of Pythagoras Lodge #9 of Washington, DC.



The pursuit of knowledge is mostdefinitely a common factor. The collegiate-style curriculum of the Scottish Rite can easily be described as a University system within which BGLOs thrive. The character and determination required to complete a collegiate education must be of a high caliber to meet the rigorous demands of the educational system. Is this also not the case for the Scottish Rite whose Degrees, in actuality, are collegiate level courses on the specific areas of focus? The Rite, being diverse, is a conclave of like-minded individuals who have completed their coursework, at a minimum, through 32 Degrees of knowledge. With this in mind, the kindred spirit between the BGLO and the Scottish Rite, if stoked, can create a blaze that is wide enough to encompass all and create synergy that can be use for mutual improvement at a larger scale.

## **Elevation is Not a Trophy**

Elevation to higher ranks is considered a great honor to men with service at heart. For those who see it for what it actually is, they have a greater understanding of its purpose. Elevation is not a trophy. It is, in fact, the acceptance of a higher level of responsibilities.

I have served as Grand Treasurer, Grand Secretary and Grand Auditor in the Grand Lodge to which I and have belong come to understand that the salutations afforded are representative of graduated levels of responsibility. For example, a brother can only be styled Worshipful Brother if he has served as Worshipful Master of a Lodge. "Right" is added for those who have been elevated to perform specific responsibilities at the Grand Lodge level. "Most" replaces "Right" for those who have been elevated to the highest level of accountability for the organization.

For clarification, it is important to note that there is a difference between a responsibility (micro) and an accountability (macro) for an organization. Responsibility is one's ability to respond appropriately to a specific set of circumstances for a section of an account or plan. The ability of the manager to ensure fulfillment of the entire account is accountability. As а Right Worshipful Brother, countless hours of service were necessary to fulfill the various responsibilities associated with the elevation in rank. Much of this work went unseen but their lack of fulfillment would have negatively impacted the organization. As such, "Right" or "revered" is appropriate because of the importance of the labor required to conclude it. Selfaccountability at the micro level produced the expected results.

Worshipful Brothers at all levels to experience sleepless nights and endure uncomfortable situations in the name of service. The Most Worshipful Brother is the account manager who bears the entire burden though. Consider that when a Grand Lodge is not in session, the Grand Master is fully accountable for the corporation to all external entities. After all, taxes must be filed with the appropriate local, state and federal agencies for the corporation. The Chief Financial Officer (Grand Treasurer) 🚿 may respond with assistance but the Grand Master must ensure the account is squared away. In cases of lawsuits, the Grand Master and the Grand Secretary will find their names on the complaint. While the Grand Secretary responds from a communications perspective, the Grand Master is actually the chief defender who must manage the crisis. So the crown can clearly become heavy with the full weight of accountability on its bearer. Hence, the nature of the salutations.

The salutations of the Scottish Rite prior to 1966 aligned similarly. The French term "Puissant" was used to denote power and the teachings of the 32nd Degree speak to the execution of power responsibly. The concepts of liberty, equality and fraternity promote the degree of equity between the terms "leader" and "servant". This can be measured in the degrees of the responses.

In order for one to effectively respond and commit their abilities to a purpose, a clear vision must be laid. The vision defines the account at the macro level so that individuals can respond appropriately to microlevel missions. Movement from the responses helps to define success because it is the movement that affirms power which is force in action. So the director of the vision was not only "Puissant" but "Most Puissant". However, an amendment to the USC Constitution and General Laws in 1966 removed the "Puissant" salutations placing a focus on the salutation of "Sovereign".

One who has received the 33rd Degree becomes a Grand Inspector General, an honorary member of the USC. "Sovereign" is added for those who have been elevated from honorary to actual membership which commits them to respond to a higher level of duties in the Rite. Only Sovereign Grand Inspectors General may gain by election to higher office and only one member may become the Sovereign Grand Commander who holds full accountability for the Holy Empire.

Additionally, the salutation of "Illustrious" is also associated with actual and honorary members of the United Supreme Council (USC) along with Commanders-In-Chief of local Consistories. It means "admired for past deeds". "Most" is added for leaders who have been deputized to oversee Orients of the USC. As such, a Deputy or Overseer of an Orient is the "Most Illustrious Commander-In-Chief' of that Orient who reports to the Sovereign Grand Commander.

An enormous weight lies upon the crown of the Sovereign Grand Commander. The management of the Holy Empire is multi-faceted and international in scope with many moving parts. Success is measured by the responses to the missions that align with the vision that has been presented. Hence, the crown of the Sovereign Grand Commandery is a visionary's crown. It is distinguished from all others not as a trophy but as a signet of one who has accepted *full accountability* for the Holy Empire.





PROFILE IN COURAGE 50 plus YEARS OF SERVICE



#### *ICIC James A. Scott, 32, 1972*

It was a great day on 26 June, 2021 at the Most Worshipful Prince Hall Grand Lodge Session of Delaware when the Grand Master called SGIG, RW James A. Scott, 33 to the altar and presented him with a 50 year Pin for service to the Masonic fraternity. Most Worshipful Grand Master Isacce Morris stated that "normally after 50 years of anything, most people want to slow down or quit, but not RW Scott. He is still serving and as you know, he is our Deputy of the Orient. He has served for over 50 years and gave me all of the details of that service." SGIG Scott has served four Masonic Jurisdictions, Massachusetts, Washington State, Maryland and Delaware. After serving a tour in Viet-Nam, he joined the Washington State Jurisdiction and elected the youngest was as Commander in Chief on record in

AASR Masonry. He served 3 years as ICIC of Keystone Consistory. During that time Keystone was the only Consistory in the Far East, and became a power house. The United Supreme Council (USC) Sovereign Grand Commander, Frank M. Summers, 33 presented Prince Scott the USC Trophy which Keystone Consistory retired for elevating the most brothers of any Consistory over a 3 year period of time. After a 10 year wait to receive his 33rd degree because of not meeting the age requirement, SGIG Scott was invited to become a member of the USC 100 year Centennial Class of 1981 by Sovereign Grand Commander Russell S. Gideon.

After the Far East military assignment, SGIG Scott served on US Presidential duty in Washington DC. where he joined Corinthian Consistory No. 5 in Wilmington Delaware. He worked with both the Northern and Southern AASR Jurisdictions, Maryland, District of Columbia and Delaware. As faith had it, GIG Scott was assigned to the Country of Turkey. Upon notification, the current Deputy of the Orient of Delaware and Turkey, SGIG Herbert C. Norris appointed GIG Scott, 33 as the Overseer for the country of Turkey where he regenerated Karamursel Consistory in Ankara Turkey and maintained the Charter. After a 30 year Military career, a Civil Service career and private business development, SGIG Scott continues to serve.

## The Sovereign Grand Commanders Illustrious Dr. Sumner

"Did you ever realize that the worst thing that ever happened to you can be the best thing that ever happened to you, if you do not let it get the best of you? For it is a fool, indeed, that does not profit by experience."—Sumner A. Furniss

Sumner A. (Alexander) Furniss (1874–1953) was born in Jackson, Mississippi, where he lived the first six years of his life. He was named after Senator Charles Sumner of Massachusetts, a staunch advocate against Slavery. Illustrious Furniss spent his youth in Indianapolis, Indiana and graduated from Indianapolis High School. Afterward, he attended the University of Missouri, but left 1 year prior to graduation. He returned to Indianapolis and began studying medicine as an understudy of Dr. E.S. Elder, a White doctor.

To help pay for his education he worked as a stenographer and private secretary. At the same time young Furniss subsequently enrolled in and graduated second in a class of 54 from the Medical College of Indiana (which later became a part of Purdue University) in March 1894. He was the only Negro in the class. As a result of his extreme scholarship, he was the recipient of the Badger Prize due to his superior mastery of medical examination, concepts, theories, and practice. Subsequent to his graduation, the newly minted Dr. Furniss became the first Negro intern at Indianapolis City Hospital. He won the right to be appointed by placing first among 14 in a competitive examination.





He was an early member and state vice president of the National Medical Association (NMA). It was formed because the American Medical Association (AMA) would not admit Negros. However, he later became a member of the AMA as well. He was also a member of the Indiana Medical Society. He opened his own practice in 1896, which he shared with his older brother, Dr. Henry W. (Watson) Furniss. These experiences played a large part in him helping to establish Lincoln Hospital (left) in 1909—the first "colored" hospital in Indianapolis of which he later became president and surgeon-in-chief. Sadly, due to the climate at the time it closed in June 1915.

The Furniss brothers also shared duties with the Indianapolis Mutual Benefit Association which offered a form of medical insurance. The elder Dr. Furniss served as the president and the younger Dr. Furniss served as the medical examiner. Sumner also belonged to the Indianapolis Board of Health and the Indianapolis Board of Health and, for years, was a leader in the affairs of Blacks and was a prominent figure in the community. A few of his civic engagements included President of the Indianapolis chapter of the National Negro Business League; Charter member and first president of the Senate Avenue YMCA; President of the Herculean Club; President of the Central Republican League; President of the Marion County League of Republican Clubs (1896); and

Executive committee member of the National Citizen's Business League. He was appointed as a member of the Marion County Executive Committee in February 1900. Love, fate and political advancement did not evade Dr. Furniss or his brother. On October 26, 1904, Dr. Furniss married his lovely bride, Lillian L. Morris (right) of Louisville, Kentucky. He also served as a caretaker to his mother, Elizabeth J. Furniss (neé Williams), who passed away from a heart attack on November 4, 1909 after a long illness. At this time, Illustrious Henry W. Furniss was serving as Consul General in Haiti while the funeral their mother was held at the home of Dr. Furniss. Despite the loss, Dr. Furniss pushed forward with great intensity in the political arena.



Surprising for modern times, but common in his day, Sumner was a registered member of the Republican Party and a delegate-at-large for the Republican National Convention held in Chicago in 1912. He was an alternate for former Vice President Charles W. Fairbanks, a Scottish Rite Mason himself. He was elected to the Indianapolis City Council in 1917-1921 and was elected as a full delegate to the convention in 1918. His civic

efforts found him and his brother included in *Who's Who In Colored America* for a number of years. He was also an early member of the Flanner House Board of Directors and was bestowed lifetime membership for this charitable organization.

In June 1918, he took part in a magnificent gathering of quite a few of the top Black thought leaders of his day. At the behest of the War Department and the Committee on Public Information, Emmett Jay Scott, Special Assistant to the Secretary of



War, Newton D. Baker, a call was made to many prominent Negro newspaper owners/editors/reporters and leading businessmen to convene in Washington, DC to discuss how they intended to cover and support the involvement of Negroes in World War I. Resultant from these deliberations, one Black journalist was chosen to be the Negro war correspondent-Ralph Waldo Tyler. This gathering was reminiscent of modern-day Bilderberger meetings. The picture (top) illustrates the serious nature of the event by those who attended. It shows a pantheon of Prince Hall Freemasonry and progressive, prominent, famous, and infamous Black men of which Brother Furniss was a part including P.B.S. Pinchback, former Governor of Louisiana; Emmett Jay Scott, Assistant to the Secretary of War; Dr. R. R. Moten, Principal of Tuskegee Institute; W.E.B. DuBois, Editor, The Crisis; Dr. Ernest Lyon, Consul General, Republic of Liberia; George L. Knox, Editor, Indianapolis Freeman; John H. Murphy Sr., Editor, Afro American, Baltimore; John Mitchell Jr., Banker and Editor of the Richmond Planet; Robert S. Abbott, Editor, Chicago Defender; Dr. Henry M. Minton, General Hospital, Philadelphia, Pennsylvania; Harry C. Smith, Editor, The Gazette, Cleveland, Ohio; W.L. Houston, Past Grand Master, Grand United Order of Odd Fellows; Dr. Sumner A. Furniss, The Ledger/Indianapolis City Council; R.L. Vann, Editor, Pittsburg Courier; Captain Arthur S. Spingarn, Medical Reserve Corps, U.S Army; and F.R. Moore, Editor, New York Age.

Brother Furniss was a member of Central Lodge No. 1 and began very young in Freemasonry, most likely after college. Very unique among men who served as Most Puissant Sovereign Grand Commander is that the record does not seem to reflect that Illustrious Furniss ever served as a Worshipful Master of a Lodge. There is also no record of any Order of the Eastern Star or York Rite membership for him. However, he did participate abundantly in the Scottish Rite. What is certain is that Masonic hierarchy (in that day) required that to be a member of the Scottish Rite one must have belonged to either a Shrine Temple or a Knights Templar Commandery. In order to be a member of a Knights Templar Commandery one must have held membership in a Royal Arch Chapter. There is no evidence of either membership in his fraternal journey. That is not to say he did not belong, only that the records are not extant currently.

Brother Furniss was Advanced to the degree of Sublime Prince of the Royal Secret on Tuesday, March 30, 1897. It did not take long for him to be pressed into service. In late December 1898, he was elected as the Illustrious Commander-in-Chief of Constantine Consistory No. 14. This Consistory was originally organized by John G. Jones in May 1895 prior to his suspension from the Scottish Rite later that year in October. This implies an air of legitimacy to its creation. However, an unauthorized Council of Royal & Select Masters had also been organized at the same time by Jones which is an indication that his work in both houses was unfounded. His meddling also created a bogus Scottish Rite body under which Constantine held fealty.

Sublime Prince Furniss served as Commander-in-Chief through 1902. During his second year of service, Jones, made a special trip to the Valley of Indianapolis to confer the Thirty-third and Last Degree upon him on Thursday, October 28, 1899. Subsequent to his service as Commander-in-Chief, he served as the Most Wise and Perfect Master, King Solomon Rose Croix Chapter and as the Secretary of all the coordinate bodies as each met separately. His activity level reflected that of a man on the move. Illustrious Furniss was appointed Deputy of the Orient of Indiana during the Annual Session of the John G. Jones Supreme Council held in New Orleans, Louisiana, in October 1910, and thus became an Active member. During that same session he was appointed to a committee charged with securing funds to purchase land to build a nursing/retirement home for members of the Supreme Grand Court of Daughters of Sphinx. This involvement foretells future happenings in this area. In one of his lasts acts as Deputy for the Orient, he turned over the money collected for annual dues, and submitted the annual returns to his Most Puissant Sovereign Grand Commander and reported that Constantine Consistory No. 14 "...was in good condition." Then, in April 1911, he wrote to then-Most Puissant Sovereign Grand Commander Robert H. Hucless 33° with the information that he was the leader of at least 150 Fraters who desired to practice Scottish Rite Freemasonry legitimately. Diligence coupled with perseverance resulted in the group's formal petition for membership to The United Supreme

Council of the Ancient and Accepted Scottish Rite of Freemasonry Thirty Third Degree of the Northern Masonic Jurisdiction of the United States of America (USC NJ), being returned in the affirmative.

Help with re-organizing the men (administering the Oath of Fealty) came from then-Puissant Lieutenant Grand Commander Iames F. Rickards 33°. Due to these efforts, Constantine Consistory No. 14. Valley of Indianapolis, Orient of Indiana was rechartered as Constantine Consistory No. 25. Valley of Indianapolis, Orient of Indiana under the aegis of the USC NJ in May 1911.

Illustrious Furniss was immediately reappointed as the Deputy of the Orient. The next year he assisted in organizing Malta Consistory No. 34, Valley of Terre Haute, Orient of Indiana. It is safe to state that he was the catalyst for the establishment and spread of legitimate Prince Hall Scottish Rite Masonry in Indiana.

Sometime in the 1890s Brother Furniss was created a Noble of the Mystic Shrine in Persian Temple (which had also been organized by John G. Jones in December 1893). Noble Furniss served as Illustrious Potentate, but the year is unclear. He also served as the Illustrious Recorder for quite a few years.

Around the same time as he sought to transfer the men he led in the Scottish Rite to a legitimate organization, he did the same for those in his Temple. In 1911, Noble Furniss had been in contact with the then-Imperial Recorder, Noble John Murphy Sr. about transferring his Temple, Persian Temple, to the new organization. His prayer was answered in the affirmative.

In August 1911 he, and his brother became charter members of Persian Temple No. 46 when it transferred its allegiance from the John G. Jones

organization. He served as the Temple's first Illustrious Recorder. A short time later he severed as Secretary to the General Committee overseeing the preparations for hosting the Imperial Council session in the Oasis of Indianapolis in 1913. He was appointed to a number of other positions but most notably served as the Deputy of the Desert for Indiana. No doubt in part to his hard charging, trailblazing, and extremely involved nature, Illustrious Furniss was duly elected and installed as the Illustrious Grand Minister of State in May 1914 during the 33rd Annual Session (11th Triennium) held in the Valley of Philadelphia, Orient of Pennsylvania. The 35th Annual Session of the USC NJ, was held in the Valley of Indianapolis, Orient of Indiana in May 1916, at his suggestion. Subsequent to Puissant Lieutenant Grand Commander Richard E. Moore 33° stepping down from his position at the 39th Annual Session (13th Triennium) held in the Valley of Philadelphia in May 1920, Illustrious Furniss was elected to fill that station. In the wake of the passing of Most Puissant Sovereign Grand Commander James F. Rickards 33° in October 1921, and by virtue of the language in the and Constitution General Regulations, he became the Acting Most Puissant Sovereign Grand Commander. He enjoyed a rapid promotion with virtually no opportunity to let grass grow beneath his feet. Shortly thereafter. in February 1922, he was depicted on the second issue of The Bulletin.

Ever the involved man and Freemason, he somehow managed to find the time to squeeze in involvement with other fraternal groups. He and seven others formed

formed a graduate chapter of Alpha Phi Alpha Fraternity, Inc. (Iota Lambda) in Indianapolis in April 1922. Brother Furniss is on the left, inside of the Phi (top).

Prior to his formal installation as the conservator of Prince Hall Scottish Rite freemasonry in the Northern Jurisdiction Illustrious Furniss was honored at a dinner in March 1923 sponsored by his Constantine Consistory in recognition of his ascension a year-and a-half prior. In April 1923, he hosted his fraternity Chapter's first anniversary dinner. The very next month he was duly elected and installed as the 10<sup>th</sup> Most Puissant Sovereign Grand Commander in May 1923 at the 42<sup>nd</sup> Annual Session (14<sup>th</sup> Triennium) held in the Valley of Philadelphia. He is the youngest to ever be elected to that position and

#### the first Sovereign Grand Commander to hail from the Orient of Indiana.

This marks the first time that the conference was held in a virtual video teleconference format. After a prayer was rendered by G.I.G. Kenneth Williams, 33°, Most Illustrious Commander-in-Chief Charles H. Bush, Jr. 33° opened COD, received the and acknowledged all Sovereign Grand Inspectors General (S.G.I.G.), and conducted roll call of officers. With a quorum being established, Most Illustrious Bush declared the COD officially opened. Afterwards, he recognized all Grand Inspectors General (G.I.G) and Sublime Princes (S.P.), and fraters serving in esteemed positions representing Ancient Craft Masonry, the York Rite, and the Ancient Egyptian Arabic Order Nobles Mystic Shrine. In attendance were a total of 53 voting members and over 100 fraters and guests.

Most Illustrious Bush continued with the business of the COD. He began by polling the membership for those that were sick, shut in, and/or in distress. #### STATE OF THE NATION:

Most Illustrious Bush stated that our nation as well as the world has seen the most devastating pandemic in modern times. He discussed how the pandemic has resulted in people losing their jobs and created barriers to people obtaining basic life necessities such as food and housing. Additionally, he addressed the civil unrest and division that is plaguing our country. Bazemore, 33°. He has the vision to advance and move us smartly into the future. Even during these challenging times, he has our United Supreme Council working on growing the organization and improving Scottish our Rite Experiences. Additionally, he addressed the USC's strategic planning efforts and encouraged the membership to register for the upcoming USC Annual Session.

#### STATE OF THE ORIENT:

Most Illustrious Bush addressed several topics concerning the state of the Orient. First, he talked about membership losses due to suspensions and some administrative tasks we need to improve upon.
