

#### **GRAND MINISTER OF STATE**



## STATEMENT ON TYRE NICHOLS

PHILADELPHIA, PA. (JANUARY 28, 2023) — Today, Dr. Melvin J. Bazemore, the Sovereign Grand Commander of The United Supreme Council, Ancient and Accepted Scottish Rite of Freemasonry, Prince Hall Affiliation, Northern Jurisdiction, USA, Inc., issued the following on the death of Tyre Nichols.

Today, we are faced with yet another episode of an unnecessary death of a young Black man at the hands of those who have sworn to



protect and serve us. While this is undoubtedly an unfortunate tale, it is also one that we have heard far too often. And, the further irony in this tale is that this violent act was inflicted by a special unit of officers tasked with restoring peace in neighborhoods.

The United Supreme Council stands with the citizens of Memphis and every other city or town across this land where our young brothers and sisters have met an untimely demise. We are thankful for the action taken by the police department in releasing the body cam footage. And pray that through this transparency that the Nichols family can receive justice for Tyre. Also, that this swift action serve as a precedent for other police departments should this act ever occur again. Last, it is our hope and prayer that the transparency seen in this event serve as a catalyst for the needed training and necessary reform of law enforcement that our communities need and deserve.

We call on our members and citizens to peacefully share our displeasure with the events in Memphis. May this statement serve as an initial message to our political leaders, community activists and law enforcement leaders that we have a high expectation for police accountability and due process for all community engagements. Words fail to express the sorrow felt for the family and friends of Tyre Nichols. We pray that the Great God of the Universe provides the needed solace and comfort in the time to come.



## RECOGNITION:

#### Securing the Legacy of Legitimacy in the Scottish Rite

The concept of "recognition" defines the nature of relations between organizations in Freemasonry. Before organizations discuss recognition, there are specific standards that each must be able to meet. First, evidence must exist to confirm the legitimacy of origin. Second, a defined territorial jurisdiction with exclusive control must already exist. Third, adherence to the Ancient Landmarks of Freemasonry must be confirmed. Once satisfied, conversations relative to the mode of recognition can begin.

Recognition does not always equate to an opendoor policy between organizations. This along with other points are discussed and determined during agreement negotiations for modes of recognition. Once agreed upon by all parties, the mode provides the basis upon which the organizations operate in conjunction with one another.

Agreements, themselves, help to secure the true legacy of legitimacy between organizations. As there are multiple bogus Masonic organizations, it is difficult for the public or even the courts to determine if an organization is legitimate or bogus. This has historically been a challenge. However, a recognition agreement can be utilized as a tool for clarification. While its value is very high in Freemasonry, its worth to municipalities is a different story.

For example, the International Free and Accepted Masons (IF&AM) established by Willie V. Banks,

was contrived without a shred of evidence that confirmed he was ever a legitimate Mason. While his organization was labelled as bogus in the circle of legitimate Freemasonry, the State of Michigan still allowed it to incorporate and operate. Small branches still exist across the nation and they do perform acts that are beneficial to the community. Yet, the public knows no distinction because "Mason" is in its name.

To knowledgeable Masons, the monikers are distinguishing factors. In the State of Illinois, there are only two recognized Grand Lodges—the Most Worshipful Prince Hall Grand Lodge of Illinois (F&AM) and the Most Worshipful Grand Lodge of Illinois (AF&AM). The agreement reached in 1998 was documented and publicized. The world now knows that the legitimate bodies in the state bear the monikers of F&AM and AF&AM. As IF&AM is not recognized, no Masonic intercourse is to be had. Multiple attempts have been successfully rebuffed.

The United Grand Lodge of England maintains a list of the Grand Lodges that it recognizes. The list is the basis upon which Masonic correspondence is shared. Those included on the list were invited to the 300th anniversary of organized Freemasonry in England in 2017 and both Illinois Grand lodges were attendees. To their dismay, none of the other so-called Grand Lodges in the state were invited. Therein, lies the security in recognition. Only those who were recognized were invited and received.



The historic agreement signed by the four legitimate Supreme Councils in the United States of America in 2022 serves as that basis upon which the legitimacy of Scottish Rite organizations in the nation are now judged. It has been publicized and it outlines modes of recognition as well as the manner through which other Supreme Councils will be recognized. It is an iron clad agreement between the *Power Four*:

- 1. United Supreme Council, AASR, PHA, Northern Jurisdiction (USC-NJ);
- 2. Supreme Council AASR, Northern Masonic Jurisdiction (NMJ);
- 3. United Supreme Council AASR, PHA, Southern Jurisdiction under the leadership of Illustrious Dr. Corey D. Hawkins, Esq. (USC-SJ);
- 4. Supreme Council AASR, Southern Jurisdiction (SJ).

The brand of the Ancient and Accepted Scottish Rite requires protection because incidents in the past caused great angst. John G. Jones, a pivotal figure in Masonic history, lost an election for the Office of Sovereign Grand Commander of the USC-SJ in 1895. Rather than deal with the loss in a manner that constituted some sense of Masonic morality, he took a more destructive path. He and Dorsey F. Seville of the District of Columbia along with a band of others created a new Scottish Rite Body within which Jones declared himself Sovereign Grand Commander. They garnered supporters and moved forward.

Sovereign Grand Commander Thornton Jackson expelled Jones from the USC-SJ for his actions but Jones was allowed to incorporate his Supreme Council in the City of Chicago. Through the

masterful hands of Seville, they went on a public relations blitz through multiple forms of media. The public was unaware of distinctions but the blitz caused great disruption in the Scottish Rite. Many legitimate Masons were prompted to choose between bodies. The USC-SJ ultimately prevailed.

The playbook of Jones and Seville has been replicated by many bogus organizations. Some argue that Jones was in good standing when he started his organization. However, as it was not authorized by a legitimate source, the action was spurious and was done in a clandestine manner. The charter for his organization was actually a business charter from a municipality and not a charter by a legitimate Scottish Rite authority. As such, no lineage to legitimacy equates to a bogus state.

Intrinsically, the Scottish Rite preaches against vanity, pride and egotism. Puffing oneself up to gain trophies is a character flaw that can create enmity because it is contrary to the concept of brotherly love. Ultra-egotism, like that displayed by Jones, is an over indulgence of ego, pride and vanity. This is in juxtaposition to compassion, selflessness and mutual support. Love combats ultra-egotism because it results in the provision of relief in times of need and the dispersal of truth in cloudy spaces. Truth separates the gray areas into black and white spaces. It is the key defense against spurious activity. Truth must be spoken to brethren who have gone off course for clarity's sake and for an opportunity at reconciliation. If reconciliation is not possible, then severance becomes the clear course.

The statement "once a Mason, always a Mason" is inaccurate. Once severed, he is a Mason no more and nothing he purports can be aligned to a "legitimate" Masonic effort. So, enforcement is key. The only recourse against this behavior is publicizing the truth within the boundaries defined by the regulations of the legitimate body to outflank the spurious acts.

The recognition agreement between the Power Four represents the truth. The ceremony surrounding the "Statement of Unity" was a public dispersal of the truth. There is no gray area in the Scottish Rite. The black and white tiles have been defined and documented by the agreement. Brotherly love will be leveraged to enforce it. Relief will be provided where ever it is required. With this in mind, there is security for the Ancient and Accepted Scottish Rite in the United States of America. By God's grace, mercy and wisdom, it shall remain secure for all posterity.

#### Loyal Lady Michelle Williams


# Past State Grand Loyal Lady Ruler Michelle Williams became a member of the Alaskanite Assembly No. 76 in October 2007. She travelled through the seats becoming the Loyal Lady Ruler, furthering her assent to become the State Grand Loyal Lady Ruler in 2016. As the Loyal Lady Ruler of Alaskanite Assembly #76 she carried on the work of the Past Loyal Lady Rulers, ensuring that the Assembly continued to be active in the Anchorage Community. The Alaska Grand Assembly's Annual Gold and White Ball was one of the signature events, she put into place as a vehicle to engage the Orient of Alaska and Alaskan Communities.

PSGLLR Williams has always been an advocate for others, as a Past President of the Midnight Sun Area Local 995/996 of the American Postal Workers Union and its first African American female to hold that position. She advocated for women in the criminal justice system who wanted to change their lives as a case manager for Mary Magdalene Home Alaska. She sat on the Board for the Multiple Sclerosis Center advocating for those who live with the diagnosis to access services, planning events and fundraising. She is Past President of North To The Future, Business and Professional Women's Club where she advocated for equal pay and rights for women. She is a member of the NAACP and sat on the Board of Shiloh Community Housing Inc (SCHI) since 2002. As trustee, treasurer, and current board vice president, SCHI's mission is to "interrupt homelessness." It was in partnership with the above-named organizations she has been able to highlight the contributions of the Alaskanite Assembly #76 and the State Grand Assembly in Alaska through advocacy, donations, time, and talents of Loyal Ladies and the assistance of the Scottish Rite.

Her career after USPS includes advocacy for vulnerable children and adults. Her earlier advocacy within the criminal justice system provided the foundation for her to obtain the position of Director the Residential Substance Abuse Treatment Program at Hiland Mountain Correctional Center, the only women's institution in Alaska. Due to that experience, she now is the Coordinator of the Alaska Department of Corrections Community Intensive Outpatient located at the Salvation Army Clitheroe Center providing substance use treatment to individuals on supervision in the Anchorage Community.

PSGLLR Williams is the current SGLLS, holding that seat since she passed the gavel in October 2017. She is the current sitting Grand Worthy Matron of the Prince Hall Grand Chapter Alaska and It's Jurisdiction. She is a Deaconess at Shiloh Missionary Baptist Church. She is married to GIG Yolandous D. Williams 33°, has three adult children, five grandchildren and three great-grandchildren.

#### Loyal Lady Gail Freeman



Her passion for the Order of the Golden circle started over forty-six years ago, as she states, "when I became involved with the wives of Saginaw Valley Consistory. Joining the Golden Circle was not discussed, however as we continued to travel with our husbands, discussions began to evolve with Illustrious Homer E. Gaines. He explained the ladies would have to work as a club for two years to prove sincerity before chartering an Assembly. Shortly thereafter, sixteen women began operating as a club." After serving in the community conducting charity work, twenty-five women were initiated and Light of Hope Assembly #64 was chartered.

The ideal of service remains a driving force behind all efforts in which she engages. In addition to her coordination duties for the Working Committee, she has also taken on a role in "The Dover & The Quill" project. The purpose of this project is to capture the thoughts of all Loyal Ladies, without regard to rank, on the topic "what the Order of the Golden Circle means to me". She is not only one of the coordinators for the project but she is also a volunteer who submitted one of the first entries for review. Sovereign Grand Inspector General Reginald B. Stewart, 33°, Grand Historian

#### **Gustave M. Solomons Consistory #101**

Valley of Kaiserslautern (Germany) - Orient of Europe Organized May 11, 1982




Gustave M. (Martinez) Solomons Sr., a native of New York, was a graduate of MIT earning a degree in Electrical Engineering which became his occupation. He was a member of Omega Psi Phi Fraternity, Inc. serving as Basilieus of Gamma Chapter for a number of years. He spent the bulk of his working life at Bethlehem Steel Company rising to become the Chief Electrical Engineer and retiring after

30 years. Notable among his experiences was his involvement with launching the first U.S. Warship named for a Black man—the USS Harmon (Leonard Roy Harmon). Illustrious Solomons was among the sponsoring party as the ship was built by his employer.

In acknowledgement of 10 years of service as a Cambridge School Committee member, he was fortunate to receive his flowers while still living. Illustrious Solomons became the namesake the "Gustave M. Solomons Transportation Career Center." A member of Holy Sepulchre Consistory #17, Valley of Boston, he was a member of the Horace G. McKerrow Class of 1953.

Illustrious Solomons led efforts to acquire a Prince Hall

Scottish Rite presence in western Massachusetts resulting in the charter of Springfield Consistory #89, Valley of Springfield in May 1972. He also served as Deputy for the Orient of Massachusetts for



#### **North Shore Consistory #52**

Valley of Duluth—Orient of Minnesota (Defunct) Organized December 4, 1921

Named for its geographic location in Northern Minnesota on Lake Superior, this Consistory was chartered by MICIC William R. Morris, Deputy for the Orient. Not much is known about its operation only that it was short lived. As was the usual story in those days, the meddlesome John G. Jones had previously set up a Consistory in 1897 by the name of Morning Star (bogus). It is unlikely that those members became charter members of North Shore Consistory #52. Currently there is a functioning Consistory named North Shore Consistory #91 in the Valley of Waukegan, Orient of Illinois.



## THE PACT ACT

## & Its Impact on Veterans Benefits

August 10, 2022, President Joseph R. Biden, Jr. signed the Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act (PACT Act) into law. The PACT Act is regarded as the most significant expansion of benefits and services for

toxic-exposed Veterans in more than 30 years. The Act expands VA healthcare and benefits for Veterans exposed to the smoke and fumes from open burn pits and other toxic substances. The healthcare benefits extend to Veterans of the Vietnam era, Gulf War era, and Post 9/11 era. In addition to expanded healthcare benefits, some of the most significant changes are the addition of new presumptive disabilities for the Gulf War and post 9/11 era Veterans, Vietnam Veterans,



and other Veterans exposed to tactical herbicides.

Presumptive disabilities are conditions for which Veterans do not need to prove that military service caused the condition. They only need to demonstrate that they meet the service requirements for the presumptive condition. For example, if a Post 9/11 era Veteran deployed to and served in Afghanistan during service, and after separating from the service is later diagnosed with pancreatic cancer, the Veteran would qualify for VA healthcare and compensation benefits for the condition. Because pancreatic cancer is listed as a presumptive condition and the Veteran has a medical

diagnosis, the Veteran meets one of the requirements for a service-related disability. Next, the Veteran needs to provide evidence that he deployed to and served in Afghanistan. This information may be documented in the Veteran's military personnel records. Veterans and survivors may file claims to the VA and be financially compensated for these conditions.

#### **NEW PRESUMPTIVE CONDITIONS AND LOCATIONS**

The PACT Act added over 20 new presumptive conditions for Gulf War and post-9/11 era Veterans. They are as follows:

#### **Cancers**:

- Brain cancer
- Gastrointestinal cancer of any type
- Glioblastoma
- Head cancer of any type
- Kidney cancer
- Lymphatic cancer of any type
- Lymphoma of any type
- Melanoma
- Neck cancer of any type
- Pancreatic cancer
- Reproductive cancer of any type
- Respiratory (breathing-related) cancer of any type

#### Other illnesses:

- Asthma that was diagnosed after service
- Chronic bronchitis
- Chronic obstructive pulmonary disease (COPD)
- Chronic rhinitis
- Chronic sinusitis
- Constrictive bronchiolitis or obliterative bronchiolitis
- Emphysema
- Granulomatous disease
- Interstitial lung disease (ILD)
- Pleuritis
- Pulmonary fibrosis
- Sarcoidosis

Regarding Vietnam era Veterans, the PACT Act added two new Agent Orange presumptive conditions:

- High blood pressure (also called hypertension)
- Monoclonal gammopathy of undetermined significance (MGUS)

#### **LOCATIONS**

Additionally, five new locations outside of South Vietnam were added to the Agent Orange presumptive locations. The locations and military service time frames are as follows:

- Any U.S. or Royal Thai military base in Thailand from January 9, 1962, to June 30, 1976
- Laos from December 1, 1965, to September 30, 1969
- Cambodia at Mimot or Krek, Kampong Cham Province from April 16, 1969, to April 30, 1969
- Guam or American Samoa or in the territorial waters off Guam or American Samoa from January 9, 1962, to July 31, 1980
- Johnston Atoll or on a ship that was called at Johnston Atoll from January 1, 1972, to September 30, 1977

Veterans may file claims for all conditions outlined in the PACT Act immediately.

#### **KEY COMPONENTS**

There several key are components to the PACT Act. In expanding addition to extending VA healthcare eligibility for Veterans with toxic exposures, Vietnam era, Gulf War, and Postera Veterans. 9/11 the Act authorizes medical 31 new facilities across the country: requires research studies on the mortality rate of Gulf War and Post -9/11 era Veterans that served in Southwest Asia: directs the VA to

the improve decision-making process the addition presumptive medical conditions, to enroll every Veteran for an initial toxic exposure screening and a follow-up screening every five years, to provide toxic exposurerelated education and training to staff healthcare and processors, and to build a stronger and more skilled workforce to meet growing demands for benefits and services.

#### **VA SURVIVOR BENEFITS**

In addition to benefits for Veterans, family surviving may be members eligible to receive benefits, specifically Dependency Indemnity and Compensation Accrued and Benefits.

#### Dependency and Indemnity Compensation

A tax-free monthly payment for the eligible surviving spouse, a dependent child of parent(s) of the Veteran or service member IF the Veteran or service member died in the line of duty or due to a servicerelated injury or illness.

#### **Accrued Benefits**

"A one-time payment to a surviving spouse, dependent child (ren), or dependent parent(s) of a deceased Veteran based on the relationship when the record shows benefits (such as VA compensation

or pension) due to the Veteran prior to death."

The PACT Act is an absolute game changer for the Gulf War era, the Post-9/11 era, Vietnam-era Veterans, and their qualifying survivors. A Veteran who has been diagnosed with one or more of the newly added presumptive conditions and meets the eligibility requirements may apply or reapply for benefits if previously denied. Qualifying survivors such as surviving spouses may apply and qualify for benefits such as DIC and Accrued Benefits if the Veteran died due to one of the newly added presumptive conditions and met the eligibility requirements. Additionally, if they have been previously denied, they may reapply.

#### **Burials and Burial Allowance**

Burial benefits available include a gravesite in any of our National cemeteries with available space, opening and closing of the grave, perpetual care, a government headstone, marker, or medallion, a burial flag, and a Presidential Memorial Certificate, at no cost. Some survivors may also be eligible for a plot allowance, transportation allowance, and burial allowances based on the service connected disability status of the deceased Veteran.



#### **Education and Training**

Chapter 35 benefits and Fry Scholarship are the two main GI Bill programs offering educational assistance to survivors and dependents of Veterans who died in the line of duty or as a result of service-related disabilities.



#### **Final Monthly Payment**

If a Veteran who is receiving VA compensation or pension benefits passes away, their last month of benefits can be paid to their surviving spouse.



#### Home Loan Guaranty

Certificate of Eligibility is available for surviving spouses receiving DIC.



#### **Health Care**

Survivors and dependents of Veterans may qualify for health care benefits, such as CHAMPVA.

## SOVEREIGN GRAND COMMANDERS

## Illustrious Leland Dickerson French, 33°

Sovereign Grand Inspector General Reginald B. Stewart, 33°

Leland Dickerson French was a Scottish Rite stalwart and a mortician by profession. He married his lovely bride, Agnes D. Burns in November 1917. He served in the Army during World War One and was honorably discharged in 1918. After military service he attended College for Embalming in 1919 and graduated as a licensed mortician. He opened The Leland D. French Funeral Home in 1920 in Cleveland, Ohio which also doubled as his residence. Most Black funeral home owners and morticians of subsequent generations in Cleveland apprenticed under him or his fellow funeral home owner, competitor, Frater, and Pythian—SP J.W Wills 32°. After his passing in 1973, the city of Cleveland declared the French Funeral Home as a landmark.

Brother French took his first steps into Freemasonry in William T. Boyd Lodge #79. He served as its fifth Worshipful Master from June 1926 to June 1928. In the first year of his term as Worshipful Master he was advanced to the degree of Sublime Prince of the Royal Secret in Bezaleel Consistory #15. Duty called once again and he answered unselfishly by serving a second term in office from

Worshipful Brother French experienced a rapid ascension through Masonic ranks. He crowned Grand Inspector General in May 1930. At the very annual next session. in his of hometown Cleveland, he was reclassified Sovereign Grand Inspector General and crowned an Active member in May 1931—a feat rarely achieved in a such condensed timeframe. In May 1932, he was appointed the Illustrious Grand Standard

June 1930 to June 1931.

Bearer. Despite only making it as far as Master of Ceremonies of King Solomon Lodge of Perfection #15 and 1st Lieutenant Commander of Bezaleel Consistory, he was appointed Deputy for the Orient of Ohio from May 1935. In May 1944, he was appointed Grand Minister of State to fill the unexpired term of SGIG R.W.J. Jeffrey 33° and was advanced to Lieutenant Grand Commander in May 1949 due to the resignation of Most Puissant Sovereign Grand Commander Sumner A. Furniss 33°. He became Sovereign Grand Commander at the 84th session held Chicago in 1965 after Most Puissant Sovereign Grand Commander George W. Crawford 33° chose to retire.

Contrary to custom of the senior officer nominating the junior officer to succeed him, Sovereign Grand Commander Crawford nominated SGIG Patrick E. Chavis Jr. 33° of the Orient of Indiana instead of Illustrious French. Fellow Cleveland Mason and Active member SGIG Charles F. Casterman 33° delivered a rousing speech and impassioned plea on the floor that ultimately convinced the Active membership to elect Illustrious French to the Office of Most Puissant Sovereign Grand Commander 35 years to the day he was elevated. In September 1965 a lavish testimonial was held in Cleveland in his honor to celebrate his election. Among the 1,000-plus guests were masonic luminaries Sovereign Grand Commander John G. Lewis Sr. 33° and Illustrious Grand Minister of State Thurgood Marshall 33° both of the United Supreme Council, Southern Jurisdiction (USC SJ).

Illustrious French was busy during his short tenure. He suggested the idea of a United Supreme Council Benevolent Foundation. This idea, which came to pass, was originally named after him. Notably during his term he retired the use of "Most Puissant" from the title of "Most Puissant Sovereign Grand Commander." He also initiated plans to revitalize the Cathedral, but shelved them due to the high construction costs. He originated the idea for a Scottish Rite House for seniors, an idea that was brought to fruition in the term of Sovereign Grand Commander Russell S. Gideon 33°.

In 1967, he was invited to Liberia by Most Worshipful Grand Master and Grand Inspector General Frank E. Tolbert, to witness the celebration of 100 years of Prince Hall Freemasonry in the country. Illustrious French delivered the Centennial Address and was conferred the rank and title "Knight"

and Sovereign Grand Inspector General Daryl L. Andrews, 33°

Grand Band of the Liberian Humane Order of African Redemption." Liberian Vice President William R. Tolbert was advanced to the degree of Sublime Prince of the Royal Secret and elevated to the grade of Grand Inspector General. He was awarded the Gold Medal of Achievement by the United Supreme Council, Southern Jurisdiction in 1969 and, in 1970, accompanied his counterpart, Sovereign Grand Commander John G. Lewis Sr. 33°, in a joint delegation, to confer the degrees of the Scottish Rite and partake in the 75th birthday celebration of President (GIG) William V. S. Tubman. This was to be his second trip to the country, but he fell ill immediately beforehand and was unable to embark on the journey. In 1971, for the third time, again as part of a joint delegation of both USCs, he was present to celebrate the 150th anniversary of the founding of Liberia and the Inauguration of President-elect (GIG) William R. Tolbert. Both Sovereign Grand Commanders were invested with the country's second-highest rank the "Star of Africa." He appeared on Ebony's 100 Most Influential Black Americans list numerous times.


While experiencing tremendous success in the Scottish Rite, Illustrious French was also active in other houses. He was made an honorary Past Grand Master of the Most Worshipful Prince Hall Grand Lodge of Ohio in 1965 coinciding with his elevation to the Office of Sovereign Grand Commander. He was the co-chairman of the Non-Prince Hall Masonry Committee of the Most Worshipful Prince Hall Grand Lodge of Ohio in 1966 along with SGIG James B. Simmons Jr. 33°, a Past Grand Master. He was also a fervent supporter of the Most Worshipful Prince Hall Grand Lodge of Ohio's charity fund. He belonged to Cuyahoga Chapter #36, Royal Arch Masons and Adoniram Council #1, Royal and Select Masons. He was a Past Eminent Commander of Emmanuel Commandery #32, Knights Templar. He was also a Past Patron of Wisdom Chapter #51, OES. Noble French was exalted as an Honorary Past Imperial Potentate of the Ancient Egyptian Arabic Order Nobles of the Mystic Shrine. He officiated the elections at the Imperial Sessions of 1966 and 1967. Previously, he had been the general chairperson for the 34th Imperial Session in Cleveland in 1934.

Outside of his Freemasonry, Illustrious French was also involved in the Knights of Pythias. He was a major facilitator, serving as the secretary in hosting the 42nd annual Grand Conclave, assisted by fellow Pythian and mortician J.W. Wills. He served in many


positions on the local and grand level culminating in being elected as Grand Chancellor. He also was active in a litany of other civic, community, social, and professional organizations including the NAACP, YMCA, Phyllis Wheatley Association, Benedict Social Club (Cleveland), Cleveland Funeral Directors Association, and the Ohio Funeral Directors Association. He was also very active member at Shiloh Baptist Church, the mother of Black churches in Cleveland, Ohio, serving as the finance director and founder and first president of its credit union.

In the wake of his passing in March of 1973 at the age of 76, the Class of 1973 was named in his honor. Portraits of him hang in the library at the Cathedral and the Keeper of the Seals and Archives Office of Bezaleel #15. Upon his passing, the torch of leadership of the Scottish Rite transitioned to the hands of his Lieutenant Commander, Illustrious Frank M. Summers, Orient of Illinois.

An attorney, Sovereign Grand Commander Summers was born in Carmel, Illinois on August 13, 1893. The second of ten children,



Summers high level of activity in his collegiate fraternity transferred well into the ranks of Freemasonry. He



was the first editor of the fraternity's journal in 1914 retaining the role through 1921. He received a Bachelor of Science Degree in Economics and, subsequently, attended Harvard Law School and the Chicago Kent College of Law. While attending Harvard, he was elected Grand Strategis for the fraternity in 1918 and contributed greatly to its administrative and ritualistic practices. He became its 14th Grand Polemarch in 1951 while, simultaneously, rising through the ranks of Freemasonry.

Summers was raised in North Star Lodge #1 while attending Kent College of Law. He demitted to Joppa Lodge #79 in East St. Louis after moving to there to open a law firm with his law partner and Lodge brother, Louie F. Orr, in 1929. Their success won many legal battles which lead to summers selection as Assistant States Attorney of Madison County in 1935. A proven legal warrior, he held this office for the next sixteen years.

The public service and leadership displayed in civic and Masonic bodies made him a prime candidate for higher offices within the Most Worshipful Prince Hall Grand Lodge of Illinois and Appendant Bodies of the Illinois Jurisdiction. He served as Grand Lodge Attorney for multiple terms after his selection as Assistant States Attorney. He was elected Grand Junior Warden in 1941, Grand Senior Warden from 1942 to 1944, and Deputy Grand Master from 1944 to 1948. He served in these roles while serving as Deputy for the Orient of Illinois from 1942 to 1968 and the first Deputy for the Orient of Wisconsin in 1950. He had been crowned in the 1930s after serving as Commander-In-Chief of Tyree Consistory #64 in the Valley of East St. Louis and elevated to the Active Grade of the United Supreme Council in 1936. Also a Past Potentate of Aahmes Temple #132, AEAONMS, he was renown in the full diaspora of Illinois Prince Hall Freemasonry.

Illustrious Summers remains as the longest tenured Deputy for the Orient of Illinois. He served in this role from 1942 to 1968 even while serving as Lieutenant Grand Commander, an office to which he was elected since 1965. He continued to serve the Grand Lodge while serving in these capacities and was made the very first Honorary Past Grand Master of the Most Worshipful Prince Hall Grand Lodge of Illinois in 1974.

After the passing of Sovereign Grand Commander French in 1973, Illustrious Summers was elevated to the Office of Sovereign Grand Commander which was perfected with his election at the 1974 Session of the United Supreme Council. He kept the Scottish Rite ship stable after the death of Illustrious French completing the renovation of the Cathedral. He expanded the Scottish Rite and represented it well across the nation. Like his predecessor, he was also noted as Ebony Magazine Top 100 Influential Black Americans during his tenure of office due to his efforts and accomplishments for the Scottish Rite and humanity at large.

While Illustrious Summers' reputation as a brilliant attorney was recognized, many of the stances that he took in regards to the advancement in the civic arena are not touted to the degree of his Masonic accomplishments.

For example:

- His representation of Oscar Johnson in 1948 broke barriers. Johnson was initially denied participation in the Missouri USLTA Tournament because of his race. Summers fought and won the battles pro-bono on Johnson's behalf. Johnson advanced through the quarter and semi finals to become the first African American to win an integrated tennis championship.
- Arthur Ashe was sponsored by Summers sponsorship during the National Clay Court Championships in 1961. The sponsorship provided financial and legal support. Ashe advanced to the third round of play. The sponsorship continued through subsequent tournaments serving as stepping stones for his career. As a result of the contribution of Summers and others, Ashe became the first African American to not only be selected for the Davis Cup Team but also win Wimbledon.
- He also mentored Dr. Harry Thomas, a multi-sport athlete from East St. Louis, who attended San Diego State University. Mentorship helped to chart Thomas' graduation from the university with distinction in 1964. He turned down the opportunity to play professional football to engage in the field of Sociology. His passion stemmed from the support he received from his mentors. He became an educator rising to the ranks of author and Professor Emeritus at the University of California at Berkley. He remains one of the foremost Sports Sociologist in America.

These efforts only represent the tip of the iceburg of accomplishments and influence exhibited by Illustrious Summers. His civic and political services also extended to service as Commissioner for the Illinois Court of Claims, Chairman of the St. Clair Housing Authority and a Board Member of Supreme Life Insurance. He continued serving the Scottish Rite while performing tasks to uplift his community. Yet, he desired to retire from the leadership of the Scottish Rite in 1977. This request was complied with at the 96th Annual Session of the United Supreme Council in Philadelphia, Pennsylvania. It was at this session that he was granted a new title, Sovereign Grand Commander Emeritus.

Sovereign Grand Commander Summers was called to the undiscovered country in 1987. Throughout his professional career, he lent his legal advice to all the fraternal organizations in which he held membership. He put his money where his mouth was particularly for the cause of defending the rights and benefits of his community. In 2004, his home in East St. Louis was declared a historical landmark which is evidence that his labors extended well beyond the doors of Freemasonry. In doing so, it should serve as an ever present reminder for Scottish Rite Masons to focus our powers on societal improvement so that the mistakes of the past do not rear their ugly heads into this day and age.





I was truly humbled to be appointed Overseer of the Orient of New York to succeed him. My prayer is that we, in the Orient of New York, can together continue the 22 year legacy of faithful service that our Deputy Grady Edge rendered to us and build on that legacy, boldly stepping into a new era.

Immediate initiatives include the formulation of a Sovereign Grand Inspector General Council, A Past Commanders in Chiefs Council, and the launching of the "Leadership Academy" - a school designed to prepare our future and present leaders with a historical education, one that defines "True Leadership" as well as a deeper understanding of our Ritualistic and Constitutional Regulations and Protocols—adopting the USC Educational Department's outlined plan. A Medical Department has been created to educate and perform routine tests for Hypertension, Diabetes, Prostate

Cancer, Breast Cancer Awareness and Mental Health Awareness. Once again, I'd like to thank SGC Bazemore for appointing me to the position of Overseer, I will endeavor to do my utmost to serve the Orient of New York and the Rite with dignity, progress, and integrity. The current officers of the NYCOD and the Commanders of the Rite (COR) were re-elected to office and the registrants for the 97th Annual Session included 27 SGIGs, 93 GIGs and 48 SPs. Total attendance was 168. SGC Bazemore was impressed with the 48 SPs in attendance. 641 members are on the rolls, an increase of 29 from the prior period. The COR consists of 213 members.

The "Statement of Unity Signing Ceremony" that occurred on September 7, 2022, was well publicized throughout the Orient and the video of the signing event was viewed by many who witnessed the eloquence of SGC Dr. Melvin J. Bazemore. Grand Inspector Generals of the SGIG Samuel J.D. Shook, Jr. Class of 2022 were also welcomed into the Commanders of the Rite and we proudly reported that the Life Membership Program, Annual Raffle Drawing and Paver Programs have all been supported. Recruitment, Reclamation, and Retention remains a priority. The 98th Annual Session in October 2023 will be held in person at the Binghamton Holiday Inn, Binghamton, NY.

SGC Bazemore visited the Valley of New York and the Consistorial Chambers of King David Consistory #3 on September 17, 2022. The sole purpose of his visit was to honor and celebrate the team responsible for separating Errol Walton Barrow Consistory #109, Rising Sun House of Rose Croix #109, and St. John Lodge of Perfection #109 from the Orient of New York and establishing the Orient for the Caribbean in Bridgetown, Barbados. He also recognized several other Fraters of King David, Long Island Consistory #61 and Pentecost Consistory #98 for their extraordinary work in the Orient. SGIG Adam C. Jones co-led the delegation to Barbados. They were all presented the Sovereign Grand Commander's Service Medallion.

King David hosted a Virtual Ceremony of Remembrance and Renewal. 150 attended and 30 new members were added to the rolls. At least 20 of the Fraters attend study classes twice monthly where research assignments are given. Ritualistic and Education goals have been achieved. The Online Dues Payment Portal has resulted in a near perfect payment of Consistory dues. Monetary donations to the Grady Edge Reading and STEM Program. Work continues to re-establish non-profit status and endowment.

For over a decade, members of King David Consistory have coordinated food and clothing drives monthly at the Grand East located at 454 West 155th Street. A partnership developed with City Harvest in recent years has increased our capacity to provide sustenance to well over 700 families monthly. Despite challenges related to Covid, this initiative has not stopped and in fact instead it has grown.

Bison Consistory #29 added 2 new members to the rolls. The total membership of the Commanders of the Rite is 44. Bison continued its involvement with the Buffalo Youth and Young Adult Choral Society where GIG Donald Howard, Vice President Commanders of the Rite serves as Treasurer and his wife, Mrs. Louetta Howard, as Musician. To spread awareness, Fraters attended the Buffalo Urban League's Annual Affair where GIG Thomas Beauford is the current

President. They support various events within the city. Appreciation was shown to GIG Oswaldo Mestre who received numerous "Service Awards" for his outstanding aid and assistance to communities and to the initiatives of SGIG Dr. Adam B. Sumlin, who conducts numerous clinics on Prostate Cancer Awareness in and around the city.

Utica Consistory elevated 6 new Sublime Princes of the Royal Secret. GIG Cedric T. Bolton led the Grady Edge Reading and STEM Program initiative this year. He held meetings with several Elementary School Administrators in Syracuse, New York to discuss adopting the Grady Edge Reading Program and the opportunity to coordinate the program at schools. They donated 50 book bags, 100 books, and other supplies at the start of the school year.

In September, Long Island made an official visit to King David Consistory to receive the Sovereign Grand Commander. The Sovereign Grand Commander's Service Medallion was given to SGIG Alonzo Ivery, GIG George R. Jackson, and GIG Mark Alexander. All were amazed and honored. In October, Long Island held its annual Divine Service at the New Brown Memorial Baptist Church where the Fraters made up half of the attendees. In November, they hosted their annual Thanksgiving Turkey Giveaway of 200 Turkeys at the church. Participation in the study classes by all grades provided for robust discussions. Learning was made greater and the future looks bright!

Albany continued its community engagement in the area. The Grady Edge Reading Program is a statewide program that will continue to expand under the leadership of Deputy Simpson. The program aims to promote literacy in economically challenged communities by giving books to students who may not have access to reading materials at home. Deputy Simpson has committed to the initiatives of Albany Consistory #90 and the entire Orient to foster a presence in communities. As New York, faces economic unrest, unemployment, healthcare, affordable housing, job opportunities for college graduates, and disparities in education, SGIG El-Wise Noisette and Albany will focus on activities and events such as the Grady Edge Reading Program, STEM, breast cancer awareness, prostate screening, community health initiatives, local food bank, and economic job development, and education to stimulate the community and bring resourceful awareness. SGIG Noisette looks forward to collaborating with the Deputy to establish and maintain positive relationships community-based institutions, churches, and schools.

Pentecost Consistory participated in the Ceremony of Remembrance and Renewal hosted by Long Island Consistory. Members attended, en-masse, at the Macedonia Baptist Church in Mt. Vernon where GIG Rev. Darren Morton is the Minister in charge. The Charity Committee organized a trip to the Westhelp Family Shelter to deliver Back-to-School gift cards to 37 residents. Joint activities are planned with Pentecost Assembly #86 including a community wide Barbeque and several church visits. The Annual Breakfast is expected to draw large numbers and influential supporters from the community. Pentecost also attended a joint Consistorial Meeting on September 17, 2022, with the downstate Consistories (King David Consistory #3, Long Island Consistory #61, and Pentecost Consistory #98). SGC Bazemore honored several with the

Sovereign Grand Commander's Service Medallion including SGIG Clarence High, SGIG Henry Rowlett, CIC Delvin Hodges, and GIG Timothy B. McKnight (posthumously). 

#### **Orient of Minnesota**

Greetings from the Valley of Minneapolis, Orient of Minnesota; currently know as the Land of 10,000 frozen lakes. Please join us as we highlight and give praise to two American Hero's and Men of Distinction from our Orient, GIG Wayne Glanton and GIG Fred Doughty.



Both GIG Wayne Glanton and GIG Fred Doughty grew up during the heart of a segregated United States of America. Wayne grew up in south Minneapolis, becoming intrigued with the construction trade at just the age of 12 where he would carry materials, and

tools to the workers. His

apprenticeship paid off so well, that after his time in U.S. Army, he used his G.I. Bill to finish his studies at Dunwoody College of Technology in Minneapolis, MN. Which was the start of his fortune. But before we speak on that, lets take a moment to explore his military journey.



One of the things GIG Glanton built while in the military was run ways for airplanes. While GIG Glanton was in Italy a P-51 Mustang came in for an emergency landing. "When that happened", he said, "we would rush out to the aircraft to try and get the pilot out before the plane burst into flames. We got this guy out and he took off his mask, and he was a black man." The pilot happened to be a Tuskegee Airman AKA The Red Tails.

Needless to say, Wayne had an interesting career in the military, which followed him to his civilian life. He learned so much that he was able to get a loan and start his very own lucrative construction company, and in doing so, did many projects around the Twin Cities, creating much needed job opportunities for members of his community. He also played a pivotal role with the construction of Interstate 394 that runs through Minneapolis. His construction company built the Prince Hall Masonic Temple that's located at 3832 4th Ave S. in 1957 and it is still being used today. He has been a member of Palestine Lodge #7 for 75 years. He retired sometime back, but tries to remain as active as he can with his charitable work in the order and the community. He has been honored for his contributions many times over the years with plaques and certificates. We honor him now. The G.A.O.T.U. willing, this World War II Hero will celebrate his 101st birthday this year.

While many of you may not know the name Fred Doughty, you, more than likely, have or will come in contact with his contributions to the Prince Hall Blue Lodge, York Rite, Scottish Rite or the Shrine. Unfortunately, GIG Doughty laid down his working tools, but while amongst us, he did whatever he could for not only his family but also his PHAmily. He was so well loved by the City of Minneapolis that his military carrier was placed on display at the government center for Black History Month. He too served in the military, proudly serving his country for 26 years in the U.S. Army, participating in two war campaigns and obtaining the rank of Sergeant Major, the highest pay grade that can be obtained by an enlisted man. While stationed in Panama, he was unable to attend the Masonic Ball, so he and others created the Nubian Ball, which was well attended. He had 5 star generals in attendance on his right of table. With all that our Illustrious Sir did, he was able to retire from the work force at the young age of 46.

GIG Doughty presented Masonic swords to the late SGIG Dr. Solomon Wallace, 33°, which is located in the cathedral, as well as to SGIG Melvin J. Bazemore. He was truly the type of man we all strive to be as we walk the path of our Masonic journey. He was a 60 year member of Palestine Lodge #7, the second oldest member of the Lodge and was elevated to the honorary degree of GIG in 1990. No matter his health situation, if a brother needed anything, he would make sure it was taken care of, no questions asked. The words we share about our dear brother do not do him justice. So we will share the words of his grandson, Charles Doughty, Sr. who said "yesterday was rough. We lost the prime example of everything you want to be as a man. He wasn't perfect but he was perfect to us. My family is losing our family tree and my grandfather is a part of the roots of that tree, and just like roots, he's embedded forever in all of us". And likewise so, in the Orient of Minnesota, GIG Fred Doughty was 86 years young.
