Editorial

This edition is dedicated to the leaders of Illinois Prince Hall Freemasonry.

After 150 years, only 45 brethren have been elevated to

serve as Grand Master. Of the 45, only one died while serving in office, three served as Worthy Grand Patron of the Order of the Eastern Star, one started the first black bank in the City of Chicago, one served for more than 20 years and one is a world renown musician. The bulk of the early leaders were abolitionists.

Masons of the Year are also considered leaders. Of the 59 recipients, 4 were elected Grand Master, 3 were elected Honorary Past Grand Masters, 7 served as a head of a Concordant Body, 14 have served in elected Grand Lodge offices and a host of others have served as Appointed Grand Officers.

Other Masons have done great things inside and outside of the Masonic Order. They are leaders in their own rights. Service and duty also ring loudly in their works. So, it is our intent to highlight these efforts in this edition for the current era and from the past.

The Mason of the Year Award

The Mason of the Year Award was established in 1957 by Grand Master Obed Vanderburg. His purpose was to promote the qualities that Freemasons hold near and dear by lifting up a brother who displayed them best during the course of the Masonic Year. The very first selection was appointed by Grand Master Vanderburg himself and was Henry G. Fort. He was selected for connecting the Order of the Junior Craftsmen with the National Urban League in conjunction with the special

committee appointed by President Lyndon B. Johnson. This program trained the Junior Craft to enter the workforce in the rebuilding of American infrastructure in the late 1960s and early 1970s. Fort also served as a founder of Chicago's first black bank—Independence Bank. Since



its inception, a total of 59 men have been selected to receive the highest award that the Most Worshipful Prince Hall Grand Lodge of Illinois can offer. The award for 2017 was awarded to Right Worshipful Brother Tony D. Stafford Sr. for his tireless efforts over the course of the 2016-2017 Masonic Year. Congratulations!!!



About Isaac H. Kelly



Isaac H. Kelly was born a slave on the plantation of Thomas Cooper in Macon, Georgia. He was trained to be an iron molder, but was freed by Cooper's eldest son in 1840 at

the age of 15 and was sent to Alton, Illinois in care of the Rev. Adiel Sherwood who was then President of Shurtleff College.

Once in Alton, Isaac opened the first of two barbershops in Alton that he operated for more than 64 years. Mr. Kelly was very active in the Alton community, serving as a Deacon at Union Baptist Church for 40 years, a sub-conductor on The North Star Line of the Underground Railroad and as the first Trustee and President of the Elijah P. Lovejoy Association. He also served the state as "Door Keeper" for the Illinois Legislature in Springfield, Illinois. Most Worshipful Brother Kelly is best known in masonic circles as one of the three founding fathers of Prince Hall Free and Accepted Masons in the state of Illinois. MW Bro. Kelly served as the first and the last Worshipful Master of G.T. Watson Lodge No.2 in Alton, the first elected Grand Treasurer of the Most Worshipful Prince Hall Grand Lodge State of Illinois and Jurisdiction, and the second Grand Master of Prince Hall Masons State of Illinois.

Freemasonry is one of the World's Oldest and largest non-religious, nonpolitical, fraternal and charitable organizations. It teaches selfknowledge through participation in a progression of ceremonies. Members are expected to be of high moral standing and are encouraged to speak openly about Freemasonry.

Freemasonry is a society of men concerned with moral and spiritual values. Its members are taught its principles (moral lessons and selfknowledge) by a series of ritual dramas which follow ancient forms and use stonemasons' customs and tools as allegorical guides. It instills in its members a moral and ethical approach to life and its values are based on integrity, kindness, honesty and fairness. Members are urged to regard the interests of the family as paramount, but importantly, Freemasonry also teaches concern for people, care for the less fortunate, and help for those in need.

Prince Hall Freemasonry is the Oldest, continually-active, African American fraternal organization within the State of Illinois. The Grand Lodge of Illinois was formed and met for the first time as the Most Worshipful Prince Hall Grand Lodge, Ancient Free and Accepted York Masons, State of Illinois on May 6th, 1867.

In 1922 the name was changed to its present title of Most Worshipful Prince Hall Grand Lodge, Free and Accepted Masons, State of Illinois, The fraternity is designed to make good men better through service to mankind. This service has been displayed in thousands of communities across the State of Illinois since the middle of the 19th Century.

We look forward to continuing our service in our communities today so they may have better tomorrows.

On May 7, 2017, Dwayne Smith led the ceremony to dedicate the headstone of Past Grand Master Kelly. He said that Melvin Frierson brought Kelly's history and legacy to light—"We certainly appreciate (his) tenacity and due diligence in putting this together," Smith said. "All I had to do was show up and he's taken care of everything."

Kimberly Clark, Mayor Brant Walker's chief of staff, also praised Frierson's work.

"When brother Frierson contacted me six or eight months ago to get information on brother Kelly, it opened our eyes to the history that the city of Alton actually has," she said. "We knew we had history here, but this is just amazing. To see so many come out to commemorate this day is just awesome."



Sunday's ceremony accompanied several moments of prayer, including an invocation by John Williams, bishop and brother, and hymns sung by Sister Patricia Story.

Past Master Christopher McKinley made the final proclamation of the dedication,

accompanied by a formal Freemason ceremony.








Carter-Black Hall

Legendary Chicago Athletes Who Were Prince Hall Masons PAST MASTER LLOYD WOMACK, GRAND HISTORIAN

We all know that Prince Hall Masons come from all walks of professions, doctors, lawyers, teachers, college professors, college graduates, pharmacist, ministers, carpenters, chefs, athletics, contractors, plumbers, mechanics, military, bus drivers, cab drivers, maintenance engineers, law enforcement, musicians, and much more. The qualifications which are needed in a applicant for membership into Prince Hall Freemasonry are he must be 18



years of age or older, be of good moral character, and a believer in the existence of the Supreme Being, which is God. To join a Lodge, a man, must be recommended by two members of that Lodge. He must understand that his character will be investigated. After approval by the members of that Lodge, he will be accepted as an applicant for membership.

This leads me to the question, have we ever given it a thought, do we have Prince Hall Masons who were physically fit athletes and extraordinary athletes? I am talking about an athlete who is good in sports. It could be in baseball, basketball, football, wrestling, field and track, golf, swimming, etc. The answer is yes. Yes, we have many Prince Hall Masons who were former athletes that excelled in their sports. Just ask some of them they will be happy to tell you about all of their athletic accomplishments. Yes, they were the best at their level of competition. However, the athlete that I want to talk about is the extraordinary athlete, the best of the best, the one that went past go and sprinted on to greater heights. Well, as the Grand Historian, in my research I found five such extraordinary Prince Hall athletes and I title this article, "Legendary Chicago Athletes Who Are Prince Hall Masons".



Harold Washington was born on April 15, 1922 and died on November 25, 1987. Harold Washington, was the "First Black Mayor of Chicago". Brother Washington, in 1980 was initiated a Prince Hall Mason and was an active member in Harmony Lodge No. 88, Chicago, Illinois. On April 12, 1983, Harold Washington was elected the 51st Mayor of Chicago. Mayor Washington was elected to a second term and served until his death.

He was a life long resident of Chicago and grew up in the Bronzeville Community. He attended Du Sable High School, and a member of its first graduating class. However, the athletic archive records show that Brother Washington was an outstanding high school athletic. In 1939 at a citywide track meet, he placed first in the 110 meter high hurdles event and second in the 220 meter low hurdles event. Yes, Brother Washington was a superb athletic before becoming a renowned politician. Several institutions in Chicago have been named or renamed in honor of Mayor Harold Washington. What an honor.



James Cleveland Owens his birth name famously known as "Jesse Owens" was born on September 12, 1913 and died on March 31, 1980, in Chicago, Illinois. Owens, in 1970, was initiated a Prince Hall Mason and was an active member in King David Lodge No. 100. In fact, Past Master Charles Stewart, a member of King David Lodge No. 100 for over sixty years performed the first Degree Ceremony. Brother Stewart is a 33rd ° Degree Mason, a Sovereign Grand Inspector General and a member of Western Consistory No. 28, Chicago, Illinois.

When he entered school in Cleveland, Ohio, a teacher misunderstood his nickname, "JC" and called him "Jesse", the name he would use the rest of his life. He was born into an Alabama sharecropping family. In 1922, when he was only 9 years old his parents sold their most valuable possession, a mule and moved to Cleveland during the Great Migration of southern blacks seeking a better life. While in high school he competed in track events where he set many track and field records. After graduating from high school he enrolled in Ohio State University where he set many track and field records there as well. He represented the United States of American, in the 1936 Berlin Olympic Games in Berlin, Germany. He won four gold medals. In spite of the contested grounds of racism, he dominated the event setting records in the 100 and 200 meter events, the 400 meter relay, and the long jump record of 25 feet 10 $\frac{1}{2}$ inches which set a record that stood for 25 years.

Following the 1936 Olympic Games, he retired from amateur sports and moved to Chicago. He established a business for himself. He was a self-inspired person. He was a person in high demand, he worked in public relation and marketing. He also did public speaking at conventions, athletic events and business gatherings around the country. In 1976, President Gerald Ford awarded Brother Jesse Owens, the Medal of Freedom. What an honor.



Ralph Metcalfe was born on May 29, 1919 and died on October 10, 1978. Brother Ralph Metcalfe in 1960 was initiated a Prince Hall Mason and was an active member in Mt. Hebron Lodge No. 29. He grew up in Chicago and in 1930 graduated from Tilden Tech High School. He was an outstanding track athlete who accepted a track scholarship from Marquette University located in Milwaukee, Wisconsin. He became the first man to win a NCAA 200 meter race title three times consecutively. In fact, he beat Jesse Owens in the 100 yard dash at the 1934 AAU National Track and Field Championship. Yes, he was just that fast. He did not beat Jesse Owens often but this one time he had some bragging rights.

Ralph Metcalfe was an American track and field star athletic and later a politician. He was a teammate of Jesse Owens. He represented the United States of American, in the 1936 Berlin Olympic Games in Berlin, Germany. He won four Olympic medals. He won a silver medal in the 100 meter event. Along with Jesse Owens, Foy Draper, and Frank Wykoff, they won gold medals in the 400 meter relay race. Even though he and Jesse Owens were fierce rivals and competitors on the track they became life long friends. In 1934 and 1935, Mr. Metcalfe was regarded as the fastest human.

Following the 1936 Olympic Games, he returned to Chicago and later went into politics. He served as Alderman representing the Southside of Chicago. In the 1970's, he served four terms in the United States Congress. In 1975, he was inducted into the National Track and Field Hall of Fame and named a member of The Presidents Commission on Olympic Sports. (NEXT PAGE)



LEGENDS CONTINUED: In 1970 the Federal Building in Chicago located at 77 W. Washington Blvd. became his namesake. **Ernest Banks** his birth name was born on January 31, 1931, in Dallas, Texas, He died on January 23, 2015 in Chicago, Illinois. Brother Ernie Banks was initiated a Prince Hall Mason and was an active member in Fidelity Lodge No. 103. In 1959, he was selected Mason of the Year for the Most Worshipful Prince Hall Grand Lodge of Illinois. This is the highest award awarded to a Master Mason. I, Brother Lloyd Womack, the 2007-08 Mason of the Year, will forever be grateful for the support that Brother Ernie Banks gave me as the Mason of the Year.

Ernie Banks nickname "Mr. Cub" was an American Professional Major League Baseball Player with the Chicago Cubs. In 1953, he signed with the Chicago Cubs and was its first African American player. During the period 1953 thru 1971, he played in the positions of short stop and first baseman for the Chicago Cubs. He wore the famous uniform jersey number 14. In 1977, he was inducted into the Baseball Hall of Fame. In 1999, he was named to the Major League Baseball All Century Team. Brother Banks was the Chicago Cubs main attraction. His baseball accomplishments are that in 1958 and 1959 he was voted the Most Valuable Player. In 1960, he was voted the Chicago Cubs first Golden Glove Winner. In 1970, he hit his first 500th Career Home Run in Chicago Wrigley Field Stadium. He finished his career with 512 home runs, most games played (2,528), at bat (9,421), extra bat hits (1,009) and total bases (4,706).

Brother Banks was active in the Chicago community as he founded charitable organizations during and after his career with the Chicago Cubs including the Live Above and Beyond Foundation and the Lets Play Two an events marketing company. In 1992, he retired from baseball with the Chicago Cubs and was the first player to have his uniform number (14) retired. In 2013, Brother Ernie Banks received from President Barack Obama, the Presidential Medal of Freedom for his contribution to Sports.





David Duerson his birth name was born on November 28, 1960 and died on February 17, 2011. Brother Duerson was initiated a Prince Hall Mason and a member of Hiram Lodge No. 14. Brother Duerson was a 33° Degree Mason and a member of Western Consistory No. 28, Chicago, Illinois. He was introduced to Prince Hall Masonry by his long time friend, Past Master Jim Mitchell a member of Hiram Lodge No. 14.

Brother Duerson was an American Professional Football Player and business entrepreneur who played eleven seasons with two National Football Leagues (NFL) teams, namely, the Chicago Bears (1983-1989) and the New York Giants (1989-1991). He played college football at the University of Notre Dame. He was a member of the Omega Psi Fraternity. In 1982, he graduated from the University of Notre Dame with honors and a BA Degree in Economics. During the period 2001 thru 2005, he served on the University's Board of Trustees.

During his career as a professional football player he was selected to four consecutive Pro Bowls (1986-1989). He won a Championship ring with the Chicago Bears (Super Bowl XX, 1986) and with the New York Giants (Super Bowl XXV, 1991). When playing with the Chicago Bears he wore the jersey number 22. During the 1986 season, he set an NFL record that stood for 19 years for the most tackles (sacks) in a season. In 1987, he was the recipient of the NFL Man of the Year Award.

In conclusion, I hope that you agree that the above discussed Chicago Prince Hall Masons are truly "Legendary Chicago Athletes" who have brought great pride to this fraternal order, to the City of Chicago, and to this Great Nation.

1917 EAST ST. LOUIS RIOTS COMMEMORATED

The 1917 Race Riots in East St. Louis has been labelled as a stain in the history of the United States of America.

Its impact on the city of East St. Louis, IL, the greater St. Louis, Missouri region, and the social, political, and cultural trajectory of this nation was monumental. The 1917 Race Riots in East St. Louis and the subsequent calls to action across the United States exposed many injustices suffered by African Americans and ultimately ignited a spirit of resilience and perseverance that has produced countless notable Americans who have been shaped by the City that Survives - East St. Louis, IL.

In October 2014, the East St. Louis 1917 Centennial Commission and Cultural Initiative (ECCCI), comprised of scholars, artists, educators, and religious, community, and business leaders, was formally established by the East St. Louis Mayor and City Council. As a not-for-profit organization, we have assembled to capture, record, and prepare relevant history for an engaging, educational, and appropriate 21st Century Commemoration in 2017. As a part of the commemoration ceremonies, Illinois and Missouri Prince Hall Masons joined the contingents as they marched across the Eads Bridge over the Mississippi River as hundreds did during the 1917 riots.

Opened in 1874, the Eads Bridge is a steel bridge which hosts both road and railway traffic and connects the cities of St. Louis, Missouri and East St. Louis, Illinois. The bridge served as a pathway of escape for those evading the riots. A brief timeline of events is shown below:

- **Precursor:** Fear of job and wage loss by white citizens of East St. Louis due to the influx of African Americans into the locale elevated tensions between blacks and whites in the area.
- Spring 1917: Aluminum Ore Company recruited blacks to fill the void created by a labor strike.
- May 1917: After a labor meeting on May 28, frustrated white workers marched into downtown East St. Louis and attacked black citizens. Despite the intervention of the National Guard, conflicts extended for weeks.
- July 1917: Tensions between black and white workers formed again as the influx of blacks to the area increased. On July 2, white males drove through a black area of the city firing shots at black citizens. In fear of another attack, black residents fired upon a car containing white citizens killing two shortly after the first attack. These actions drove a mob of thousands to set ablaze the black section of town and murder black citizens as they attempted to escape. Several made it across the Eads Bridge to safety.

On July 2, 2017, the ECCCI and the Masonic contingents marched across the bridge as a symbolic reenactment of these events and as an attempt to reconcile the events of the past.


FIRST ANNUAL:

For the first time in the history of the Most Worshipful Prince Hall Grand Lodge of Illinois and, most likely, for the first time in history in the United States of America, has an organization held a 5K Walk/Bike/Run on the same date and at the same time at four different sections of a state. On August 19, 2017 the Grand Lodge sponsored a 5K to raise funds for Prostate Cancer Research and Awareness. As this disease has a major impact on the African American Community, it was only fitting that the oldest, continually active, Black fraternal organization in America lead it. The brainchild of Right Worshipful Brother Roland G. Simon, the events were held simultaneously in the Cities of Chicago, Champaign, East St. Louis and Joliet. These cities comprise the most saturated locales of Prince Hall Masons. To date, nearly \$10,000 has been raised. Congratulations on a job well done.

What Is Prostate Cancer?

Cancer starts when cells in the body begin to grow out of control. Cells in nearly any part of the body can become cancer cells, and can spread to other areas of the body.

Prostate cancer begins when cells in the prostate gland start to grow uncontrollably. The prostate is a gland found only in males. It makes some of the fluid that is part of semen.



The prostate is below the bladder and in front of the rectum. The size of the prostate changes with age. In younger men, it is about the size of a walnut, but it can be much larger in older men.

Just behind the prostate are glands called seminal vesicles that make most of the fluid for semen. The urethra, which is the tube that carries urine and semen out of the body through the penis, goes through the center of the prostate.

NUTRITION: SEVEN SUPER HEALTH FOODS

In my research, I, found there are seven foods that can help keep your blood sugar in check and are smart choices for your overall health. The seven healthy foods choices are as follows:

- I. <u>RAW, COOKED, OR ROASTED VEGETABLES</u>: These add color, flavor, and texture to a meal. Choose low-carb veggies like mushrooms, onions, eggplants, tomatoes, Brussels sprouts, and zucchini and other low-carb squashes. Try them with a dip, such as low-fat salad dressing, hummus, guacamole, and salsa, or roast them with seasonings such as rosemary, cayenne pepper, or garlic.

- III. <u>FLAVORFUL, LOW-CALORIE DRINKS</u>: Plain water is always good, but water mixed with fruits and vegetables is more interesting. Cut up a lemon or cucumber and put it in your water, or make ice cubes with pieces of fruits or veggies in them. Or try cold or hot tea with lemon or a cinnamon stick. Not only are these beverages low-carb, they can also help fill you up so you don't crave other foods.
- IV. <u>MELON AND BERRIES</u>: Did you know that one cup of either melon or berries has just 15 grams of carbs? For a twist, mix the melon or berries with plain yogurt, or freeze chunks of fruit in ice cubes to flavor your water.
- V. <u>WHOLE GRAIN, HIGH-FIBER FOODS</u>: Fill up on whole grains to keep from overeating or choosing the wrong foods. Besides breads, try legumes like dried bean, peas, and lentils. Or, enjoy black bean-and-corn salsa with raw veggies.
- VI. <u>A LITTLE FAT</u>: Good fat choices include olive oil, avocado, and fatty fish. Try salmon served on a bed of lettuce. The fat from the fish can serve as a dressing for the salad.
- VII. <u>PROTEIN</u>: Choose Greek yogurt, cottage cheese, eggs, and lean meats. Peanut butter on a celery stick is a good fat-and-protein mix for a healthy, satisfying treat. You can also snack on a lower-fat cheese stick or a piece of beef jerky, but keep an eye on how much sodium each contains.

Rather than push a burden on the Craft, the Grand Lodge Trustees drove the 2017 Mega Raffle, are driving the 50/50 Raffle and are working with the respective Grand Lodge Committees to generate additional funds. "As the Christian has a revival, the Moslem has a pilgrimage to Mecca, so do Prince Hall Masons have revivals, and they are called Prince Hall Americanism Day, celebrated on or as close to September 12th each year. It is a time for the Prince Hall Mason to take stock of his life, renew his faith in God, Country and Fraternity, which will include his neighbor. It is a time to renew his faith in God, his patriotism to his country and his duty to mankind. It is in the truest sense a Masonic Revival."

By many, Prince Hall is considered the founder father of African American Freemasonry in the United States of America. In the late 18th Century, Hall and several others sought to join the Masonic ranks after their service in the American Revolutionary War. They were inducted into the Order in the 1770s but, due to the climate of the day and challenges to the legitimacy of their induction, they were not recognized by one and all. As such, they submitted a petition to the Grand Lodge of England to obtain a charter to formally organize African Lodge directly from the source. With their prayer granted in 1784 and the charter received in 1787, African Lodge #459 was a legitimate Lodge on the rolls of a recognized Grand Lodge.

By the end of the 18th Century, the African Lodge established two additional branches of itself in Pennsylvania and Rhode Island. After the death of Prince Hall in 1807, the branches organized themselves into the African Grand Lodge in 1808. It is from this source that Prince Hall Freemasonry extended itself across America.

Having made its way to the State of Illinois in the 1850s, Prince Hall Freemasonry is the oldest, continuallyactive, African American fraternal organization within the State of Illinois. The fraternity is designed to make good men better through service to mankind. This service has been displayed in thousands of communities across the State of Illinois since the middle of the 19th Century.

Most frequently asked questions


How does one qualify for assistance?



PRINCE HALL MASONIC JOURNAL



The efforts of Masonic abolitionists in the 19th Century set a stage upon which political and civic gains were made by African Americans in the State of Illinois. Community activism and involvement were the overwhelming messages that came from this era as the African American community solidified their own locales for themselves. This became prominent particularly during the period of Reconstruction. During this period, a number of factors came into play which aided in the growth and development of the black community in Illinois. Many of these efforts were driven by Prince Hall Masons.

The Grand Lodge of Illinois Prince Hall Masons was organized after the conclusion of the American Civil War during a period in which the black community engaged in efforts to organize for power through the Convention Movement. Consider that the first African American elected Official in the State of Illinois was John Jones, Past Grand Master of the Prince Hall Grand Lodge of Ohio and Honorary Past Grand Master of the Grand Lodge of Illinois. With Jones also being known as the Father of the Black Convention Movement, he gained election to the Office of Cook County Commissioner in 1871. This election was the first for several others that followed. Although some differences did exist, the focus remained on the stabilization of the black community which, subsequently, created a base upon which political gains were made.

Jones was elected in 1871 as a Republican which is the party that the majority of Northern blacks held affiliation during the 19th Century. Through the Republican Party, Jones and others were able to gain electoral victories and appointments for black candidates across the state:

- John J. Bird—Illinois' first black appointed state officer appointed in 1873 as Trustee to Illinois Industrial University (Masonic associate of Jones)
- John W.E. Thomas—Illinois' first black elected State Legislator in 1877 (nominated by Jones)
- Austin Perry—First black Alderman of Mattoon elected in 1883 (Masonic associate of Jones)
- George Ecton—Illinois' second black elected State Legislator in 1887 (contemporary of Thomas)

After the death of Jones in 1879, his nephews, Theodore W. Jones and John G. Jones took up the mantle of leadership. They along with Thomas and Ecton gained additional victories through the Fourth Ward Republican Club and Quinn Chapel sessions.

- Joseph W. Moore—Elected First black South Town clerk in 1890 (Masonic associate of Jones)
- Edward H. Morris—Illinois' third elected State Legislator in 1891

As Theodore Wellington Jones had gained election to the office of Cook County Commissioner in 1894, he leveraged his political authority in conjunction with Thomas and Ecton to generate unrest relative to the treatment of black citizens in Cook County. Combining efforts with John G. Jones and Morris, their created a powerful team—The Jones Team. Their collaboration proved to be fruitful in the late 1890s in Cook County.

For years black had been mistreated by Cook County officers and officials. In 1897, the Jones Team brought pressure through the elected officials and through civic protests directed by John G. Jones to wage war against the unfair treatment by the Cook County Sherriff, County Jailers and the superintendent of the Post Office. The pressure exhibited ushered the fight to a national level and also brought attention to the lack of recognition of black soldiers who had fought and died during the Spanish-American War. The pressure wage by the team resulted in political gains:

- Ferdinand Barnett—Appointed first black Assistant States Attorney in 1897 as a direct result of the pressure exhibited by the team
- John G. Jones—Elected State Legislator in 1901
- Oscar DePriest—Elected Cook Country Commissioner in 1904

The efforts of the aforementioned also translated into massive civic action that was designed to make the black community become self-sufficient.

- Civic League for the State of Illinois established in 1897 to perform root-cause analysis of issues and implement permanent solutions
- A Chicago Branch of the National Negro Business League was established by Theodore W. Jones to promote business development in 1901
- Committee on Negro Citizens of Chicago on the Prevention of Tuberculosis was established in 1908 to care for the disease among the community

These steps were introduced as independent methods to not only secure the community financially but also to address the physical well-being on the community. All in all, this provides evidence that the focus remained on the community.

Media coverage of these events were published in all publications that were owned and operated by African American publishers. Local news stories were popular but the ranges of the papers did not stay within the bounds of Cook County. They expanded to a large degree covering happenings from the northern-most to the southern-most points of the state.

The Chicago Conservator, for example, was a prominent black paper which eventually helped to spawn the creation of a national organization for black advancement. Among the topics covered in the publication were local stories but also stories which had national impacts.

The Race Riots in Springfield received a great deal of coverage. The lynching of William Donegan, the 1867 charter Senior Deacon of the Prince Hall Grand Lodge of Illinois, received extensive coverage by Ida B. Wells. The graphic nature in which she described the events and its publication in the Conservator stirred the souls of thousands across the nation. The violence which occurred in that locale drove local and national leaders to consider the events. As a direct result of the lynching and coverage provided by Wells and others, the National Association for the Advancement of Colored People was organized in 1909. The purpose of the organization—to address the social, economic and political rights of African Americans.

Efforts like the aforementioned introduced solutions to the black community that aided it in remaining stable despite the ebbs and flows of the tide of racial relations. They also helped to keep the cash flow of black dollars in the community. (Continued on next page)

This cyclical cash flow along with the programs implemented at the local and national levels created stability in the black community. As a result, additional political gains would be achieved.

The Great Migration brought new black families to Cook County and to the City of Chicago, in particular, in droves. Yet, the stability of the community allowed it to be flexible enough to accommodate the new families. The challenge, though, did exist from a political perspective particularly because many migrants from the South held allegiance to the Democratic Party. While some shifted allegiances, other kept their affiliations in tact. Yet, despite the growing challenge, blacks continued to gain electoral victories and power in the Republican ranks.

- Oscar DePriest—Elected Chicago's first black Alderman in 1915 and Illinois' First Black United States Representative in 1928
- Corneal Davis—Elected Chicago Alderman in1920s (DePriest ally)
- William L. Dawson—Elected Chicago Alderman in 1933 (DePriest ally)

After the mid-1930s, many black shifted to the Democratic Party. As a result of the shift DePriest lost his seat to a black Democratic, Arthur Mitchell, in 1935. Yet Mitchell continued to focus on race improvement and fight many of the battles relative to inequitable treatment that were waged by DePriest. Mitchell was succeeded by Dawson in 1943 who had shifted allegiance to the Democratic Party in 1939. Davis, who had also shifted affiliation to the Democratic Party, also gained election as a State Legislator in 1943. Together, Dawson and Davis became black power brokers not only in the State of Illinois but in the Midwest region of the United States of America.

Dawson and Davis leveraged each other to maintain local roots and to serve as conduits for national information that had local impacts. Ashby B. Carter, was a beneficiary of their relationship. Carter had risen through the ranks of the National Alliance for Postal Employees (NAPE) and became its President in 1945. Through the relationship with Dawson and Davis, Carter was a regular visitor at the White House with multiple Presidents of the United States of America. His efforts helped to desegregate multiple services for black employees. These efforts were published in the Chicago Defender Newspaper which was founded by Robert Abbott a score earlier but under the control of his nephew, John Sengstacke, in the 1940s. The Defender not only covered the efforts of Carter but also served as the primary conduit of information to the public on political gains. Jet Magazine, established in 1951 by John H. Johnson, followed suit. This cycle of efforts and communication proved invaluable to black advancement during the middle of the 20th Century.

Dawson, Davis, Carter and Sengstacke were all members of Mt. Hebron Lodge #29 of the Most Worshipful Prince Hall Grand Lodge of Illinois. John H. Johnson was a member of Harmony Lodge #88 and was a very active Scottish Rite Mason who received acknowledge locally and nationally. Their individual and collective efforts speak to the strength that resides in unity. The Holy Bible tells us that it is "more precious than the oil that ran down upon the beard of Aaron." The strength in that oil is that is was blessed by God. The strength of the quartet lasted for more than a score and by their wisdom, they reared the next generation of leaders who would extend the concept of community advancement to the next level.

- Ralphe Metcalfe successor to Dawson in 1970 organized the Congressional Black Caucus in 1971
- Bennet McVey Stewart succeeded Metcalfe in 1979
- Harold Washington, former Metcalfe Lieutenant and State Legislator from 1965 to 1980, succeeded Stewart in 1981 and, subsequently, gained election as the first black mayor of the City of Chicago in 1983

The elevation of Harold Washington to the mayoral seat of the City of Chicago was a milestone victory in multiple ways. Chicago had long been considered one of the most segregated cities within the United States of America. For the city to have elected an African American Mayor, was an enormous event which brought national and international attention to the city.

It is important to note that the sequence of events which lead up to Washington's monumental victory were laid by his predecessors. Their victories and sacrifices, their challenges and failures, their resolve and energy were the basis upon which Washington earned his victory. This base also served as the starting point for political victories that would come.
