THAT, WE, Lois Weesner, James E. Daugherty, Dallas Ewing, Pat Cle Calhoun, and Terry Lee Miller, all citizens of Texas, and being over the age of twenty-one (21) years, under and by virtue of the laws of the State of Texas, do hereby voluntarily associate ourselves for the purpose of forming a non profit corporation upon the following terms and conditions:

THIS IS A NON PROFIT CORPORATION

I.

The name of the corporation will be HAWG HEAVEN PROPERTY OWNERS ASSOCIATION, INC.

II.

The term for which it is to exist is perpetual.

III.

The purpose for which the corporation is organized are as follows:

- 1.) The Hawg Heaven Property Owners Association, Inc., shall be the representatives of the property owners in Hawg Heaven Estates in assisting in the preservation of property values and at the same time assuring to every purchaser of lands that the appearance, sanitation and permissive activities shall be controlled and safe guarded; and,
- 2.) Perform any other duties necessary or desirable in the opinion of the Hawg Heaven Property Owners Association, Inc., to keep the property neat and in good order, or which it considers to be of general benefit to the owners and occupants of the subdivision, it being understood that the judgement of said Hawg Heaven Property Owners Association, Inc., in the expenditure of such funds shall be final so long as such judgement is exercised in good faith.
