Notes to Financial Statements

For the year ended December 31, 2024

Note #1. At the December 2, 2024 Church Business Meeting, the Church approved allocating \$12,000.00 in the Parsonage Fund toward Church operating expenses.

Note #2. Support for Taylor Seminary (\$6,000.00) will be removed from the 2025 budget. Instead, these budgeted funds will go toward supporting students from Springside Baptist Church who are attending Bible College. Beginning in September 2025, students attending Bible College full time are eligible to receive a bursary, to a maximum of \$1,500/student/year, to be put towards tuition expenses.

Bursaries will be distributed annually, before the fall semester of each school year.
