Relocation fee is \$750.00 for sewer & \$300.00 for water

\*Apartment Complexes must provide their own grinder, sized to fit the projected sewer flow\*

\*\*Commercial customers are required to provide all equipment necessary to connect to the sewer system\*\*

All new customers are required to pay a deposit and permit fee. Established customers are required to pay deposit at time service is disconnected if one not on file

3rd Jammed Pump Fee - will be charged for equipment and labor time

If Service has been pulled for any reason- Customer will have to pay reinstall fee, deposit and permit fee

**Sewer Reinstall = \$2830.00 Water Reinstall = \$400.00**

( plus any new customers will have to pay a deposit and a permit fee)
