Horse Transportation Agreement & Bill of Lading

OWNER authorizes the transportation of the horse(s) detailed in the attached schedule(s) by Golden Pony, LLC (hereinafter Transporter) for the cost indicated below. OWNER understands that all due diligence will be taken to provide for the safety of the horse(s) and OWNER authorizes veterinarian care at OWNERS expense should it become necessary. The Transporter will make every effort to notify the OWNER before any such services shall be rendered. Transporters are not liable for the death of OWNERS horse(s), or any injuries sustained while in transit.

ALL HORSES BEING TRANSPORTED REQUIRE A NEGATIVE COGGINS in Accordance with the rules and regulations of the State. It is up to the OWNER to see to it that all paperwork is in order. A DEPOSIT of 50% is due at the time of booking and is non-refundable if OWNER cancels. OWNER must notify Transporter in advance if there are limitations regarding pick up or drop off date, OWNER is responsible for informing Transporter of any problems or special needs the horse(s) may have. Transporter reserves the right to charge a "training" fee if after 30 min. of attempts, OWNERs horse(s) is/are not on the trailer. The fee is \$25 per half hour. This same applies if OWNERs horse(s) is/are not ready at pick up time and Transporter or any of the other horse(s) on the trailer the horse will not be transported, and the deposit will be non-refundable. If OWNER wishes to send along tack or additional items, OWNER must discuss items with Transporter as there may be additional charges for these.

Payment is due in full at time of drop off. If for any reason payment is not made at the time of drop off Transporter reserves the right to, at its sole discretion, retain possession of the horse(s) until such time that the bill is satisfied and the OWNER will be responsible for the costs to Transporter for the care of them including, but not limited to, boarding (\$25/day/horse), veterinary and farrier. If payment is not made within 7 days from the destination site delivery date, the horse(s) will become the property of the Transporter and the horse(s) may then be sold. Monies from the sale of the horse(s) shall be used to pay the Transporters fees including its costs to care for the horse(s) including, but not limited to, boarding (\$25/day/horse), veterinary and farrier while they are held pending payment or sale. Any remaining money from the sale will be forwarded to the OWNER. If the sale of the horse(s) does not cover the total amount owed to the Transporter, the OWNER remains responsible for the balance.

For deposits we accept Venmo or Zelle. Payments made at the drop off location must be CASH, unless other arrangements have been made and agreed to in advance.
