Old Business:

- New 3D targets/Inserts – Need to order at least new inserts to replace bad ones. Brent will look into this.

- Board staff key sign-out sheet – Complete.
- “Thank you” to all who helped moved back into indoor range after fair, all the help made it go quick.
- Prorated membership – October \$40, November \$20. Need to pay following year membership. Will update membership forms to reflect.
- Open house set for December 7th from 4-8PM.

New Business:

- When new bales come in, will need to set up time to install. Will discuss at October meeting on what to do with old bales, possibly sell.
- Outdoor Range – Targets need some work, people are starting to shoot outer part of target and not center, so will just leave target until we take down targets this fall. Will replace/fix before spring. The city of Hutch has made it a policy that no crossbows are

allowed at outdoor range, they will help us make new signs with the policy. Will discuss at October meeting on when to take down outdoor range.

- 2024 Membership/League fees – Increased family max to \$120 to keep up with MSAA and increased league fees by \$5 for both adult and youth.
- League discussion – Discussed on if we want any changes to leagues. Animal league will only be 20 yds this year, will possibly host a Genesis entry level league(More info to come).
