- Reviewed 2025 Regional indoor shoot and asked if anything needs to be changed or improved on. Had 100 classes shot in the 2 weekends. No issues or things to change.
- All un renewed key fobs have been deactivated as of 1-5-25.
- Need to get new files for membership form and trifold. Cal will get Zach a jump drive, and will bring to standard printing to get more.
