Art in a Pickle Barn Application/Contract

The Art in a Pickle Barn is a central checkout art and gift show which includes paintings, photography, cards, jewelry and other quality gift items handmade by local artists. The show is a sanctioned event of the Skagit Valley Tulip Festival and the show is listed in the Tulip Festival guide/map.

The Skagit Arts Association (SAA) board reserves the right to adjust the open/close dates to coincide with the bloom time.

In submitting this contract application, I agree to abide by SAA by-laws and show rules as well as comply with the SAA and Fire Marshals' space regulations. I take full responsibility for any damages and agree that SAA and the hosting property owners are not responsible for any damage or theft of my merchandise.

Show Requirements:

- Current SAA membership
- All items for sale must be handmade/ handcrafted by the artist. Originals, plus prints and cards of the originals are permitted. Commercial and imported items are not allowed.
- Artist must supply their own tables and display furniture.
- If electricity is needed, please indicate this on the application form and you will need to provide your own power strip and extension cords.
- The artist must work at least three 4-hour shifts at the show.
- It is highly recommended that you attend the monthly meetings, especially the months prior to the show. It is required that you attend at least 3 meetings. Meetings are held monthly, with the exception of April, July, August and December.
- The artist must participate in at least one show committee. These committees will be discussed in the May/June meetings and will include, but are not limited to shift scheduling, set-up and take down, advertising, and signs.
- The artist must provide one or more items of your art to be available for sale with the proceeds going to the scholarship fund. Recommended value of \$25 or more.
- The artist must provide 3 photographs of your art to be considered for the show and the photos can be used on the website as well as for other promotional purposes.

SAA will deduct a 20% commission rate to be used for the costs associated with the show and for the scholarship fund.

The SAA Board reserves the right of final evaluation and decision of acceptability of artwork to be admitted at the show.

The completed and signed contract with your booth and membership fees will be accepted starting June 1st and received by December 31st. No refunds will be made after December 31st. Submission after this deadline will be accepted if space is available, however the fees for the booth space will increase.
