The benefit trust financial report was shared with the members with no questions. Current balance of \$194,565.08

AFL-CIO Report:

Workers Memorial Day was held April 28, 2023 in Highland Park.

Building report:

Interior paint work in the office has been completed.

The union office was recently powerwashed at a cost of \$486.

A proposal to replace all the original 1940's windows in the union office was discussed. With one estimate being received and approved by the members for \$18,955.94 we will now reach out to several companies to get other estimates and discuss all estimates with members prior to work being started.

A proposal to fix our water issues in the basement with standing water on the floor in certain locations and water infiltrating through the walls and deterioration of inner concrete walls. Everydry gave us an estimate to trench the inside floor and install a drainage system, trench the outside and install outer drainage system, install new sumppump well and a battery backup system, fix any structural issues with foundation and install Automated venting system to vent moist air to outside and install fibrated waterproof panels to the walls. The members approved an estimate of \$24,820. We will now reach out to several companies to get other estimates and discuss all estimates with members prior to work being started.

A discussion to install a centralized computer storage system and have a network company link all our computers and create a program for storing our membership files and all the grievance files electronically and have the ability for all our computers top have access to the data on the shared system. An estimate for the cost will be presented in the coming months along with the full proposal.

Political Education:

HR 82 the Social Security fairness act has been resubmitted before the 188th Congress. As of this submission it has 230 co-sponsors.

D.C. Lobby Trip April 19-21 Went well, we met with Congresswoman Tenney and met with Morelle's office. On Thursday we met with Senators Gillibrand and Schumer. All of which are very supportive of Postal Issues. Senator Gillibrand was especially interested in creating legislation to protect postal workers from crimes and both senators have opened investigations regarding carriers that were not allowed to leave the offices in Buffalo during the blizzard at Christmas time.

H.R. 856 / S.274 **paid** family leave bill has been introduced in the House and Senate. This would provide paid FMLA instead of having to use your own leave. This is only being proposed and has not passed yet.

Vehicle & Safety:

Heat illness training must be given by April 1st every year. If you have not received the training please notify your steward.

The incorrect PTF pay rates have now finally been corrected. To those that were paid the wrong regular and overtime rates as a PTF backpay adjustments will be made in July. PTF's were overpaid hourly by .11 per hour and underpaid overtime by \$1.38 per hour.
