**HEALTH BENEFITS**: Kenneth Montgomery

Kenny Montgomery gave a report explaining that open season was ending Monday 12/9/2024. **SINCE THEN, OPM HAS EXTENED OPEN SEASON UNTIL 12/13/2024.** Please do not wait until the last minute on Friday.

Going forward, OPM is the exclusive agency to deal with changes for PSHB, if you need to make changes with a qualifying life event (marriage, divorce, birth of a child) these all need to be made through the portal at login.gov.

Whether you stayed in the NALC plan or joined it this year, by the first part of January you will receive a new benefit card. You MUST use the new card with a new subscriber number. The old card will no longer be valid so please replace the card in your wallets. You will also receive a welcome packet in the mail sometime in January.

Beginning January unless you are already 65 or retired already it will be mandatory to join Medicare part b once you retire and turn 65. It is no longer an option. The premium for Medicare part B in 2025 is \$185 per month.
