Utilize your 75 annual physical therapy visits allowed by the NALC HBP or enroll in Hinge Health, a free benefit that encourages mobility and flexibility. Be consistent by getting your free annual physical exam. See a doctor regularly (even when you aren't sick) and talk openly about the little things bothering you. Big problems have small beginnings, so catch them before they snowball out of control.

September 10th is Suicide Awareness Day. We all have people in our personal lives and at work who are struggling. Some hide it well, but often troubles manifest in silent ways. We aren't robots. Check in with your brothers and sisters and listen. People won't care how much you know until they know how much you care. Your vigilance and effort could help save a life.

Maven, <u>www.mavenclinic.com</u>, is a new, free benefit offered by the NALC Health Benefit Plan. Maven provides free, 24/7 virtual support throughout your reproductive health journey.

You can video chat and message with fertility, pregnancy and postpartum specialists, mental health providers, OB-GYNs, nurse practitioners, midwives, doulas, prenatal nutritionists, physical therapists, developmental psychologists, pediatricians, lactation consultants, sleep coaches, parenting experts, and career coaches anytime. In addition, Maven provides support for adoption and surrogacy, as well as menopause and midlife health.

- New Employee Experience, Retention and Mentoring Program has started
