Regular exercise is one of the best ways to combat stress. Discounts are available for gym memberships with Active & Fit Direct at \$28/month or 20-70% discounts for premium services at places like Planet Fitness, LA Fitness, World Gym, and other smaller, local gyms like the JCC of Rochester or Palmyra Community Center.

Or, if you have space to workout but need classes to keep you focused, virtual training programs including yoga, pilates, kickboxing and strength training are available through Daily Burn for 30 days free and then \$14.95/month.

Political Education:

<u>DeJoy's sudden departure hints at new players, and one report points to Wells Fargo as a</u> potential take-over entity. The financial giant recently distributed a memo calling USPS an "obvious source of value" in a combined privatizing and spin-off.

President Renfroe in meeting states this attack is all influenced from private mailers UPS/Fed Ex- started back in February 2025

45% of our business is now parcels and growing

Dejoy apparently was pushed out of the position from White House- Reasoning he canceled contracts with Ups and amazon where mailers paid more

UPS also created a program that allowed them to see when they were delivering other packages to customers and that in turn took away the last mile and reduced sure post but because this was costing the customer more ... they were jumping to using USPS directly as oppose to private mailers which then in turn they complained to the Trump administration and expressed they wanted our parcel business ... which is where talk of privatizing started

On the hill... the talk is still out there for stripping the FERS bridge, high 5 instead of high 3... from the sounds of it we have a good relationship behind the scenes with Mike Johnson-speaker, Scalise -Leader, Tom Emmer—Whip (all republicans) - Sounds like we are in good shape for heading off privatizing at least for this fiscal year which is to end Sept 30, 2025

<u>HR 70 Anti-privatization resolution -</u>180 Cosponsors 169 Dems (Morelle is on) and 11 Republicans

Sens. Gary Peters (D-MI) and Dan Sullivan (R-AK) introduced a Senate resolution (S.Res. 147) that calls on Congress to take all appropriate measures to ensure that the Postal Service remains an independent establishment of the federal government and is not subject to privatization.

Four senators joined the bipartisan leads as original co-sponsors: Sens. Lisa Murkowski (R-AK), Susan Collins (R-ME), Thom Tillis (R-NC) and Maggie Hassan (D-NH).

The Senate version is identical to the House version (H.Res. 70)

HR 1522 Federal Retirement Fairness Act (Tenney, Tonko... No Morelle)
This bill has 70 cosponsors — 62 Democrats, 8 Republicans — plus its sponsor

Unfinished Business: President Monique Mate:

- The Contract- Arbitrator Nolan which was expedited was ratified on March 21, 2025
- Renfroe spoke of the word "mediate" was not to agree with the USPS but both NALC and USPS had there
 own time and alone discussions with arbitrator
- Wage provisions: 3 general wage increases, and 6 proportional COLAs were awarded.
- The first four COLAs total \$2,725 at top pay.
- The remaining two will depend on the CPI at that time. General wage increases will be 1.3% for November 2023, 1.4% for November 2024 (both paid retroactively), and 1.5% in November 2025.

- Pay table modifications: Steps AA and A will be eliminated from Table 2, raising starting career pay by 4.5%. The annual rate at Step P in Tables 1 and 2 will be increased by \$1,000. This increase is in addition to the general wage increases and COLAs mentioned above.
- <u>Back pay:</u> will cover all letter carriers for all paid hours from May 20, 2023. Back-pay calculations will include all retroactive raises and COLAs.
- <u>CCA pay:</u> CCAs will receive 3 additional 1% increases and an additional \$0.50/hour. 2.3% for November 2023, 2.4% for November 2024 (both paid retroactively), and 2.5% in November 2025.

All these modifications will be effective within 180 days of the date of the arbitration award signed (3/21/25).

- New rate do not have exact date looking at 3 pay periods should know this week (Tentative date (April 19th Paycheck MAY (, 2025)
- Article 8 new rules will not take effect until the USPS has the "new rate" 2 ½ times when someone works over 12 hours in their system.. looking at most likely July 1st... will not start in a middle of quarter.. they will open up to sign the lists 2 weeks prior
- Electronic version of Contract should be out this week (Came out on 4/3/2025)

Heat and safety battle- last year Biden proposed this was implemented through department of Labor so it would be standard- Trump on his first day put an executive order for any newer proposals be put on hold

➤ NALC met with secretary of Labor Lori Chavez -DeRemer – she was receptive to having this in place- Teamsters are also pushing for this bc of UPS.. TBD

We received labor charges last year early October 2024 we responded as a branch .. On 2/14/2025 the charges were dismissed by the board....
