



Illinois' 'Round' School Now Historic Site



The octagonal (round) school building shown here, one of three left in the nation, is now an Illinois Historic Site.

Known as the Charter Oak School, the tiny brick building stands near a blacktop road west of Schuline in Randolph County. The Heritage Conservation and Recreation Service of the Department of the Interior has included the school in the National Register of Historic Places.

Restored recently by the Randolph County Historical Society, the odd-shaped one roomer was used from 1873 to 1953. It was built in accordance with a design suggested by Daniel Ling, a pioneer teacher, who pointed out that the octagonal shape utilizes daylight and offers wind resistance.

LOWER ILLINOIS VALLEY BOOK OF WHITE HALL, 1978, by Eileen Smith Cunningham, R.R. 2, Carrollton, Illinois 62016. Soft-cover, spiral bound, 221 pages, 8½x11 inches, various indexes, illustrated, \$6.75.

White Hall, Greene County, Illinois, whose tile, sewer pipe and pottery finds its way all over the union, was founded by David Barrow, on the 12th day of January, 1832. White Hall soon became one of the most flourishing towns in Southern Illinois. This is a very good, comprehensive history of White Hall considering phases of history, before and after it was founded in 1832 on topics such as: churches; schools; fire department; the library; the press; the cemetery; societies; business interests including an interesting assortment of business advertisements. The White Hall directory of about 2,352 persons, lists the name and occupation of some citizens, while on others there is a full biography. The second portion of the book *Souvenir White Hall Illinois 1911*, includes an extremely fine collection of photographs of the early residents, homes, business facilities - inside and out, churches, farms, etc. Also, an interesting section called "Review of 1910" which lists by month, the births, marriages and anniversaries, deaths and the occupations of various citizens, listing county, municipal and lodge officers, or "Who is Who" in White Hall. A valuable book for those with White Hall connections.

FROM OUR HOUSE(S) TO YOURS --- Dear Geneal People:



From all appearances Spring has sprung, thanks be to God. We extend a grateful invitation for all leaves to appear out of the ground and onto the trees this year after a very hard winter - but not as bad as the year before - here. Are you mindful that a quarter of our year is gone? That brings my never-ending problems with your quarterly - not "what can I find to publish", - but, "do I have to leave that article out this time too?" The book just fills up too fast. We thought that Bob Dalton's readings of Antioch had so many people that genealogists were seeking that we would include it all at once. . We hope it is helpful to many researchers.

Did you ever have 96 thank-you letters descend on you at one time? That was my happy reading privilege last week after giving my lecture on "The Basics of Heraldry" to about 100 sixth-graders at the Rochester School March 1st. My granddaughter, Brenda Scarbrough, had to write a theme on someone she admired. She wrote a lovely one about my Betsy Ross research, and received an A with teacher noting: "your grandmother sounds super!" She sent me a copy. I told her that if her teacher wanted me to, I would tell the young people about it. I gave the talk to the 6th grade on Heraldry, and about 125 fifth-graders on Flag history. (After standing for 2 hours, I am glad I am not teaching on a day-to-day basis!) Here is part of Carrie Taylor's letter: "I really enjoyed your program about heraldry. Your pictures were terrific. And plus I liked those pictures you passed around."

Taunya Mahaffey added a picturesque note to her letter: "I went home and told my mom that my favorite color is vert and she didn't know what I was talking about. I appreciated your coming." Connie Jones said: "I liked it when you showed us the flags. I never thought there were so many in the world. Thanks again!" And on and on.

What a lovely class of future citizens are sitting in those Rochester classrooms! I presented the lecture on March 12th to members and guests of the Sangamon County Genealogical Society. They seemed to enjoy it very much. . . . I have come a long way in this unusual area of research since publishing my first quarterly in December 1973 on "The Basics of Heraldry for Ancestral Knowledge...Your Descendant Heritage." . . . But there is still a long way to go before I can get a publication done on Flag History --- mostly for lack of time, not historical knowledge Life can be so interesting in these fields of study. I wish that I had a way to get more genealogists using vexillology and heraldry backgrounds in historical research.



Our December Quarterly listed biographies for several books from this area. Numerous requests were sent. Did I miss sending someone theirs? If so, please write again. The Public Library, in remodeling their Board room, have scattered their historical books all over so that it was impossible to xerox all at one time. This did not make things easy for us. 




Maps will be given on this page, with text opposite. The full page map for 1821 is on the cover of our March 1979 Quarterly. The map of Illinois showing county boundaries for 1839 is on the cover of our December 1978 Quarterly. Study the county line differences carefully in order to discover where early deeds may be on file with the County Clerk. [From Counties of Illinois pamphlet issued by the Office of the Secretary of State, Mailing Room Basement Centennial Building.]



All of West Central Illinois was known as Madison County, 1812 to 1821, at which time new counties with large territories was formed. See Map 1, opposite.

The point of this article is to say "Morgan County, as we know it today, was never a part of Sangamon County EXCEPT for a small portion of land north of Indian Creek to Cavanaugh Bluff in Section 16, Township 16 North, Range 9 West of the 3rd Principal Meridian, which was the western border of Sangamon."

See Map 1, 1821. Note the dark line between Cass and Morgan. Indian Creek, then called Balance, or Negro, emptied into the Illinois River in Cass County. The head of its northern branch (now called Little Indian Creek) started in the northeast quarter of sec. 1-16-9, where Cass, Morgan and Sangamon conjoin. It swerved southwesterly of Literberry and Arcadia, then northwesterly above Concord to Arenzville and thus on to the Illinois River.

The Law of 30 January 1821 describes the division between Morgan and Sangamon thusly: "Thence through the middle of the prairie dividing the waters of the Sangamon and Mauvaise Terre . . .".

The confusion of names is probably amplified by early settlers referring to all of this area, at one time, as Sangamon Country in lieu of the earlier "Illini country" when it was inhabited by the Indians, commonly called "The Illini". The large area claimed by the State of Virginia as of July 4, 1778 by George Rogers Clark was legally called Illinois County.

Now that we have transgressed backwards into Time, let us now go forwards. Up until 1845, Morgan County possessed a 3-mile strip north of its present borders, being the lower half of Township 17 North, which in 1845 became a part of Cass. See Map of Illinois in 1839 on the cover of our December 1978 Quarterly.

The importance of this specific history of county line changes from 1821 to 1845 concerns those researchers desiring to locate early land records. From 1821 to January 28, 1823, all Cass County land and Morgan land above Indian Creek, would have deeds recorded in Sangamon County. Those for Scott and the larger portion of Morgan would be in Greene County until 1823. See Map 2.

From January 28, 1823 to March 3, 1837 deeds for Morgan, Cass and Scott would be in Morgan County, as well as the names on the 1830 Census. However, please note that marriage records and court proceedings are not available in Morgan, from 1823 until December 8, 1827 because the log courthouse containing all records (including Cass and Scott at that time) burned on December 7th, 1827. The first 180 marriage records were thus lost. (Death and birth certificates were not filed anywhere in Illinois until the State Law of 1878 became effective.) Deed records start with January 28, 1823 because the County Recorder had the deed book at home that fateful night catching up on his land entries.

Cass County (minus its present lower 3-mile strip) was formed March 3, 1837. So, deeds for Morgan and Scott and said 3-mile strip, would be in Morgan County, 1837-1839.

Scott County was formed February 16, 1839, so all land records, thereafter, would be in that county, as well as marriage records and court proceedings.

Deeds for the Morgan 3-mile strip, the lower half of Township 17, started in Cass County February 16, 1845. See Map on Cover of our Dec. 1978 Quarterly.

Researchers, therefore, need to note carefully the date on which any land was purchased, its legal description, and date of filing, in order to determine which County would have the early records. (continued to next page)

Note on Map 2 how Macoupin's rectangular county had the southeast quarter removed to Madison County from 1825 to its becoming a County January 17, 1829. The rest of it was a territory of Greene County prior to that date.

Calhoun County was a part of Pike from 1821 to its establishment as a County January 10, 1825.

Pike County took in all of Illinois north of the Illinois River (including Chicago) until Fulton was formed January 28, 1823.

Did you know that Christian, divided between Montgomery, Sangamon and Shelby counties was established as Dane County February 15, 1839? Its name was changed to Christian County February 1, 1840 by State Law.

Now you know at least that much historical data upon which to base your genealogical researches! Good luck.

IS WHAT I WRITE RIGHT?

Have you ever stated something the way you thought it ought to be, then passed it on to someone else to enjoy, only to have them suggest many changes in wording. How did you feel about it? Did it dampen your enthusiasm? Who is right in matters of this complexion? This kind of episode happens often to people who have to write "papers" for a class project, or letters to relatives or friends. Does this practice squelch individualism and colloquial expressions one intentionally uses as a joke, or for more colorful statements?

One of the most highly acclaimed pieces of literature in history is a speech given by a lowly man. Let us see how someone might doodle away his fame by proof-reading:

Be concise, say eighty-seven
Four score and seven years ago our fathers ^{*what about mothers? ancestors would be better*} brought forth ^{*"FOUNDED"*} on this continent a new nation, ^{*say "with the idea of freedom"*} conceived in liberty and dedicated to the proposition that ^{*how about women?*} all men are created equal. Now we are ^{*too narrow a viewpoint - expand*} engaged in a great civil war testing whether that nation or any nation so dedicated and so conceived can long ^{*"last" would be better*} endure. We are ^{*meeting*} met on a great battlefield of ^{*what war? Be specific*} that war. We have come to dedicate a ^{*say "part"*} portion of that field as a ^{*don't beat around the bush - say "cemetery"*} final resting-place for those who ^{*avoid 2 like words in succession*} here gave their lives, that that nation might live.

Moral: don't "doctor" your grandparents' statements in journals, diaries, and other written works. And don't keep adding that word [sic]. It detracts from the originality of the historical writings that are precious to our sight.

STORY OF ANTIOCH COMMUNITY

by. Mrs. Sara John English, 20 October 1927

[This manuscript was found in her papers in the Jacksonville Public Library. She has one volume there, and other papers in the Illinois State Historical Library.]

The history of Antioch cemetery is truly a part of the history of Morgan County. Even though it can not lay claim to being its oldest cemetery, still it has the honor of being the resting place of the earliest pioneers.

In the fall of 1819 Seymour Kellogg and family and his brother Elisha settled upon the north side of Mauvaisterre Creek just $\frac{3}{4}$ of a mile from the present cemetery. They built three cabins and were the first white settlers of this county, within the present boundary lines. In 1820 they erected two more cabins but soon after they went to what is now Jacksonville, Illinois.

Col. Samuel F. Mathews and Sarah Ann Adams of Kentucky were married Feb. 22, 1821, and early that spring came to Illinois and settled on the claim and occupied one of the Kellogg cabins. The next year their first child was born, the first in this community, though Julia A. Lindley is said to be the first born in Morgan County, 1820. Others claim James B. Crain and his wife were the parents of the first white child born in the county.

Samuel sent for his father, Richard Mathews, and his father-in-law, Mr. Adams, and their families to come to Illinois. The Taylors, Boyce, Clifton Davis and Mrs. Cass Hamm are descendants of the Adams family. They erected the first mill and ground their own corn. On this farm the first Cumberland Presbyterian services were held by the Rev. John Berry, and the church was organized in 1823.

The Mathews were prominent in the county and held many public offices, served in the State Legislature, and won distinction in the War of 1812, the Black Hawk, and the Civil Wars. Mrs. Richard Mathews, his son Col. Samuel, and Richard and his five wives all lived near here. Richard's fifth wife, a Miss Ross, was the mother of Mrs. Lee Alcott and Mrs. Abner Upham. She is buried in Diamond Grove, but the rest are buried in their private cemetery on the farm which is now owned by L.B. Trotter. John and Cyrus, their grandsons, have lots in Antioch Cemetery and are buried there. John and his wife, Louise (Welborn) Mathews, have . . . one great-grandchild, Marietta Fox, who was the 6th generation of these pioneers.

Alexander Robertson came to this settlement in 1821, occupied one of the Kellogg cabins and a part of the claim is now owned by Beatrice Robertson. His grandson, Wesley Robertson, and great-grandson, Frank Robertson, are buried in Antioch with the old pioneer, Alexander Robertson and his wife. [Many of these are now in Diamond Grove. See Bob Dalton's tombstone readings p.14]. Wesley Robertson's widow married Mr. Harris. This family was of Scotch ancestry, and Presbyterians.

While the Kelloggs were still on the north side of the creek, Isaac Edwards started a settlement on the south side in 1820. This settlement was on the north side of the Old State Road, afterwards known as Shuff's Farm, now owned by C.M. Coons. On this farm the first regular school in Morgan County was taught by a Mr. Palmer.

Michael Huffaker established his home near the school, called Mauvaisterre School. He was born in 1800 and at 21 years of age left Kentucky's hills for Illinois prairies. When he was only six miles from Springfield he was taken sick and returned to Kentucky. One year later he was married and he and his young bride, both on horseback and with another horse which he led carrying their possessions, came to Morgan County. They had \$200.25. They bought land for \$200, leaving them the paltry sum of 25 cents to begin life in this strange new land. Their cabin was east of the school. He later erected a handsome brick house which still stands near Arnold. George Graff, George Huffaker of New Berlin, Mrs. Will Master, Mrs.

Birther Huffaker Hubble of Jacksonville, and Mrs. Etta Mathews are descendants of this pioneer. They were members of the Christian Church and many of them are buried in Antioch Cemetery.

In 1820 they were joined by a pioneer whose name has advanced the history of Morgan County, Mr. Isaac Reeve. He came with his wife and 9 children, following the Indian trail from Alton to Jacksonville, driving a sow and her pigs and 2 cows. He was the first blacksmith in the county. He opened his shop with his anvil on a stump and his bellows fastened to a sapling. [There is evidence that he opened his first shop in the area now called Diamond Grove Cemetery. There appears to have been quite a settlement as the trail headed west, then referred to as Diamond Grove village.] His descendants are living here now to the 6th generation. Mrs. Homer Woods' children are of the 6th generation. Hon. J.J. Reeve, present mayor of Jacksonville is of the 4th. Hiram Reeve and his wife, Margaret McMillen, were among the early Cumberland Presbyterians; but most of the Reeves are Methodist. This family of pioneers is well represented in Antioch Cemetery, though they have their own cemetery on the farm, on the old State Road, 1/2 mile east of Salem Church.

One of the stones in Antioch bears the name of Shepherd Roland. Shepherd came to this county in 1821. He built the first band saw in 1823, which was run by ox power and located on the old Taylor farm now owned by Mrs. James Mahon. The Magills had already built a water wheel mill on the creek, afterwards called Grant's Mill. There was also a mill on Indian Creek which was called Grant's Mill. The first mill was just north of Antioch.

William Orear was born in Virginia. His grandfather was a native of France. He married Maria Sawyer in 1825. On their wedding trip they came to Morgan County, Illinois, on horseback, with all that they possessed in saddle bags. This couple had 3 children. Mrs. Orear died in 1820. Ten years later William Orear married Lena Eades. They were Methodists, he was a trustee of Illinois Female College and President of the First National Bank. He served two terms as sheriff and six years as State Senator, serving until his death. His widow married Judge Thomas. She had William Orear's body removed from Antioch to Diamond Grove Cemetery. Mr. Orear's daughter, Frances Delia, was twice married, first to Mr. Eades, second to John W. Crum. She was a Methodist and was graduated from Illinois Woman's College. She died in 1889 and was buried in the family lot by her first husband and her mother, in Antioch.

George Curts was born in Kentucky. At the age of 19 he went to Indiana with his father and was apprenticed to a blacksmith; when 21 he came to Illinois with William Jackson. He prospered and bought a large farm still called "the Curts farm" on which he built a fine brick house called the "Brick Mansion." His granddaughter, Mrs. Scott Green, now owns and lives in the house. Mr. Curts' first wife was Nancy Huffaker, daughter of Jacob Huffaker. They had eight children who, with their father and mother, are all buried in Antioch Cemetery. They were prominent members of Antioch Church, interested in the cemetery and the community. Old Morgan County is richer for having had them as citizens.

Hiram Smedley came here from Kentucky in 1833. He married Margaret Jane Weagley in 1840. Though he never sought public office he was elected several times by the people and did much to make Morgan County an honor to the state. He and his wife were known as the friends of the poor.

Next came the Green family to this county, the year it was established [1823]. Rev. Mr. John Green was one of the pioneer ministers and was the father of Steven Green and Mrs. Jacob Strawn. Mrs. Strawn, Matilda, died December 28, 1831 and

left three sons, William, James G. and Isaiah. She is buried beside her father, John Green, Sr., who died June 12, 1851, aged 75 years. Her mother, Susanna Green, died November 18, 1846 aged 66 years. They are buried in Scott Cemetery, in Morgan County. Stephen Green was the father of a large family.

In Antioch Cemetery we find the names of Marshall Green and his wives, his son Nathan, Horatio Green and his wife, Ellen O'Neal and daughter Amy. Ellen O'Neal came of pioneer stock which dates back to the Cottons and O'Neals of Revolutionary times. This couple was a power for good in the county. Scott Green, a great-grandson of Rev. John Green, is Secretary-Treasurer of the Antioch Cemetery Board. Six generations have lived in this county.

Thomas O'Neal, born September 22, 1793, was a soldier of 1812, his wife was Mary _____. They are buried in Scott Cemetery also. Thomas O'Neal's father was Bryant O'Neal, a soldier in the Virginia Militia during the Revolutionary War. For his services he received 160 acres of land in Kentucky where he went to live. He died and is buried there in Bardstown, Ky.

Rev. John T. Cassell was educated under the tuition of Rev. Barton Stone. He finished his medical course in Lexington and was graduated from the Transylvania University in 1826. He was highly educated for the times. He came to our county in 1830 where he prospered. He had eight children, among them, H.O. Cassell, lawyer; Dr. Cassell; Eliza, wife of Harrison Osborne; Robert and Kate, the one who became the wife of George Haggerty and was the mother of Kate and Mrs. Sue Haggerty Orear; and Ann E. wife of John Corrington, who came to Morgan County in 1834. She was a member of the Christian Church and her son is now serving on the Cemetery Board. Harrison "Tip" Cassell was the father of Annie Cassell Dickson, the mother of Harrison Dickson, the first Morgan County boy to give his life "Over There" during World War I. Miss Sue Cassell, who recently passed away, was the last member of Robert Cassell's family. She was educated at Berea College, and lived at Jacksonville, Illinois. She gave liberally to the support of Antioch, as her forbears, the pioneer Cassells had, in the past.

Harrison W. Osborne and Eliza Cassell, his wife, came to Morgan County from Lexington, Kentucky, in 1829 or 1830. He, with Barton W. Stone, established the Antioch Church. He was educated in Transylvania University, Lexington. He was loved and revered by thousands, and preached many years at Antioch Christian Church.

Eliza Osborne married Henry Babb and Robert Tilton married Elizabeth Deweese. He had the oldest dry goods house in Jacksonville, Illinois. The Phelps Dry Goods Company of today owe their success largely to Robert's honest and business ability. Mr. Phelps' wife, Almira Osborne and her sister, the "Beloved State Historical Society Librarian," Miss Georgia L. Osborne, are granddaughters of this Robert Tilton Osborne. They also come from Revolutionary stock.

The Layton family took a very active part in the community. Among their children were Mrs. Richard Mathews, Mrs. Weagley, wife of Dr. Weagley, Mrs. Irwin Dunlap, Mrs. Morton and William, whose wife was Malinda Boyce. On stones in Antioch are the names Will Layton and his sons, William, Irwin and daughter Nettie. Mrs. William Layton now lives in Springfield, Illinois, with her daughter.

In 1829 this community felt the need of a permanent church and this Christian Church was organized and a building soon erected. The church had a door on the side of the pulpit, as the entrance, then you walked back to your seat in full view of the congregation. No turning to see who came in late. The need was felt for a permanent and incorporated cemetery, though none was laid out for years, and it was not incorporated until July 14, 1873. The Directors named at the time were George Orear, Isaac Tindall, Hiram Smedley, Irvin Dunlap and George Haggerty.

After several years William Layton, as Secretary, began keeping a record, but no one knows whose body was the first to be placed in this city of the dead. Many bodies were moved from other places and farm graveyards. Rev. Barton Stone's body was in Antioch for a long time but the State Society of the Christian Church moved his body to Kentucky to rest beneath the shadows of Berea College. Fifty years ago the present church of Antioch was built upon land deeded for the church by the Tindalls and where the old church stood.

The Tindalls came from Pennsylvania. On Isaac Tindall's farm in 1889 the first natural gas in Morgan County was found. The old church of Antioch is still standing on the old Tindall farm and is now used as a shed. It is now owned by A.D. Arnold.

Samuel Tindall married a daughter of Dr. Edmund Moore, and had one son, Ed, of Arnold, Illinois. Isaac Tindall died a bachelor.

Then came the Cully family from Indiana. Wallace Cully had several sons. He and his wife and several of his sons are buried in Antioch Cemetery, John, Will and Marshall. Oliver Cully served in the Civil War. He married Alvira Green, daughter of Stephen Green. James Cully married Fannie Stevenson of Orleans, Illinois, daughter of Septimus Stevenson.

The Redding family was also one of the pioneer families. Jacob Redding lived just north of Antioch Church on the farm now owned by Will Baxter. His wife was Artimeria Wade. Their daughter married David Winter from south of Jacksonville, Illinois.

The Heddingtons have several grave-stones in Antioch Cemetery. They were related to the Osbornes. The pioneer and able teacher, Charles Leving's wife, was a Heddington. He was a man of vision and ability. John and his wife, Barbara Boston, of Maryland, settled in Kentucky. Anthony was born in 1807. In 1829 he was married to Louisa Stevenson, daughter of James Stevenson, who also came from Kentucky to Morgan County in 1829. Anthony Boston owned a large farm and his daughter, Mrs. Frances Bacon, owns the farm at this time. He had ten children. His mother's people were Presbyterians, but the Bostons were members of the Christian Church. Their names are on the Antioch Church records, as well as the gravestones.

John Shuff and his wife belonged to the early settlers. They were noted for their kindnesses and were prominent in Antioch Church. Their son, John Shuff, was the first soldier of the Civil War to be buried in Antioch Cemetery. Their son, James, was drowned while swimming in Mauvaisterre Creek on William Cleary's farm. Charles Levings was with him and came near drowning, but Dr. Weagley was in the crowd which had gathered and saved Charles Levings, who had been diving, trying to recover the body of James Shuff. A sailor named Ed Lynch recovered James' body. His father died a few minutes after he and Mr. Dunlap had finished counting school funds. His death was most unexpected and sudden, and his loss keenly felt by the community.

James Strawn was born in Ohio in 1828. His wife was a Miss Bradshaw. He was one of the pioneers of Morgan County. He lived and died on his farm east of Orleans. His father was Jacob Strawn, his ancestors were Quakers. His mother was the daughter of Rev. John Green. His father, Jacob, was called "The Cattle King." His motto was "When you wake up in the morning, don't roll over, roll out."

On the stones in Antioch Cemetery are the names of Jacob Strawn and his sons Clifton, Johnnie and Willie. Will's funeral was the first W.M.A. service in Antioch. Will's wife was Rosa Mason. She still resides in the village of Alexander where he lived and died. Charles M. Strawn, his son, lives in Jacksonville. After the death of his daughter, Pearl Strawn Kumle, his body was taken from Antioch to

to Diamond Grove Cemetery. Clifton Strawn, the grandson of Lloyd Strawn, is the 6th generation of this old family.

George Orear established a home 8 miles east of Jacksonville. His father was Benjamin Orear of Kentucky, and his mother was Elizabeth Irvin Orear. They were both born in Virginia. His father was a native of France who came to America prior to the Revolutionary War. They were the parents of 8 children. One son, Benjamin, died young. George married Sarah Ann Heslep in 1828. They had 7 children, Thomas, Franklin, Mrs. Sarah Morton, Nellie, Elizabeth, Mrs. Harriet Dunlap, and Mrs. Armentia Dunlap. Mrs. and Mrs. Orear were active in relief work during the Civil War. Mrs. Orear had a noted flower garden and on Decoration Day the flowers from it covered many graves in Antioch Cemetery. Stephen Dunlap was the 10th child and 6th son of Rev. James Dunlap. James Dunlap was the son of William, who was born in 1744, and died in Kentucky in 1816. He was a major in the Revolutionary War. Stephen Dunlap married Dicy Runkle in Ohio in 1834, and died near Jacksonville, Illinois, in 1877. They had 6 sons and 1 daughter, Mrs. Mary Jane Farrell, the wife of the late Felix G. Farrell. She and a small son are buried in Antioch Cemetery. Mr. Dunlap was a member of the first County Fair Association. The first Fair was held October 6 and 7, 1857, on the old poor house grounds, on East State Street, Jacksonville. On the first day of this Fair, October 6, such a heavy snow fell that it was impossible to show that day and the cattle suffered terribly from exposure as they had only a few sheds. Mr. and Mrs. Dunlap were members of the Primitive Baptist Church, northeast of Yatesville. He was an Elder of this church until his death. This church was organized in 1825 by the Rev. William Crow who served as pastor for 41 years. He was the grandfather of Ed Beggs of Ashland, Illinois. The next minister was the Rev. Mr. Isaac Van Meter. He served 24 years. Mrs. Dunlap was a remarkable woman, well informed and universally beloved, and active until her death. She was nearly 101 years of age. Stephen and Dicy Runkle Dunlap, his wife, still rest in Antioch Cemetery. Two of their sons are still living, Stephen and Samuel. The grandchildren of Stephen are the 6th generation of this family in Morgan County, as well as the 6th generation of Orears.

No one was more honored in this settlement than Samuel G. Weagley, M.D. His life was spent as he said, "in farming and handing out pills." He lived for many years just west of Antioch with his wife and five children. His wife was Amanda Layton. Their home was famed for its beauty and artistic furnishings and beautiful flower garden. He saved the lives of many but he lost his three sons. His two daughters were Mrs. Kate Grant and Mrs. May Hockenhull. When Dr. Weagley died Antioch was crowded. He had helped to bring into the world 3/4 of the audience. They sang "The Great Physician," and there were no dry eyes in the congregation. Dr. Weagley and his wife both died in 1900. They were faithful members of Antioch Church.

Edward S. Henrichsen settled here in 1840 and laid out a new town which he called Franklin, but it is now called Orleans. In 1857 he laid out another to the east and called it after John Alexander. His wife was Ann Wyatt, daughter of Col. Wyatt. They had 6 children. His son, William Henrichsen, held many public offices and was Congressman from the 20th District of Illinois.

This is but a poor and incomplete story of those who lived near, and now rest in old Antioch Cemetery. The little white church is guarding their graves. [But it has been long gone, as of this printing in 1979.]

[Sara John English follows this by quoting the Incorporation papers of July 14, 1873, from which we will abstract names of interest.]

. . . That the undersigned have associated themselves together for the establishment of a Cemetery in Township Fifteen (15), north of Range Nine (9), west of

the third principal meridian in Morgan County, Illinois. 4th That the object of said Association is to provide a place for the burial of the dead. 5th That the following named persons towit: George O'Rear, Isaac N. Tindall, Hiram Smedley, Irwin Dunlap, and George W. Haggerty were on the 7th day of July A.D. 1873 elected managers of the said Association for the first year of its Corporate existence.

In witness whereof the undersigned have hereunto set their hands and seals this seventh day of July A.D. 1873: Irvin Dunlap, S. Dunlap, I.N.Tindall, G. O'Rear, G.W.Haggerty, A. Smedley. . . .

The Directors for 1877 met April 23, 1877, and from the "Minutes" of this meeting we made the following extracts. [Article continued by S.J.English.]

"Antioch Association met Apr. 23, 1877 on motion George Haggerty was elected to fill the Chair, in place of Stephen Dunlap, deceased. George O'Rear was elected President at that time, W.T.Layton was elected Sec.-Treas. S.W.Haggerty, H. Smedley, I.N.Tindall, W.H.Ledferd and O.H.Cully; at this meeting, they received a check from John Robertson for \$30.00 in payment for 2 lots. The amount of moneys handed to me is as follows - Irvin Dunlap note for \$232.00, Dr. S.G.Weagley note for \$50.00, from I.N.Tindall \$4.90, check from George O'Rear for two lots \$30.00 and a donation from Mrs. J.D.Eads \$80.00, total \$130.00."

The Deed to the Antioch Cemetery Association was made "this twelfth day of June A.D. 1869 between Isaac N. Tindall and Jeannette Tindall of Morgan County, Illinois, . . ."

[A List of Lot Owners copied from list in Secretary-Treasurer Book is then given, but not included here, in this Quarterly. But, on page 21 of Sara's essay, we abstract the following information:]

All the land for this cemetery was given by the Tindall family, I.N. and his wife and Isaac F. Tindall. Not more than one half the graves have ever been marked and no record kept of those who were buried. Many bodies have been removed to Diamond Grove Cemetery. Among that number are the bodies of John Robertson (commonly known as Scotch John) and William Strawn.

There has never been any record of the bodies removed and reports differ widely as to who have been taken away. Old settlers report that many victims of the Cholera plague were buried there, and that these graves were never marked in any way.

A list of all the grave stones now in the cemetery (October 1927) were copied and verified by me, and I trust coming generations may find the record of their ancestors when the grave stones are worn and illegible, broken and gone, and thus prevent the dead past from burying the dead.

[Then she gives 18 pages of readings, ending with:] Sara John English, State Librarian, Illinois Daughters of the American Revolution, October 20, 1927, Morgan County, Jacksonville, Illinois.

* * * * *

Our J.A.G. & H. Society provided Robert Dalton with copies of Sara's readings, those made by Miss Elizabeth Hardy, and those from Myra N. Martin. He has carefully checked all of these out by making numerous trips to Antioch to verify the dates, etc. And so, we are indebted to Bob for a most complete reading of that rural cemetery that can be had. It covers the next 20 pages. We are so grateful for his dedication to cemetery recordings.

If any other person has knowledge of burials not listed herein, will they please send us the data with as much detail, and extra family history, as possible.

ANTIOCH CEMETERY

By Robert Dalton

April 23, 1978

This well-kept rural cemetery is located seven miles east of Jacksonville, on the north side of the Old State Road. Legal description of the cemetery site places it in the southeast quarter of Section 9 of Township 15 N Range 9 W. Antioch Christian Church was formerly located adjacent to the cemetery. That building was moved to Ashland more than 23 years ago and is still used for church purposes. Antioch Cemetery was not incorporated until July 14, 1873. Shortly thereafter bodies were removed from nearby family cemeteries and re-interred in Antioch Cemetery. It is believed that an unusually large number of Negroes are buried in this cemetery, being family members of workers hired by the Strawn family. For a time this cemetery was the second burial site of the famous preacher, Elder Barton W. Stone. His body has since been disinterred and removed to Cane Ridge, Kentucky. A list of Antioch Cemetery burials published in the Jacksonville Journal of Jan. 29, 1911 should be disregarded as it contains many errors.

The following item appeared in the Jacksonville Journal of Sept. 13, 1897: "William Foster, of Alexander, was in the city Monday for the first time since May, as he has been laid up by a bad case of rheumatism. 

However, the handwriting is so bad it is impossible to figure out the child's name. Apparently this child's death was not printed in the Jacksonville Daily Journal.)

Each member receives a card; however, each Family receives only one copy of our publications or newsletters. Each can file his or her own Surname Index Cards and Lineage Charts to place on file with our Society.

Junior members, whose parents are not members, receive all publications.. This is our effort to encourage young people to start family history research collections.

Memberships received late in the year will be sent all publications for that year, and their dues will be payable again as of January 1 following.

MEETINGS: Each interested person, member or not, is welcome to attend meetings.

REGULAR MEETINGS - 4th Thursday nights except July.

Meetings are usually held at the Illinois Power Auditorium, 1901 West Lafayette.

Doors open at 6:30 for registration and visiting. Meeting starts at 7:30 p.m.

Day meetings at the library have been discontinued due to lack of local interest.

LETTERS OF INQUIRY are reviewed at meetings. Names sought and name of person making inquiry is included in news articles pertaining to our Society's activities.

This has proved to be a popular feature, and is read widely since our notices are sent to 10 area newspapers.

YOUR OFFICERS AND BOARD MEMBERS APPRECIATE YOUR SUPPORT as indicated by your friendly letters, and membership applications. This is our only way to pay for the ever increasing costs of publishing our JACKSONVILLE IL. GENEAL JOURNAL, especially with the higher postage rates. Our GENEAL JOURNAL contains hundreds of names from Courthouse records, cemeteries, census records, marriage indexes and other materials from the several counties in West Central Illinois. Most of these records have never been published before, nor are available for public use otherwise. We place many of our records in the Jacksonville Public Library, the Illinois State Historical Library, and recently the newly-opened Sangamon Valley Genealogical Collection in Lincoln Library, on 7th Street in Springfield which is open to genealogists at times when others are closed. (On Saturday to 6 p.m., but not Sunday, on Third floor.)

IF YOU WISH TO RECEIVE your current Membership Card would you be kind enough to enclose a self-addressed stamped envelope? And, please, make them LONG ones when requesting genealogical materials so that xeroxed materials won't have to be folded so much.

IF YOU ARE AN OUT-OF-STATE RESEARCHER please be informed that many County Clerks in Illinois will require you to have a membership card from some Genealogical Society in Illinois before they will permit you to search indexes of vital records such as birth and marriage. This does not apply to Deeds nor Court records, except that adoption records require a legal reason and possibly a Court Order from a Judge.


