At the June 20, 1991 Jacksonsonville Area Genealogical and Historical Society Board meeting, it was voted to present to the membership the following By--Law changes effective 1992.

Section 3

Section 5

Section 6

Section 3 There shall be the following classifications of membership; society and life.

Honorary memberships may be given in recognition of outstanding service to the society. Dues for each classification of membership shall be recommended by the Board of Directors, prior to September 1, approved by the membership at a regular meeting and published in the September Quarterly.

Section 5 Each member shall receive a membership card and each such membership to cover one household. Members paying dues late in the year will receive all publications of the Quarterly.

Section 6 Members who have not renewed by February 28, shall be automatically dropped from membership after being duly notified in writing by the financial secretary, and causes a late fee to be added for reinstatement.

The By-Laws chairman, Shirley Rahe, presented and read to the membership at the regular meeting of the Society June 27, 1991 the proposed changes. She then presented same to the membership at the regular meeting July 25, 1991. At this time the membership voted to accept the changes. Com: W. Wallace, V. Gordon

STANDING RULES: ARTICLE III - - MEMBERSHIP DUES AND FEES.

Section 1 would remain the same. Section 2 would eliminate parts; 1, 2, and 3. Number 4 would become number 1.

- 1. SOCIETY MEMBERSHIPS ANNUAL DUES \$12.00.
- ALL PRESENT LIFE MEMBERS are those exempt from annual payment of dues, provided a cash contribution in the proper amount was made prior to June 30,1991.
 Society and Life members each receive one membership card and a single copy of the Quarterly per household.
- 6. will be 3. Honorary Life Membership may be conferred upon a member by a unanimous vote of the voting members present at any meeting of the Society. Such title shall entitle the holder to all the privileges due a Society Membership.
- 7. will be 4. To remain a member of the Society, members shall be liable for the payment of annual dues as heretofore described. Non-payment of dues is considered notice of withdrawal from the society. All rights, privileges and interests of a member in the society shall cease on termination of membership. A late fee of \$2.00 shall be charged after February 28th plus the annual dues to be eligible for reinstatement.
- 8. will be 5. No change, any change of address is the responsibility of the member. For a replacement copy of a back issue or an issue missed due to no notification of change in address, will incur a postage fee.

This was presented and read to the membership at the regular meeting July 25, 1991, at which time the membership voted to accept the changes.
