
## Discussion items:

- Select interim President

- Frank Bell was nominated as interim President until the annual meeting on 8 Aug 2020.
  - All present approved.
  - Frank agreed and noted that he will not be running for President at the annual meeting.
- Discussion to appoint an interim Secretary.
  - All agreed to keep the Board as is until elections at the annual meeting.
- Gratitude expressed for the years of dedicated service from Ken and Rose Jordan and Jan Toton to the Scott Shores Association.
- Actions between now and 8 August annual meeting
  - Obtaining documents, notes, and recordings from Ken and Jan.
    - Lisa volunteered to contact them both to get the needed documents handed over to enable a smooth transition.
  - Contact members regarding the issues before the board (see below) so they may be aware and prepared for the annual meeting
    - It was agreed that Frank and Tim would make the initial draft and pass around via email for others to provide input.
    - It was agreed that we would email the communication to those for whom we have an email address, and we would mail a letter to the rest.
    - It was also agreed that we would all attempt to get additional email addresses from friends and neighbors.
    - It was agreed to get the correspondence out no later than the end of the month to hopefully get the information to members as quickly as possible. That way, they could ask questions over the July 4<sup>th</sup> weekend when a lot of people are here.
  - Update website
    - It was agreed to update the website with these discussion items and decisions.
