Propane Co-op: Charlie spoke with two different companies that deliver in Pinewood. One is Ferrell Propane out of Estes, who offered delivery at \$2.79 per gallon. The other is Poudre Valley Propane, but they refused, saying they don't have the manpower to deliver to PWS at the moment.

Crescent Lake Drainage: Charlie met with Pat and John from the road board and went down to examine the damage in person. They will confer about potential solutions and

costs and get back to us with a proposition. Charlie, Evan, and Patty will meet up to examine the situation on Tuesday, September 27th.

Tubs Park Upgrades: Rob, Patty, Gabi and Bob successfully installed both benches, and Evan, Ardeen and Patty also finished heaping on the new gravel at the top of the path. Patty suggests that we continue installing ³/₄ gravel on the rest of the walkways at the park next spring.
