New Business:

Propane Co-op: Gabi provided a brief history of our neighborhood's various propane deal over the years and their current statuses. We agree that it might be time to involve a third provider, and Charlie will investigate.

Crescent Lake Drainage: recent rains have over-run the drainage ditch and damaged the parking area. We agree that because Larimer county suggested the "French drain" design over installing a culvert. Charlie will contact the county so they can see the result and suggest a course of action.

Tubs Park Upgrades

August 19th starting at 8:30am Patty, husband Rob, and Gabi will install two new benches. Play horse upgrade will wait until next month. We also need to remove the old broken picnic table. Dam was breached and flow was restored. Vandalized sign still needs repair

CWPP

The CWPP group consisting of PSFPD, PSWD, PSPOA, and Road Board representatives gathered on July 21st. The group reviewed the CWPP progress to date, which included Chief Plank's draft list of Community Hazard Reduction Priorities. Discussion of coordinating the PSFPD's wildfire awareness day with the PSPOA's annual Tubs park cleanup day. PSPOA board members discussed. Gabi moved that the PSPOA establish the third Saturday of May as Tubs Park Cleanup Day, in solidarity. MOTION APPROVED.

For the calendar, each board is going to contribute \$200-\$300 per year for printing and distribution costs. Each board is asked to contribute content as well. Patty moved to commit that sum (\$200-\$300) in the PSPOA budget for that purpose, Gabi second. MOTION APPROVED.

The PSFPD would like to cooperate with the PSPOA on the disposal of community yard waste. Evan will investigate how the city of Lyons recently hosted a free yard waste disposal event. One part of the action plan is to provide dumpsters for slash and debris drop for free use by residents (costs paid by the PSFPD and PSPOA). If county funding is available, that will be applied as well. Board members discussed broad support.
