Tis the season for holiday fire-safety reminders: Keep flammable items (curtains, holiday decorations) at least 3 feet away from wood stoves, fireplaces, and candles (or consider using battery-operated candles). Do not overload electrical outlets and throw away light strands with frayed or pinched wires. Turn off, unplug, and extinguish all decorations before going to bed or leaving your home. Also, a dry Christmas tree is dangerous - be sure to water daily.

Larimer County Animal Control Ordinance from poa website

CHAPTER 6 LARIMER COUNTY CODE Revised Ordinance ANIMALS

Sec. 6-78. Public nuisance prohibited.

Dogs must be contained on one's property by a fence, housing, or electronic means. Off one's property, dogs must be kept under restraint or be immediately responsive to voice command. Pets may not disturb the peace by barking or howling, in an ongoing manner. It is the duty of pet owners to ensure that they pick up after their pets.
