**Trespassing:** There have been several incidents of trespassing over the last few weeks especially in and around the TUBS area. We would like to ask everyone using the park to access the Tubs through the main entrance. And to better mark the Park (the tubs area) boundaries, the PSPOA is installing signs that mark the lot lines. Be aware that the lower area of the river between the park and the Kiowa bridge is on private property. Not all lot lines end at the river. Many properties cross the river and continue up the other embankment. Please respect your neighbor's property and wishes and don't cross it to take a short cut to the river unless you have permission from the property owner. Parents, please make sure you and your children are clear on the rules of trespassing and the areas that are private property surrounding the TUBS. ### Tip of the Month: Russian Olives - a dangerous invader, by Tom Tuer

**Description**: A bush or tree up to forty feet tall, with alternate lance-shaped silvergreen leaves, 1 to 3 inches long, 3/8 to 1-1/4 inches wide; yellowish-green flowers in spring; stems with stiff woody thorns 1-2" long; fruit resembles olives, seed is a small white or brown stone; can also spread by suckers from the extensive roots. Seeds are readily spread by birds, mammals and water flow from residential areas to river bottoms.1 They are able to establish below the canopy of native trees, and are more tolerant of drought and large salt-content soils.1 Colorado banned its sale in 2004; originally sold for wind breaks and as an ornamental.

**Hazards**: Competes with native trees producing dense thickets that consume water at a greater rate than native trees. Fire threat is heightened by increased vertical and horizontal canopy density, increased fuel continuity and volatile fuel ladders, nesting and roosting for birds is reduced, decreasing species richness. A study found nests of eleven bird species in Russian olive stands compared to twenty-nine in native river woodlands.

**Treatment**: Small trees can be uprooted using a weed wrench; or cut tree near base and apply herbicide (either a 50% solution of *Garlon-4* "triclopyr"1 or *Roundup* "glyphosate" in a mix with a crop oil concentrate6) to the stump near its outer ring; repeated cutting and application of herbicide is necessary as sprouts form; there are no bio-control agents available. It is on the Colorado List B of invasive species, requiring local governments to develop plans to prevent spread. Larimer County encourages removal.

**Plea:** I urge everyone to help eliminate the species from Pinewood Springs in order to reduce our fire vulnerability; preserve our precious river (which is our primary source for water); and maintain our diversity of birds, mammals and botanical species. There are several large stands of mature Russian olive trees in the community which produce an immense number of seeds; a large portion will end up at the river. With a cursory investigation only near the bridges, around twenty saplings have been found

already. I am starting a campaign to eradicate the invader from the riverbanks and hopefully from the entire community. The time for action is now when the spread to the riverbanks can be controlled, and small trees are much easier to treat. We owe it to our neighbors and future residents to prevent the destruction of our river environment. I hope I can have general support of the community in this effort (and a few dedicated helpers).
