CANCELLATION POLICY

For Racing Season

Cancellations of 29 days or more from the date of the event

Full credit (valid for a period of 12 months) or refund less an administration fee of £20 for Sprint Classes, Acu course, £50 for Endurance entries.

Cancellations between 15 and 28 days from the date of the event

A credit (valid for a period of 12 months) refund less an administration fee of £20 for Sprint Classes, Acu course, £50 for Endurance entries.

Cancellations less than 14 days from the date of the event

No Refund or credit (unless the space is resold, refund less an administration fee of £20 for Sprint Classes, Acu course, £50 for Endurance entries.)

Cancellations of COD's for any event

For COD's, the terms are the same as making and paying for an event in full. All cancellations are subject to the same charges and should the rider not attend, No Limits reserves the right to charge the card for the full amount of the event without prior consent.

Direct Debit Scheme

This scheme is a direct payment of a season entry fees, deposit is to be paid followed by 7 monthly payments.

Cancellations must be made in writing, cancelling the direct debit can result in your entry being cancelled.

If a direct debit is cancelled by you, a charge of £10 per time to reinstate the direct debit, after two cancellation, the direct debit scheme will be cancelled and your entry will revert to pay as you go rate.

Non payment of direct debits administration fee of £30 will be added for each and every failed transaction after the first one, after two successive failure, your direct debit scheme will be cancelled and your entry will revert to the pay as you go rate.

RIGHTS OF SELLER

- 1 The Seller reserves the right to adjust the price and specification of any item on the Website at its discretion.

In all other circumstances, unless otherwise notified in writing by the Seller, the issue of any credit (full or partial) due to any Force Majeure Event is at the entire discretion of the Seller.

In all circumstances, the Seller is not liable for any additional costs, expenses, and/or losses of any kind and however caused which arise out of or in connection with a Force Majeure Event (including but not limited to travel costs, accommodation costs, subsistence costs, and/or loss of earnings).

The Seller is not liable for any costs, expenses, and/or losses of any kind and however caused which arise out of or in connection with a Force Majeure Event which are covered by any insurance policy which the Buyer has or is required to have as a prerequisite to attending or participating in an event provided by the Seller.
