# VILLAGE OF BOYNE FALLS ORDINANCE NO. 59

### **SECTION I. Title:**

This ordinance shall be known as the Village of Boyne Falls Animal Waste Ordinance

#### SECTION II. PURPOSE:

An ordinance to establish requirements for the proper disposal of animal solid waste in the Village of Boyne Falls so as to protect public health, safety and welfare, and to prescribe penalties for failure to comply.

#### **SECTION III. Definitions:**

For the purpose of this ordinance, the following terms, phrases, and words and their derivations shall have the meanings stated herein unless their use in the text of this Chapter clearly demonstrates a different meaning. When not inconsistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

- a. Immediate shall mean that the animal waste is removed at once, without delay.
- b. Owner/Keeper any person who shall possess, maintain, or harbor any animal or otherwise have custody of any animal, whether or not the owner of such animal.
- c. Person any individual, corporation, company, partnership, firm, association, or political subdivision of the State subject to municipal jurisdiction.
- d. Animal an animal(other than a disability assistance animal) kept for amusement or companionship
- e. Animal solid waste waste matter expelled from the bowels of the animal: excrement
- f. Proper Disposal placement in a designated waste receptacle, or other suitable container, and discarded in a refuse container which is regularly emptied by the municipality or some other refuse collector; or disposal into a system designed to convey domestic sewage for proper treatment and disposal.

## SECTION IV. Requirement for Disposal:

All animal owners and keepers are required to immediately and properly dispose of their animal's solid waste deposited on any property, public or private, not owned or possessed by that person.

# SECTION V Exemptions:

Any owner or keeper who requires the use of a disability assistance animal shall be exempt from the provisions of this section while such animal is being used for that purpose.

### SECTION VI Enforcement:

The provisions of this Article shall be enforced by the Charlevoix County Sheriff Department and the Charlevoix County Board of Health for the Village of Boyne Falls.

## SECTION VII. Violations and Penalty

Any person(s) who is found to be in violation of the provisions of this ordinance shall be subject to a fine not to exceed \$ 50.00 (Fifty Dollars) per occurrence.

## SECTION VIII. Severability:

Each section, subsection, sentence, clause and phase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phase, and the finding or holding of any such portion of this ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

## SECTION IX. Effective Date:

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
