Doug Weiss attended the Army Corp Engineer's meeting and they are moving forward with the Grant. He did state however that MDOT also attended and they think the bridge is in fair condition. There will be another meeting in August for the bridge. Marilyn did find that the emergency order is in place but does need to be updated.

## Old Business –

Marilyn conferred with the attorney about the sidewalks in front of a home needing repair. The Attorney found that there is no ordinance in place, so this makes it the problem of the Village to take care of. It was suggested that the problem area be dug up and grass seed added to fix the problem. The motion was made by Mike Kondrat Jr. and Seconded by Gabe Blackledge. All in favor.

Marilyn and Mike meet with Consumer's Energy about the trees being in the roadway and problematic but they are saying they are not in the roadway making it not their problem. Mike is going to ask the property owners if they have the property staked to find out where the line is and will report back at the next meeting. If it is not on the property owner's property, the village will need to get some bids to take down the trees that are in need of being taken care of.

## New Business -

Travel Trailers/Motor Homes cannot park on the street and even though they can park on private property, the zoning is not legal for it to be lived in full time. A water bill will be sent to the person who is doing this at their residence and a letter will be sent to also inquire about the insurance and registration for said motor home.

No one showed any interest in the part time maintenance position to help Dave Carson this summer. Bill Cousineau offered to help at that position for \$18.00 per hour. Motion was made by Mike Kondrat Sr. and Seconded by Mike Kondrat Jr. Marilyn Cousineau abstained from voting. Motion passed with 5 in favor.

White Building next door to the Village Hall will be offered to the Fly Wheelers to be moved if they are interested. Marilyn will call them to find out and will report back at the next meeting.

Ann Marie Boettger has accepted the Clerk position replacing Heidi Riggs.
