VILLAGE OF BOYNE FALLS
PUBLIC BUILDINGS, GROUNDS, AND PARKS
Ordinance No. 46

THE VILLAGE OF BOYNE FALLS ORDAINS:

Section 1. Village Ownership and Sale of Public Property.

The Village may acquire, purchase, and erect such public buildings, as may be required for the use of the Village, and may purchase, appropriate, and own such real estate as may be necessary for public grounds, parks, markets, public buildings, and other purposes necessary or convenient for the public good. Such building and grounds, or any part thereof, may be sold at public or private sale or may be leased, as the Village may require. However, a public park shall not be sold without the consent of a majority of the qualified electors of the Village.

Section 2. Severability

If any section, provision or clause of this Ordinance or the application thereof to any person or circumstance shall be invalid, such invalidity shall not effect any remaining portion or application of this Ordinance which can be given effect without the invalid portion or application.

Section 3. Effective Date.

This Ordinance shall become effective thirty (30) days after being published in a newspaper of general circulation within the Village.
