Old Business

A discussion about raising the Air BnB water bills to a commercial rate of \$146. Joann Bell made a motion to increase the rates, supported by Larry Organek. Motion carried 6 to 0. The clerk will write letters to owners notifying them of the rate increase.

A discussion about raising the water bill for Bear River Health. Bear River Health can accommodate up to 90 individuals and are preparing hundreds of meals per day. The water rate has remained the same since the building held the school. Council decided to table the discussion until next meeting, to give more time to research and configure a new rate.

Discussion on repealing Ordinance 63, Marijuana. Larry Organek made a motion to repeal Ordinance 63, effective immediately, supported by Doug Weiss. Motion carried 4 to 2.

Raphael Zara made a motion for resolution to apply for the Parks Grant through Charlevoix County, supported by Brandy Marvin. Motion carried all in favor.

New Business

Does the council want to pay to have a SAM's number? The number is used to apply for Federal grants, costs \$599 and has to be renewed yearly. Brandy Marvin made a motion to purchase the SAM's number, supported by Raphael Zara. Motion carried to all in favor.

Discussion on financing for the new truck. The cost of the truck is \$114,000, with \$137,152 for installation and \$14,728 for optional front plows. President Marilyn Cousineau will get back with the council on the interest rate. Joann Bell made a motion to go with Charlevoix State Bank, supported by Raphael Zara. Motion carried to all in favor. Larry Organek made a motion to go with Truck & Trailer Specialties for everything except the plow, supported by Raphael Zara. Motion carried to all in favor.
