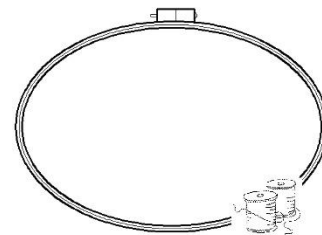

Artist Résumé

When art collectors and gallerists see my textile artwork for the first time, they call them unframed stitched paintings. Thread on textile is my medium, much as "oil on canvas" or "acrylic on hard board" is a painter's medium. The medium of my work can be further defined by the ground used hand dyed textile, dye painted textile, rust pigmented textile or commercial textile. The thread is applied to these grounds by hand (no machine), using a small one-inch needle in a time-intensive process.
