**Prairie Leaf #1** is the first in a new series that was inspired by a trip to Fond du Lac, Wisconsin, and a visit to a 20-acre restoration prairie filled with plants and wildflowers. I harvested some of the leaves that intrigued me and used the Compass plant leaf for this piece. The leaf is recreated here in actual size with hand stitching. I then used a 1/16-inch echo stitch design to give the piece a three-dimensional look. The green and rust ground is one of my hand dyed pieces.

The artwork is designed to be displayed in either a vertical or horizontal orientation which allows for versatility in displaying the artwork spatially and visually.
