#### A word of caution to Scotch pine growers this year

This year has been a welcomed wetter than normal year for a large part of the state. With wet weather in many cases comes Brown Spot Needle Blight, especially on long established tree farms. If there has been a history of Brown Spot on your Scotch pines, then for sure you probably should treat with Chlorothalonil or Copper sulfate fungicide. The first treatment should be now when the needles are about half length and then again in 3-4 weeks. This disease sneaks up on you and by the time needle damage is visible it's too late to treat. It is usually not evident until late summer which again is too late to treat. You may what to talk to your state entomologist for advice.

Message from Corey Johnson and Ryan Fisher

The Wickiup Hill Tree Farm was started by Ken and Shirley Andrews in 1980. They planted White Pine and Scotch Pine trees their first year. Kenny planted about 1200 trees a year for the first 7 years with hopes to sell about 500 trees a year to supplement his retirement. Ken was the first to give Fraser Fir trees a shot in the area and once they were tall enough to sell, customers bought **everyone**, and the farm began shifting its inventory to primarily Fir Trees.

Ken continued to plant and sell trees playing with variety until 2009 when Tim Andrews (Ken's Nephew) took over operations of the farm. He continued running the farm much like his uncle Ken did for 10 years planting several varieties of spruce trees, red, scotch, and white pine, as well as **Fraser**, balsam, **Canaan**, and **concolor** fir trees.

Korey Johnson and Ryan Fisher worked at the farm as high school kids for Kenny. While attending college and then into their careers as a teacher (Korey) and a lawyer (Ryan) were away from tree farming from 2007-2018.

We had a thought that turned into a dream (even if our wives didn't understand it completely) to run our own farm together some day. Land was difficult to find but we had the opportunity to work alongside Tim Andrews in 2018 in preparation for his retirement. After two full years of working and learning, in 2020, Tim decided he had **enough,** and our two families took over operations of the farm. Nothing like Covid and the Derecho in your first year of management to break **in with** a couple new tree farmers. The first year we planted 1500 trees. Since then, we have been planting about 3000 trees a year and expanding the farm.

We feel we have a very unique farm with a lot for farmers of any size and experience to learn from. We know through our **meeting** we will learn as much from many of you attending as you will from us. We look forward to sharing what we have learned in our first years of operation and what we are trying and changing in an effort to grow quality trees going forward.

### ICTA GENERAL MEMBERSHIP MEETING Saturday July 15, 2023

<u>MEETING:</u> The meeting was called to order at 9:30 p.m. at Wapsi Pines Tree Farm, Fairbank, IA by the President John Beckwith.

MINUTES FROM SATURDAY JULY 09, 2022: Sandra Hunter read the minutes from the 2022 general membership meeting. The minutes were also included in the Winter Newsletter. Reid Bermel motioned to accept the minutes as read, seconded by Mark Fisher.
