Things to Remember

- 4th estimated personal income tax payments for 2024 is due January 15, 2025.
- 4th quarter 2024 payroll forms will be due January 31, 2025.
- Quarterly accrual accounting clients should have inventories, accounts receivable, and accounts payable balances as of December 31, 2024.
- Monthly accounting clients, please have your work papers into the office by the 10th of the following month.
- Keep those mileage logs up to date!

2024 Mileage Rates

.67 cents per mile for business miles driven

.21 cents per mile driven for medical or moving purposes

.14 cents per mile driven in service of charitable organizations

Tax Season Planning

Be prepared this season with these few helpful tips:

- Organizers are headed your way, please read and fill them out fully. They will help you and us with your personal tax return preparation. Don't forget your signature on the 2nd page of the cover sheet!
- Keep a folder and put items in it as they come in the mail or your email for 2024 taxes.
- Don't forget to save all receipts from donations and **note** what it was for if it's not on the receipt and how much it's worth.

Business Travel Deductions

Business travel deductions are available when employees must travel away from their tax home or main place of work for business reasons. A taxpayer is traveling away from home if they are away for longer than an ordinary day's work and they need to sleep to meet the demands of their work while away.

Deductible travel expenses include:

Travel by airplane, train, bus or car between your home and your business destination.

Fares for taxis or other types of transportation between an airport or train station and a hotel, or from a hotel to a work location.

Shipping of baggage and sample or display material between regular and temporary work locations.

Using a personally owned car for business.

Lodging and meals.

Dry cleaning and laundry.

Tips paid for services related to any of these expenses.

Other similar ordinary and necessary expenses related to the business travel.
