Dear Friend of NICWA,

Seven years ago, Allie and her husband decided to become foster parents. They understood that their local community desperately needed licensed Native parents. Within two weeks of making their decision, they met a three-month-old, Riley, who changed their lives and reaffirmed their belief that when the Indian Child Welfare Act (ICWA) is followed, it has a positive impact for children and their families. By sending your gift today, you will help 567 tribes defend against current attacks on ICWA and keep families together.

### Children thrive when ICWA is followed.

Chief Judge Allie Greenleaf Maldonado is a citizen of the Little Traverse Bay Bands of Odawa Indians in northern Michigan and a member of the mshiikenh or Turtle Clan. She is also the mother to a beautiful, vibrant sevenyear-old boy who attends Montessori school with his sister, tests in the top five percentile in math, has the reading level of a high school student, and loves fishing.

Riley is active in the Little Traverse community and a citizen of the Little River Band of Ottawa Indians. His life with his adoptive family includes gathering blackberries and raspberries on tribal lands in the summer, visiting the tribe's fall encampment, participating in November ghost suppers, celebrating Tribal Sovereignty Day, and one of his most recent favorite activities—learning how to shoot a bow and arrow.

Riley thrives because he remained close to his family and community. Born in Reno, Nevada, to his young biological mother, Riley immediately became part of the child welfare system in a state that worked hard to follow ICWA by reaching out immediately to the tribe upon identifying his tribal affiliation.

"Everybody needs to feel that they belong," shared Allie.

ICWA ensures that tribes are able to determine a home that will provide the best care for their member children. Since Allie and Riley come from sister tribes and share the same clan, the tribe felt theirs was an appropriate placement when his immediate family was unable to care for him. This prioritization is crucial as it keeps Native children connected to their families and culture—a child welfare standard ideal for all children.

"Indian tribes are lucky, as we have a rich and deep history. People are better for it, to know their history," Allie reflected in thinking about her community. She believes that all people need to feel that they belong, and the most effective pathway to this goal is by keeping families together.

#### ICWA is under attack.

But due to current attacks on ICWA, families and communities may be torn apart. Opposition comes from private adoption attorneys and agencies and anti-tribal groups who all have a financial stake in its demise. Five lawsuits have been filed in federal district courts over the last several months—all with the goal to weaken or overturn this effective and meaningful federal law.

NICWA continues to play an essential role in this fight by continuously updating and rallying Indian Country, engaging in social media campaigns, organizing ICWA experts in crafting a unified litigation and public education strategy, and providing materials and support to numerous tribes, organizations, and individuals.



## Ogichidaa: modern day warrior defending Native children.

Ogichidaa is an Odawa word that means "warrior," and that is the first word Allie mentions when she talks about NICWA and our defense of ICWA. "You are protecting the future of tribes, our right to exist, and our right to be sovereign. You are protecting our right to pass on our culture to our children, and our future."


