

This is an example of a template to send your county commissioners office and members about the COVID bio-weapons and 5G.

*All descriptive and local information **in red** should be deleted and replaced with your own local names, laws and preceding information.*

Make sure and email as many people within your county commissioners office as you can.

County Commissioner Email Template:

Dear your county's name County Commissioners Office,

My name is Your name. I'm a resident of County name County, State.

It's come to my attention that you have plans/contracts in place to increase the use of 5G wireless technology, in particular for what you think is "faster internet" or "better cell-phone service."

I can assure you that this is not the intent of 5G antennas, whether large or small. 5G technology are weapons that have been created by the Department of Defense, Lockheed, and the EPA. They emit harmful electromagnetic frequencies (EFM radiation) that are intended to disrupt healthy and unhealthy cells in the human body and cause countless illnesses, including immediate death when the frequency is high enough and turned up remotely.

5G also has a direct impact on those who took the classified bio-weapon that you refer to as the "COVID-19 vaccine." This so-called "vaccine" is in fact a categorized biological weapon by definition, with only one intent; to kill those who take it.
