FOOD HANDLING LICENCE COURSE

By law regulations from the Logan City Council you need to obtain a Food Handling license in order to handle and sell food to the public. Please ring Logan City Council to find out when they hold their food-handling course.

After sitting through the food handling course and having an understanding of the requirements for food handling, this will give you time to which you can make an informed decision whether you would like to continue with your food stall or not.

TERMS and CONDITIONS

- ✚ Workplace Health and Safety Act is required and must be obeyed and followed. This is your own responsibility to ensure that the safety for yourself and others are adhered to.
- ✚ To all adults both MEN and WOMEN 18yrs and older, please be aware there is to be NO CONSUMPTION OF ALCOHOL on this day. If found doing so you will be kindly ask to leave the show ground escorted by the POLICE. Show respect for yourself, your family and your friends together along with the PNGFQI to make this a safe and enjoyable day of celebrating marking another year of Independence for our beloved country PAPUA NEW GUINEA.

Please read the following conditions:

- You are responsible for ensuring all food outlets meet both Brisbane City Council & Logan City Council's Health and Safety requirements.
- For those selling cooked food you must provide your own food licence. {Please organise and apply for these 2 weeks in advance with the Logan City Council.}
- You must provide your own marquee or tents (3x3sqm). No pegs are to be driven into the ground. Any damage to the turf will result in a \$700 per square metre fine plus GST to replace and repair. All marquees and structures must be free standing. Use sand bags that can be purchased at various camping shops or similar weights.
- The ground canteen will be selling HOT PIES, HOT CHIPS, HOT DOGS, SOFT DRINKS and DRINKING WATER
- Stallholders CANNOT sell these above-mentioned items. Any other cooked food is acceptable.
- Those of you stall holders that are cooking you are required to supply small oil waste drums, also oil mats wide and big enough to place under your BBQ stand, to ensure there are no oil leaks as it may damage the turf in your area.
- You will only sell the agreed items at your stall. Please ensure that you do understand that food stalls only sell food – non-food stalls only sell non-food items. You are not allowed to sell both at the same stall.
- Betel Nut sellers it is your responsibility to provide plastic bags for customers to spit into and also stress the reason why to do so every time a customer buys a bag of betel nut.
- Limit one car per stallholder, as parking space is limited.
- Ensure your area of stall allocation is clean at all times
