

Next EMI Georgia Network Meeting – September 26, 2022



Target population determined by the EMI GA Network:

- Parents of preschool-level children of color
- Parents of students of color who are in the preschool to prison pipeline



NEXT STEP: Breaking the PSTPP through community partnership with Head Start targeting Head Start's family engagement program components



Rationale for engagement with Head Start:

- Engagement in education settings is essential to breaking the preschool to prison pipeline
- Prevention and intervention are essential to breaking the preschool to prison pipeline.
- According to the Sentencing Project's report released Feb. 2021, half of imprisoned people in the United States are parents of minor children who are under age 18: 47% in state prisons and 57% in federal prisons. In 2018,
 - 20% of Native children
 - 13% of Black children
 - 6% of Latinx children
 - 6% of white children

had experienced parental incarceration at some point in their lives.





Rationale for engagement with Head Start:

- According to the Annie E. Casey Foundation, 8% of Georgia's child population or 189,000 children have had a parent in jail or prison at some point in their childhood.
- Adverse effects of parental incarceration on young children.
- XX% of children who participate in the Head Start program in Georgia have parents who are under supervision (i.e., incarcerated, on probation or parole) within the criminal justice system.
- Head Start has a track record for implementing prison-based programs with mothers who are incarcerated and their children.
 - Coffee Creek Correctional Facility in Wilsonville, Oregon
 - Connections, a program of the Oakland Livingston Human Service Agency in Pontiac,
 Michigan





Project Actions:

- 1. Engage Head Start in conversation
- 2. Make presentation to GHSA directors
- 3. Begin to identify a cohort of local Head Start programs with the Head Start centers with whom we have connections (focused on the family engagement component, but not limited to occurrence of incarceration)
- 4. Determine finalized components for engagement with the GHSA at the state and local levels
- Invite GHSA to present at EMI Georgia Network general meeting
- 6. Roll out the family engagement plan and opportunities at EMI Georgia Network's general meeting
- 7. Explore potential for EMI Georgia Network to present at the GHSA fall or spring conference
- 8. Accountability: Develop tools for tracking engagements and impact assessment
