NUMI KINGDOM CHAPTER 6 1

I Queen: Muad'Dib Saidah N. El'Osiris do solemnly and sincerely in the presence of the Creator profess, testify and declare that I am a faithful under natural law, and that I will, according to the true intent of the enactments which secure the natural law of Men and Women the highest succession to the Throne of my Realm, uphold and maintain the said enactments to the best of my abilities.

I Queen: Muad'Dib Saidah N. El'Osiris, swear (or affirm) that I will be faithful and bear true allegiance to my God head Oshun and stay true to the Prophet Noble Drew Al, of Amexem North, Central, and South America, as well as surrounding islands. Al Moroc, Morocco, West Africa, Northwest Africa., her heirs and successors, and that I will faithfully observe Divine law, Common Law and the Law of Reason. Natural Law, Natural Rights, and Constitutionalism laws, Bylaws of Numi Kingdom including treaties with Indigenous Peoples and fulfil my duties.

I am Flesh and Blood Man and Woman Natural Persons and duly affirm standing squarely upon our principles of Love, Truth, Peace, Freedom, and Justice.

I am and my offspring are Free Mauri Nationals of Al Moroc (America) North, Central, South America and Adjoining Islands anciently referred to as Amexem and I am part and partial to the land of my Ancient Forefather (Mauri Amazeegh Berbers) by Birthrights and inheritance, aboriginal and indigenous as well as a de jure natural Man and Woman and declaring my power and authority by right of birth and right of the soil. All unalienable rights and immunities, As a True Noble of The Numi Kingdom of North America (Mu'ur, Mauri) "WE" are Indigenous Aboriginal being, a free Inhabitant and NOT an artificial person/entity but A living, breathing divine being endowed with the Infinite Consciousness of Allah, The Most High, Higher-Self Over Soul, OSUN, MU UR, RA, ALLAH).

CORONATION OATH RULES:

I Numi Kingdom Laws of Oath heretofore framed in doubtful Words.

Whereas by the Law and Ancient Usage of this Realm the Kings and Queens thereof have taken a Solemn Oath upon the Mauri Amazeegh Berbers at Their respective Coronations to maintain the Statutes Laws and Customs of the said Realm and all the People and Inhabitants thereof in their Spiritual and Civil Rights and Properties But forasmuch as the Oath itself on such Occasion Administered hath heretofore been framed in doubtful Words and Expressions with relation to ancient Laws and Constitutions at this time unknown To the end therefore that One Uniform Oath may be in all Times to come taken by the Kings and Queens of this Realm and to Them respectively Administered at the times of Their and every of Their Coronation.

II Numi Kingdom Laws Oath hereafter mentioned to be administered, by the High Priest of the Berbers Moorish empire

May it please Your Majesties That the Oath herein Mentioned and hereafter Expressed shall and may be Administered to their most Excellent King Baga of the 'House of Masinissa' ruled in Numidia and Queen Dihya (whom Allah long preserve) at the time of Their Coronation in the presence of all Persons that shall be then and there present at the Solemnizing thereof by the High Priest of the Berbers Moorish empire of Mauri or either of them or any other Priest of this Realm whom the King's Majesty shall thereunto appoint and who shall be hereby thereunto respectively Authorized which Oath followed and shall be Administered in this Manner That is to say, *The first both of my ancestors*.

III Form of Oath and Administration thereof.

The High Priest or Priest shall say,

Will You solemnly Promise and Swear to Govern the People of this Kingdom of Numi and the Mauri Moorish Dominions thereto belonging according to the Statutes in Body Politics Agreed on and the Laws and Customs of the same?

The King and Queen shall say, I solemnly Promise to sue to do.

High Priest or Priest,

Will You to Your power cause Law and Justice in Mercy to be Executed in all Your Judgements. King and Queen, I will.

High Priest or Priest,

King and Queen. All this I Promise to do. After this the King and Queen laying His and Her Hand upon the Holy word of Allah, shall say, King and Queen The things which I have here before promised I will perform and Keep So help me God.

Then the King and Queen shall kiss the Book of life.

IV Oath to be administered to all future Kings and Queens.

And the said Oath shall be in like manner Administered to every King or Queen who shall Succeed to the Imperial Crowne of this Realm at their respective Coronations by one of the High Priest or Priest of this Realm of Moorish empire for the time being to be thereunto appointed by such King or Queen respectively and in the Presence of all Persons that shall be Attending Assisting or otherwise present at such their respective Coronations Any Law Statute or Usage to the contrary notwithstanding.

DECREE LAW: "So, in closing", I will reiterate that our efforts are grounded in the respect of the Human Family, by uplifting the fallen Humanity through Love, Truth, Freedom, Justice and Peace.
