## PROJECT SUMMARY:

The Project will include a Civic Center interconnected with mixed-use buildings surrounding an interior parking structure. The Project will be comprised of approximately 4230 Container apartments, approximately 120,000 square feet of ground-floor commercial space, three courtyards and a public plaza area with new road development including an International Airport, along with hospital medical centers and clinics. Including schools and learning centers along with agriculture botanical garden greenhouses and Commercial shopping centers.
