Royal Decree:

Adoption of the Ogoni Tribal Nation into the Kingdom of Numidoria Embracing Human Rights and Unity in the Kingdom of Numidoria

In the sacred halls of solidarity, on this poignant occasion of the 28th Anniversary Commemoration of the Ogoni 9, as convened by the Movement for the Survival of the Ogoni People USA (MOSOP USA/ Ogoniland Nigeria Africa) in Atlanta, Georgia, on November 12th, 2023, we, the Kingdom of Numidoria, embark on a historic journey by extending our sovereign embrace to the esteemed Ogoni Tribal Nation.

As the sun sets over our united aspirations, we commit ourselves to a steadfast pledge—protecting human rights and fostering unity within the Kingdom of Numidoria. This decree serves as the cornerstone of our commitment to the welfare of our people and the collective strength of our diverse communities.

Article I: Unity in Mourning:

On this day, our hearts resonate with the poignant memories of the Ogoni 9, martyrs who made the ultimate sacrifice for justice and environmental rights. In solidarity, the Kingdom of Numidoria stands united in mourning, joining hands with the Ogoni people to commemorate the bravery and resilience that define this pivotal moment in history.

Article II: Adoption into Numidoria:

In a gesture echoing through the corridors of time, the Kingdom of Numidoria formally and joyfully adopts the Ogoni Tribal Nation into the folds of our sovereign realm. This historic act of kinship transcends borders, symbolizing our commitment to shared values, cultural respect, and harmonious coexistence.

Article III: Cultural Preservation and Exchange:

Recognizing the vibrant cultural tapestry of the Ogoni people, the Kingdom of Numidoria pledges unwavering support for the preservation and integration of Ogoni traditions. A comprehensive cultural exchange program shall be inaugurated, weaving the rich heritage of the Ogoni people into the very fabric of Numidorian identity.





Article IV: Economic Partnership:

The Kingdom of Numidoria and the Ogoni Tribal Nation embark on a journey of economic collaboration. Joint ventures in trade, commerce, and sustainable development shall be cultivated, ensuring the prosperity and well-being of both nations. This partnership seeks to harness the strengths of each, creating a harmonious synergy that uplifts both Numidoria and the Ogoni people.

Article V: Educational and Technological Collaboration:

A commitment to fostering knowledge and innovation lies at the heart of our alliance. The Kingdom of Numidoria and the Ogoni Tribal Nation pledge to establish collaborative educational and technological initiatives. Scholarly exchange programs, research partnerships, and technological advancements will be actively pursued to empower the youth and cultivate intellectual growth.

Article VI: Mutual Defense and Support:

Bound by the spirit of fraternity, the Kingdom of Numidoria and the Ogoni Tribal Nation solemnly pledge mutual defense and support. In times of need, our nations shall stand as one, facing challenges together, and reinforcing the strength of our alliance. This commitment to collective security ensures the safeguarding of both Numidorian and Ogoni interests.

Article VII: Diplomatic Relations:

Formalizing our commitment to international cooperation, diplomatic relations will be established between the Kingdom of Numidoria and the Ogoni Tribal Nation. Open channels of communication, transparency, and collaborative decision-making will define our diplomatic engagement, fostering a relationship built on trust and shared goals.

Article VIII: Renewal of Friendship:

This royal decree is not just a symbol of adoption but a profound renewal of enduring friendship. As we embark on this collaborative journey, let the bonds forged be unbreakable. May the path ahead be one of shared prosperity, respect, and cultural richness, echoing through the generations to come.

Article IX: Environmental Stewardship and Sustainability:

The Kingdom of Numidoria, in partnership with the Ogoni Tribal Nation, commits to environmental stewardship and sustainability. Joint initiatives shall be undertaken to address ecological challenges, promoting responsible resource management, and adopting eco-friendly practices for the benefit of both nations and the global community.

Article X: Healthcare and Social Welfare Collaboration:

Recognizing the importance of the health and well-being of our Subjects, the Kingdom of Numidoria and the Ogoni Tribal Nation shall collaborate on healthcare initiatives and social welfare programs. Accessible and quality healthcare facilities will be developed, ensuring the prosperity and happiness of our people.

SECTION 2 OF THE ROYAL DECREE:

Article I: Right to Life Every individual in the Kingdom of Numidoria has an inherent right to life, and the kingdom shall take all necessary measures to protect this fundamental right.

Article II: Freedom of Expression the Subjects of Numidoria enjoy freedom of expression, ensuring open discourse and the sharing of ideas without fear of retribution.

Article III: Equality and Non-Discrimination The kingdom upholds the principle of equality, prohibiting discrimination based on race, gender, religion, or any other grounds.

Article IV: Right to Privacy The right to privacy is inviolable, and the kingdom pledges to protect its Subjects from unwarranted intrusion into their personal lives.

Article V: Freedom of Religion the Subjects of Numidoria are free to practice their chosen religions without fear of persecution, promoting a diverse and tolerant society.

Article VI: Right to a Fair Trial Every individual has the right to a fair and impartial trial, and the judicial system in Numidoria is committed to upholding this fundamental right.

Article VII: Protection of Refugees Numidoria extends protection and support to refugees, ensuring their safety and well-being within the kingdom's borders.

Article VIII: Right to Education Access to quality education is a fundamental right for all Subjects of Numidoria, promoting intellectual growth and societal progress.

Article IX: Freedom of Assembly and Association Subjects have the right to assemble peacefully and associate freely, fostering a vibrant civil society within the kingdom.

Article X: Right to Work Every individual has the right to work in conditions that respect human dignity, and the kingdom promotes employment opportunities for all its Subjects .

Article XI: Gender Equality The kingdom is committed to gender equality, ensuring that men and women have equal opportunities in all spheres of life.

Article XII: Right to Adequate Housing the Subjects of Numidoria have the right to live in adequate housing, and the kingdom will work to eradicate homelessness and provide shelter for all

Article XIII: Protection of Vulnerable Populations Special protections are afforded to vulnerable populations, including children, the elderly, and persons with disabilities, ensuring their well-being and dignity.

Article XIV: Right to Healthcare Access to quality healthcare is a fundamental right, and the kingdom is committed to providing healthcare services for all its Subjects .

Article XV: Cultural Rights The kingdom recognizes and celebrates the diverse cultural heritage of its Subjects, ensuring the protection and promotion of cultural rights.

Article XVI: Right to Internet Access the Subjects of Numidoria have the right to access information through the internet, promoting knowledge and connectivity.

Article XVII: Environmental Rights The kingdom is dedicated to environmental conservation, recognizing the right of Subjects to live in a clean and sustainable environment.

Article XVIII: Protection of Indigenous Peoples Indigenous peoples within the kingdom's borders are afforded special protection, respecting their unique cultures and traditions.

Article XIX: Right to Political Participation Every Subject has the right to participate in political processes, and the kingdom promotes inclusive and Monarchy governance within the Royal Council.

Article XX: Protection of Economic Rights The economic rights of Subjects, including the right to own property and engage in trade, are safeguarded by the kingdom.

Article XXI: Right to Social Security All Subjects have the right to social security, ensuring a safety net for individuals facing economic hardships or vulnerabilities.

Article XXII: Right to Data Privacy Subjects 'data privacy is paramount, and the kingdom pledges to enact and enforce robust data protection measures.

Article XXIV: Protection of Migrant Workers Migrant workers within the kingdom's borders are entitled to fair treatment, legal protections, and humane working conditions.

Article XXV: Right to Digital Freedom the Subjects of Numidoria have the right to digital freedom, ensuring online expression without fear of censorship or surveillance.

Article XXVI: Protection from Torture and Cruel Treatment Every individual is protected from torture or cruel treatment, and the kingdom condemns any form of inhumane punishment.

Article XXVII: Right to Adequate Standard of Living The kingdom ensures that all Subjects enjoy an adequate standard of living, including access to housing, food, and clean water.

Article XXVIII: Protection of Intellectual Property Rights Intellectual property rights are safeguarded, encouraging creativity and innovation among the Subjects of Numidoria.

Article XXIX: Right to Peaceful Protest Subjects have the right to engage in peaceful protests, and the kingdom commits to protecting this fundamental aspect of democratic expression.

Article XXX: Protection of Whistleblowers play a crucial role in promoting transparency and accountability, and the kingdom guarantees protection for those who expose wrongdoing.

SECTION 3 OF THE ROYAL DECREE:

Article I: Right to Digital Literacy the Kingdom of Numidoria is dedicated to promoting digital literacy among its Subjects, ensuring that everyone has the skills to navigate and thrive in the digital era.

Article II: Preservation of Historical Heritage The kingdom commits to preserving its rich historical heritage, and protecting historical sites, artifacts, and traditions for future generations.

Article III: Right to Animal Welfare Numidoria ensures the humane treatment of animals, promoting their well-being and preventing cruelty through stringent animal welfare laws.

Article IV: Cultural Exchange Programs The kingdom encourages cultural exchange programs to foster understanding and appreciation among diverse communities within and beyond its borders.

Article V: Right to Parental Leave Numidoria recognizes the importance of family life and guarantees parental leave to support parents in balancing their work and family responsibilities.

Article VI: Protection of Intellectual Freedom Intellectual freedom is paramount, and the kingdom safeguards the rights of artists, writers, and thinkers to express themselves without censorship.

Article VII: Right to Digital Security Subjects have the right to digital security, and the kingdom is committed to protecting against cyber threats and ensuring the confidentiality of digital information.

Article VIII: Promotion of Renewable Energy Numidoria is dedicated to promoting renewable energy sources, contributing to a sustainable and environmentally friendly future.

Article IX: Right to Participate in Cultural Events Every Subject has the right to participate in and enjoy cultural events, festivals, and celebrations, promoting a sense of community and belonging.

Article X: Sovereign Responsibility to Combat Climate Change the Kingdom of Numidoria acknowledges its sovereign responsibility to combat climate change, implementing policies and initiatives to mitigate environmental impact.
