Fact: Our Global ID Tribal Land Trust Nation is now registered with Homeland Security, US Customs & Border Protection, and issued to the Office of Foreign Missions and the United Nations, issued, delivered, and acknowledged by USPS, with NO corresponding rebuttal.

Fact: Our Liberty Pass is "ONLY" issued to Diplomats, Nationals, and state citizens (living flesh, blood, and bone men/[wo]men) that are required to be verified by our Embassy of California (de jure) Assembly.

DISCLAIMER: IF someone creates or uses a fraudulent card or duplicates our information and it directly affects both our community, or a diplomat, or a national, or a state citizen whose information was illegally used, and our tribal land trust nation was illegally used will be prosecuted. 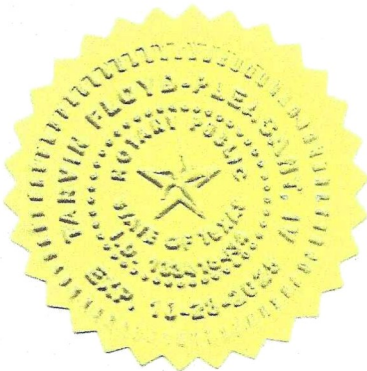

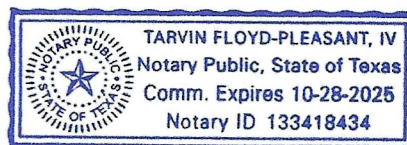
