PREAMBLE

This Treaty of Recognition was established by and between the Living Estate known as Tiggle Province, acting through its Head of Estate, Empress *tiggle-el*: between January 16th, 2004 through July 29th, 2010 undisputed secured as County of Calafia/Calafia County as Land Patent for TLTN (Tribal Land Trust Nation) as TLTN Diplomats *de jure* private tribal government nation. All foreign governments, their agencies, or representatives that may interact with, observe, or address said estate and jurisdiction.

This Treaty affirms the mutual respect of rights, sovereignty, privacy, and peaceful engagement under principles of international law, indigenous self-determination, and divine inheritance.

I. SOVEREIGN STATUS AND INDEPENDENT DOMICILE

Fact: Tiggle Province is a sovereign, non-domestic, non-corporate jurisdiction domiciled in equity, custom, and divine right, and shall not be presumed a subdivision of any municipal, state, or federal government.

Fact: The Estate operates under the living trust authority of Tiggle Estate of 1969 and is the governing civil, spiritual, and territorial body of all property, persons, and instruments declared under its jurisdiction.

II. MUTUAL NON-INTERFERENCE and PEACEFUL RELATIONS by HISTORICAL HISTORY OF FACTS

Fact: All foreign agents, departments, or public officers engaging with the Estate shall do so in peace and good faith.

Fact: The Estate shall not interfere in the domestic affairs of foreign governments, and in return, expects the recognition of its jurisdiction and private administrative process.

Fact: The Estate reserves the right to refuse contracts, summons, obligations, taxation, or adjudication by foreign entities.

Re: The Original Americans Were Indigenous Copper-Colored Aboriginal Peoples

Descended from indigenous aboriginal peoples of America, *we* stand in *our* proper capacity to speak truth and place all facts into the record.

Fact: It has come to *our* knowledge and research that the United States Government and its official records have acknowledged, directly and indirectly, that the original Americans were indigenous copper-colored aboriginal inhabitants, prior to the arrival of European settlers.

Fact: we present the following History of Exhibits into evidence:

Exhibit A – Webster’s Dictionary (1828 Edition)

Fact: Definition of “American”: “A native of America; originally applied to the aboriginals, or copper-colored races, found here by the first settlers...”

Fact: This legal and educational authority defines “American” as the copper-colored aboriginals.

Exhibit B – Naturalization Act of 1790 (1 Stat. 103)

Fact: Text restricted naturalization to “free white persons.”

Fact: This exclusion confirms that the indigenous aboriginal copper-colored Americans were not classified as “white,” proving their distinct original identity.

Exhibit C – Treaty Language

Fact: Early treaties (e.g., Treaty of Hopewell, 1785) recognize indigenous Native Nations as the “aboriginal inhabitants” and sovereign entities.

Fact: The U.S. would not enter treaties unless it acknowledged them as pre-existing sovereigns.

Exhibit D – Explorer & Founder Descriptions

Fact: Columbus (1492) described Indigenous as “copper-colored.”

Fact: Benjamin Franklin referred to them as of “swarthy complexion.”

Fact: Thomas Jefferson described them as “reddish-brown.” **Fact:** These original accounts confirm their complexion and heritage.

Exhibit E – U.S. Census Notes

Fact: Early census records described Native Americans as “copper” or “tawny.”

Fact: Government records confirm complexion-based identification of the original people.

Affirmation of Truth by Facts

Based upon the above Exhibits, the historical record affirms that the original Americans were indigenous copper-colored peoples.

Any subsequent alteration or reclassification of the aboriginal Americans into “red,” “other,” or erased categories constitutes a fraud upon the record and the people.

This affidavit is entered into the record to restore truth, correct the public history, and assert the inheritance rights of the true original indigenous copper-colored peoples of America.

V. LEGAL FOUNDATION AND TREATY STANDING

Fact: This Treaty of Recognition is established under the authority of:

- The Montevideo Convention (1933)
- UN Declaration on the Rights of Indigenous Peoples (UNDRIP)
- UN Resolutions 1514, 1541, 2625, 73/295
- The Law of Nations
- The Vienna Convention on Diplomatic Relations (1961)
- The Ecclesiastical Canons Law: Recognizing 1933 Canons Law a complex system of rules and regulations, rooted in both divine law and human tradition.
- The UPU Constitution for postal jurisdiction and extraterritorial communication

- The UPU Constitution for postal jurisdiction and extraterritorial communication

Fact: All signatory parties or observing entities acknowledge the independent legal personality and governing jurisdiction of Tiggle Province, inclusive of Tiggle-Walker-Lochart Province by inheritance.
