



## Declaration of Statehood for Tiggie Province

Amendment May 14<sup>th</sup>, 2022

The **Tiggie Estate of 1969**, by the Declared rights of Tiggie Province, inclusive of Tiggie-Walker-Lockhart Province within Tiggie Province, under Droit Droit status and the Original International Common Law, Jurisdiction.

### Preamble

We, the People of Tiggie Province, bound under covenant with the Creator, descended from the indigenous lineage mixed with Shawnee, Cherokee and a few Choctaws lineage under the authority of the Tiggie Estate of 1969 decreed and governed by the framework of trust and estate established our Statehood of Tiggie Province of the TLTN Diplomats *de jure* private tribal government nation. Our rightful existence as a self-determining State, Jurisdiction.

Declared and affirmed our rightful jurisdiction standing as a State among the family of nations, not by rebellion, but by lawful succession, indigenous inheritance, international principle and by Treaty of Recognition of our Existence. We walk as *Droit Droit* ↔ a divine, indigenous, as diplomatic people, and in this capacity we govern ourselves in trust with justice, in peace, equity, and truth affirms our position among nations.

### Article I – Identity and Defined Territory of the Province

1. –The Registrar distributes Authentic **Certification of National ID & Liberty Travel Pass (Real ID)** by the TLTN Diplomat *de jure* private triable government nation, true **Real IDs** of the Tiggie Province. Whereas- We the People, in Full Life, Substantiate a more perfect Union to Retain All Liberty of Motion Through Our Indigenous Autochthonous Ancestral homelands in Perpetuity. Thereupon our being shall pass without Hindrance, or Delay, by use of our National ID & Liberty Travel Pass. The Territory of Tiggie Province is established under Original Common Law jurisdiction with present domicile defined for record purposes as:

This address shall serve as the recognized postal and administrative seat until further expansion is complete and declared.

### Article II – Population & Citizenship

- 1– Tiggie Province is founded membership criteria by Lineal descendants and heirs as Tiggie-Walker-Lockhart Province within the Tiggie Estate of 1969, within our TLTN Diplomats, a *de jure* Private Tribal Government Nation. Members incorporated under recognized trusts of the Province by Treaty. Individuals who lawfully affiliate through adoption, oath, family, and successors form the permanent population of Tiggie Province. Citizenship is affirmed by declarations, oaths, trust membership, or appointment by the Registrar of the Tiggie Province within Calafia (*de jure*) Assembly within The Tiggie Province Embassy.

### Article III – Trust & Estate Framework

- 1— The governance and authority of Tiggie Province is vested in its trust and estate framework, including but not limited to:
  - i. The **Tiggie Estate of 1969** (Foreign foundational trust) & (Domestic Secured Trust).
  - ii. The **TLTN-MCT Corporate Sole Trust** /Sole Proprietor (spiritual and diplomatic head).

- iii. The **TWL Foreign Grantor Trust** (international relations and protections).
- iv. The **JMTL Tourist Trust** (heritage and estate development).
- v. **Domestic Revocable Trusts** (administrative and holding capacity).
- vi. **Subordinate Trusts** (Claimant, Payment, CPBNA Private Banker, and such other trusts as may be established).

1. These trusts collectively form the **legal, fiduciary, and governmental authority** of Tiggle Province.

#### **Article IV – Government Structure –**

The Government of Tiggle Province is vested in the trust and the Estate Framework of the Tiggle Estate of 1969, acting through it Trustees(s) and Administrative Council of the California (*de jure*) Assembly. Authority is delegated to:

- Council Board of Trustees (legislative body)
- Corporate Sole / Ambassador (executive and diplomatic divisions)
- Registrar & Treasury & Fiscal Auditor (administration and finance)
- Judiciary/Tribunal (dispute resolution within the estate/province our (*de jure*) Assembly).

This structure fulfills the requirement of a stable and continuous government.

#### **Article V – Postal Authority –**

1. Tiggle Province has established an independent Embassy **TLTN Postal Authority**, which shall serve as the official designated postal operator for the Province.
2. The Postal Authority shall regulate, administer, and manage all postal matters within the jurisdiction of Tiggle Province.
3. The Postal Authority shall hold the right to seek accession to the **Universal Postal Union (UPU)** and obtain recognition of its postal codes, stamps, and instruments of communication.

#### **Article VI – Rights & Duties –**

1. The People of Tiggle Province are entitled to the fundamental rights of life, liberty, estate, privacy, and dignity.
2. No law shall be enacted that deprives a member of Tiggle Province of their lawful inheritance or their trust protections.
3. Duties of citizenship include loyalty to the Province, respect for trust law, and the defense of its jurisdiction.

#### **Article VII – International Relations Interstate and International**

1. Tiggle Province affirms its capacity to enter into relations, treaties, and agreements with other States, nations, and international organizations.
  - a. Between July 29<sup>th</sup>, 2010 to date over 98 ‘**Treaty of Friendship and Recognition**’ for our private government nation has been issued to All Foreign Government Agencies and Administrations.
  - b. Between 2008 through July 29<sup>th</sup>, 2010 Secured Land Patent as the Tiggle Province.
  - c. Tiggle Province **Legal Notice by Proclamation of Existence** of TLTN Diplomats; TLTN Diplomat *de jure* private tribal government nation; National ID & Liberty Travel Pass; Tribe Land Trust Nation; California (*de jure*) Assembly; Embassy; Calafia County; and Calafia Bank & Trust as CPBNA (all Tax Exempt) between January 16<sup>th</sup>, 2004 through July 29<sup>th</sup>, 2010, undisputed. (Interstate/International)
  - d. Legal Global Notice issued by AFFIDAVIT OF PUBLICATION issued June 17<sup>th</sup>, 2023, documents standing Global.
  - e. Declaration of Existence was created July 29<sup>th</sup>, 2010 and reissued Nover 21<sup>st</sup>, 2024 to Comptroller of Currency, FDIC, FINCEN, and Several State Registrars for Private Banking, with no rebuttal.
2. The Province may accede to international conventions, beginning with the **Constitution of the Universal Postal Union (Vienna, 1964)**, and shall uphold the principles of peaceful relations.



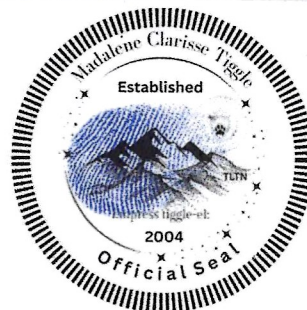
### Article VIII – Amendments –

1. Incorporate our Declaration and Constitution, by treaty may be amended by resolution of the Council of Trustees, ratified by the Corporate Sole, and published on the record.
2. Amendments must be consistent with the principles of trust law, international law, and the rights of the People.

### Article IX – Supremacy –

1. This Declaration and Constitution is the supreme law of Tiggie Province.
2. No foreign statute, ordinance, or regulation shall override the lawful jurisdiction established herein.

**Execution** This Constitution was duly established and adopted by the Trustees and People of Tiggie Province, under seal, amended on June 12<sup>th</sup>, 2025. 0 will be added if needed.



### AFFIRMATION AND EXECUTION

This Declared Establishment of Tiggie Province *nunc pro tunc* July 29<sup>th</sup>, 2010, inclusive of TLTN Postal Authority within TLTN Diplomatic *de jure* private tribal government nation, is affirmed and made effective by the living hand and seal of the Head of Estate and shall remain in full force until amended or withdrawn in writing.

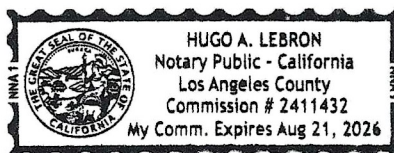

# Constitution Framework of Tiggie Province

Amendment of July 29<sup>th</sup>, 2010

Issued under the Tiggie Estate of 1969, in right of Tiggie Province, standing in Droit Droit capacity, and grounded upon Original International Common Law and the Law of Nations.

## Preamble

We, the People of Tiggie Province, descended from Polk and the Cherokee Indians, and as such are entitled to Cherokee Indian citizenship in the Cherokee Nation, also Virginia Shawnee lineage, bound under covenant with the Creator, and governed by the framework of trust and estate, do hereby ordain and establish this Constitution.

This Constitution affirms our rightful standing as a State among the family of nations, not by rebellion, but by lawful succession, indigenous inheritance, and international principle. We walk as *Droit Droit* — a divine, indigenous, and diplomatic people — and in this capacity we govern ourselves with justice, equity, and truth.

## Article I – Identity of the Province

1. The name of the State shall be **Tiggie Province**.
2. The jurisdiction of Tiggie Province exists under Original International Common Law, independent of foreign coercion, and established upon the estate and trusts of Tiggie and Tiggie-Walker-Lockhart lineage.
3. The official symbols of Tiggie Province shall include:
  - i. The **Crest and Seal of Tiggie Province**.
  - ii. The **Crest of the 'Tiggie Family Estate' Seal of Tiggie Province**.
  - iii. The **Flag of Tiggie Province**, adopted by council resolution.
  - iv. The **Crest and Seal of the TLTN Diplomatic *de jure* private tribal government nation** established by Tiggie Province, on private land exist under Original International Common Law, and a true independent established upon the estate and trusts of Tiggie.
  - v. Such additional emblems as may be proclaimed.

## Article II – Population & Citizenship

1. The People of Tiggie Province shall consist of:
  - i. Lineal descendants and heirs as Tiggie-Walker-Lockhart Province within the Tiggie Estate of 1969.
  - ii. Members incorporated under recognized trusts of the Province, including the JMTL Tourist Trust, the Corporate Sole Trust/Sole Proprietor, the Foreign Grantor Trust, CPBNA Private Unincorporated Bankers National Association Trust, and subordinate trusts, etc....
  - iii. Individuals who lawfully affiliate through adoption, oath, or by treaty.
2. Citizenship is affirmed by declaration, trust membership, or appointment by the Registrar of Tiggie Province.
3. No person shall be deprived of recognition within Tiggie Province who lawfully stands with or under this jurisdiction.

## Article III – Trust & Estate Framework

The governance and authority of Tiggie Province is vested in its trust and estate framework, including but not limited to:

- i. The **Tiggie Estate of 1969** (foundational trust).
- ii. The **TLTN-MCT Corporate Sole Trust /Sole Proprietor** (spiritual and diplomatic head).
- iii. The **TWL Foreign Grantor Trust** (international relations and protections).
- iv. The **JMTL Tourist Trust** (heritage and estate development).
- v. **Domestic Revocable Trusts** (administrative and holding capacity).
- vi. **Subordinate Trusts** (Claimant, Payment, CPBNA Private Banker, and such other trusts as may be established).



These trusts collectively form the **legal, fiduciary, and governmental authority** of Tiggle Province.

#### **Article IV – Government Structure**

The Government of Tiggle Province shall be composed of:

**Council of Trustees** – exercising legislative and policy-making authority.

**Corporate Sole / Ambassador-at-large/Ambassador(s)**<sup>2/3/4/5</sup> – the executive and diplomatic representative of the Province.

**Registrar and Treasury** – CB&T as CPBNA CFO2(s)/Fiscal Officer/Auditor maintaining records, finances, and accounts as MCT Withholding Agent a Virginia State Registrar for Settlements of the Province.

**Tribunal of Equity** – California (*de jure*) Assembly serving as the judiciary for dispute resolution within Tiggle jurisdiction.

1. Authority flows from the Tiggle Estate of 1969, delegated by trust instruments, and executed by trustees, officers, and appointed agents.

#### **Article V – Postal Authority**

This Constitution was duly established and adopted by the Trustees and People of Tiggle Province, under seal, originally on July 29<sup>th</sup>, 2010, hereby amended on June 12<sup>th</sup>, 2025.
