1. **VEFICATION BASED ON:** action was commenced in the Superior Court of Riverside County Hall of Justice in California, County of Riverside entitle: **THE PEOPLE OF THE STATE OF CALIFORNIA** vs Tiggie-Lockhart, Madalene-Clarisse DOB: 12/28/1969; MADALENE TIGGLE-LOCKHART DOB: 12/28/1969; and MADALENE TIGGLE, as Case #RIF2104626, Case #RIF200326, Case #375305MT added Case #74168QQML, Booking # 202238125; Tracking # 10021047, Additional Case #509994MT. Created by use of a **SURRENDERED DL C6727460** as of 02/28/2012, and the **LEGAL PESONS** of decedent MADALENE CLARISSE TIGGLE *listed* where created & verified by **VA County Registrar** as of: 01/02/1970 **NOT** 12/28/1969; and all names are decedents/legal persons/trust **NOT LIVING, causing trademark infringement, deprivation of god given rights, identity theft, peonage, enforcement into servitude, and continued creation of securities unlawfully with NO form of permission now reported as securities fraud.**
2. **FACT:** Failed to provide their verification of identity, no right to speak, no service of any warrants or paperwork, with NOTHING, just kidnapped into the system by peonage. For several days moving from place to place, an innocent *living [wo]man, a non-decedent* enforced into peonage and suffered medically, rushed to the hospital, and received two blood transfusions, then enforced back into the system, continued to be moved to several places again. Criminal.
3. **FACT:** This action pursuant to the provisions expressly provided by Act of Congress, any civil action brought in a State court of which the district courts of the United States have original jurisdiction, **may be removed by the defendant or the defendants**, to the district court of the United States for the district and division embracing the place where such action is pending. A Removal based on diversity of citizenship, in determining whether a civil action is removable on the basis of the jurisdiction, the citizenship of defendants **sued under fictitious names shall be excluded** (emphasis added). Thereby the matter of the CRIMINAL CASE was MOOT, and still held hostage.
 - a. **UNDISPUTED FACT:** Use of a surrendered DL or CID as of 02/28/2012 due to incorrect information DOC: 01/02/1970 of the legal persons, is **identify fraud by the defaulted parties.**

- b. **UNDISPUTED FACT:** as of 02/28/2012 separation of the decedent from the *living [wo]man* (an *international protected person*) by informant/mother issued to the County registrar of Commonwealth of Virginia 145-69-075220 by deed poll **removing** all allegations as a United States Citizen ≠ did not remove the LEGAL PERSON's who are the United States Citizens, is still **identity fraud by the defaulted parties**.
- c. **UNDISPUTED FACT:** renders the entity/legal person/registered entity a United States Citizens... as of 01/02/1970, which in law require Department of Justice to issue PROTECTION Order and an extended restraining order.
- d. **UNDISPUTED FACT:** removes the *living [wo]man*, an *international protected person* as of 12/28/1969. Which the two are **NOT** the same.
 - i. Rendering the living [wo]man the true beneficiary/beneficial heir of such legal person, only connection(s) by *attorney-in-fact* as of 02/28/2012.
 - ii. Whereby the legal fictions are in need of **protection** from these courts' unlawful intent... by use of identity theft, securities fraud, and continued unlawful claims, threatening the life of a *living [wo]man*, outside their jurisdiction.
