

# LEGAL NOTICE

## PROCLAMATION OF EXISTENCE

Private unincorporated *de jure* Government:

**TLTN Diplomats; TLTN Diplomat *de jure* private tribal government nation: National ID & Liberty Travel Pass; Tribal Land Trust Nation; California (*de jure*) Assembly; Embassy; Calafia County; and CALAFIA BANK & TRUST as CALAFIA PRIVATE BANKERS, N.A (ALL Tax Exempt)**

**By secured 2004 pursued 02/16/2008 through 07/29/2010 Publicly land Secured  
PROCLAMATION AND PUBLICATION interstate**

- 1: This PMA itself is formed as a '**private membership association**' and runs as a trust, within a private unincorporated *de jure* government.
- 2: There is **no** requirement to record the existence of the private membership association **anywhere**. The PMA is for privacy purposes as an unincorporated association.
  - The only purpose of documenting the existence of PMA in public is for our **private Banking purposes only**, all matters are outside the de facto jurisdiction as a **private *de jure* un-incorporated government Association**.
- 3: This PMA is governed by the terms and conditions of the Articles of the Private unincorporated *de jure* government as:  
TNTL Diplomat/TLTN Diplomats/Tribal Land Trust Nation inclusive of our **TLTN Diplomat *de jure* private tribal government nation**: with our own '**National ID & Liberty Travel Pass**;' we are TAX Exempt (pursuant to Canon 2124/2127), as a California *de jure* Assembly; Embassy; Calafia County; Calafia Bank & Trust aka Calafia Private Bankers, N.A. (CPBNA), and Articles of Association, on secured private land 2004-2008 owned by PMA, as of 29<sup>th</sup> day July 2010, undisputed.
- 4: **No** state can make any laws impairing the obligations of contracts.
- 5: If the Trustee considers it necessary; the PROCLAMATION and **LEGAL PUBLIC NOTICE** is hereby granted to be published by the Trustee -MCT Withholding Agent. This Notice for restricted Registration is allowed for relationship of the PMA existence inclusive for the '**CALAFIA PRIVATE BANKERS, N.A.**' ...giving **NO** jurisdiction to **NO** state.
- 6: **No**-one will be provided with our private terms and conditions of the PMA that is **not** contracted with the PMA.
- 7: The Trustee is never compelled to share the terms and conditions of the PMA with any court, **nor** state, **nor** its de facto government employees.
- 8: The Trustee may form a private not for profit, foundation, humanitarian, educational or other type of company that the PMA owns.  
The Trustee may apply for a 9-digit EIN # and work through the company as its manager **only** and authorized actions as the **manager aka ambassador-at-large aka minister of foreign affairs**. The Company is a PMA. The Trustee has placed the PMA and section 3 above into a trust for extra protection.
- 9: The **PMA** by Trustee can transfer automobiles into PMA as TLTN Diplomats by title transfer owned by a PMA; We are self-insured and when needed obtain an EIN # then it would be better to transfer automobiles into the name of the company as: '**TLTN Diplomat *de jure* private indian tribal government nation**' that the PMA owns.
- 10: The **PMA** secured members a safe haven by their Charter Vessel created by the de facto state coming fourth as *de jure* private indian tribal government nation, TLTN Diplomats.
- 11: The **PMA** has secured members right to travel interstate **Land Air & Water ↔ LAW** by: **National ID & Liberty Travel Pass, Private Motor Carrier of Passengers(non-business)/Non-Commercial/No Fee, in Trust by private property of PMA as a private motor carrier interstate as: Autochthonous AmEricAn Indian National Diplomats, Secretary, Counselor, Minister, Ambassador, Envoys, Chargé d'affaires, and Emissary by PMA and Trademark Member Seals for additional protection**. The Office of Foreign Missions will be provided with notice of TLTN Diplomats.
- 12: The Trustee may transfer property meaning real estate into the company name or the Trust name by Quit Claim Deed by PMA.
- 13: The **PMA** operates by Treaty wherein validates acknowledgment of Recognition of Existence, which we have over 78 treaties issued.
- 14: **All matters** are PMA contracts. All State/Fed Government provided Proper Notice for years **Notice** 2004-2008-2010-2012-2014-2022-2023 & 2024.
- 15: PMA shall agree and remain under a "Non-Disclosure Agreement" of any detail of the PMA in the amount of \$ *fifty thousand* retainer and \$ *ten thousand* per hour in whatever currency that is chosen, assuming that the value amount of currency does not exceed forty per one troy ounce of .999 fine silver specie and our private banking will be producing our own currency.

**Wherefore, i**, officer of this PMA Association as Ambassador-at-large Empress *tiggle el*: PMA IPP, Minister of Foreign Affairs proclaim and make a Lawful and Legal Entry under oath and affirmed before god, the facts provided for said Public Notification by LEGAL NOTICE for **PROCLAMATION OF EXISTENCE** (treaty) as documented above undisputed as of 2004-2008 secured 29<sup>th</sup> day July 2010; Herewith Published for and on the Public Record for **CALAFIA PRIVATE BANKERS, N.A.**, and acknowledgement of PMA.
