The winner of each barn will be contacted and interviewed by the Committee on Friday or Saturday morning. The overall Shiawassee County Sportsman of the Year winner will be announced at closing ceremonies.

Each barn winner will receive an award. The overall Sportsman of the Year will receive a plaque and a scholarship!

In selecting the youth in your barn, please consider the following characteristics:

- This youth should be unselfish and committed to their project
- He/she should be willing to help out in any way that benefits the club, group, and barn.
- This youth must show a positive attitude.
- This youth must be a good role model for others in his club, his barn, and at the Fair.
- This youth must display good sportsmanship and respect to his/her peers, leaders, judges, superintendents, and adults/parents, even in the face of adverse outcomes.
- This youth should demonstrate cooperation and respect.
- This youth must demonstrate his/her integrity, and doing what is right.

Any adult/leader/youth can nominate an individual. This nomination ballot and all support forms must be turned in together. You must secure a minimum of two additional support forms (each form to be completed by a different individual).
